her dedication to music, Fuller Lodge, and the community. Chair Rayburn expressed Leon Heller's willingness to provide funds to cover the expenses of the lecture series. The Board moved to approve the letter as is and the vote was unanimous approval. Chair Rayburn will send the letter to Barbara Lai to finalize on County stationary.

Chair Rayburn mentioned that the Board is interested in obtaining training in Historic Preservation issues. He also mentioned that Board members may be interested in attending other Board meetings to gain experience in the operation and procedures common to Board meetings.

B. Staff Reports and Updates

Update on the FLHDAB Ordinance Change.

Mr. Kohlrust stated that on May 2, County Council approved the name change of the Board from the Fuller Lodge District Advisory Board to the Historic Preservation Advisory Board. The new Ordinance goes into effect in 30 days.

Board Appointments.

Mr. Kohlrust also stated that County Council approved the appointments of two new Board members, Patrick Moore and Phillip Gursky. Their appointments are effective immediately.

Discussion of staff changes by for Board Support.

Paul Andrus, Director of Community Development, discussed organizational changes with the move of the project managers' function and staff to the Public Works Department in 2015. Now the focus of the FLHAB has changed from improvements to Fuller Lodge to advancing Historic Preservation in the community. The close connection and cooperation between Planning and Zoning and Historic Preservation will be critical in moving historic preservation efforts forward.

Wayne Kohlrust will continue to provide project support for Fuller Lodge improvements.

Fuller Lodge/Historical Museum Project Update.

Mr. Kohlrust announced that the Lodge portion of the project is done. He also stated that the Museum project is completed. There is some warranty work on the flooring in the Manhattan Gallery portion of the building that needs to be completed. Staff is in the process of resolving any issues.

The purchase and installation of a new sound system and screen for the Lodge are being researched by Chair Rayburn. He expressed concern that County staff will be adequately trained to use and maintain the new equipment. Mr. Kohlrust assured Chair Rayburn that staff would be trained and able to use and maintain the new equipment.

Mr. Kohlrust reported that the rock bordering the site is deteriorating and this will be replaced through the Parks Division and a contractor.
