### 7. NEW BUSINESS - Possible Action

#### 10628-18- Bus Stop Improvement Plan

The purpose of this plan is to provide a comprehensive inventory of bus stops and associated amenities and to prioritize needed and desired improvements, system-wide, in Los Alamos Townsite and White Rock. This plan serves a guiding document for Los Alamos County - Atomic City Transit is a living document that is subject to change. The bus stop improvement plan focuses on stop accessibility, increasing passenger amenities, and design consistency.

The plan shall:

- Establish an inventory of bus stop locations with associated passenger amenities
- Identify usage at existing bus stops using the boarding/alighting survey
- Identify areas of concerns related to ADA access as well as prioritize opportunities for improvement based on ridership.
- Existing Conditions detailed list of bus stop locations, numbers, current conditions, and current passenger amenities.
- Bus Stop Spacing Currently the bus stop spacing is generally one quarter mile or 5 city blocks from one stop to another.
- Design Currently ACT uses several different vendors for bus shelters and benches.
- ADA Accessibility In accordance with Department of Transportation American with Disabilities Act Standards for Transportation Facilities, the following criteria from the DOT's ADA standards indicated the compliance is required to the extent construction specifications are within a public entity's control.
- Classification Prioritization for Improvements
- Recommended Implementation Program
- Budget and Implementation
- Other Programs Recommendations

Staff recommends prioritizing the 33 identified stop locations in need of connections to sidewalks as the initial phase of the improvement program. The second phase of the improvement program would focus on the 24 stops that need an accessible connection to the bus stop as well as an accessible landing pad.

The final phase of the program would be to identify and install passenger amenities, to include bus stop shelters, benches, bike racks, trash receptacles, among the 50 most used bus stops based on usage of the stop and characteristics of the location. A motion was made by Member Wheeler, seconded by Vice-chair Machen that the Transportation Board adopt the Bus Stop Improvement Plan and encourage staff to begin implementation of the identified improvements according to the phasing detailed in the plan. The motion passed unanimously.

The Airport Division is responsible for operating and maintaining the Los Alamos County Airport and delivering a safe air transportation hub *and vibrant economic engine* for airport tenants, citizens, LANL, and local businesses.

### History

The airport was built in 1947 by the Atomic **Energy Commission as** part of Los Alamos Scientific Laboratory. It was a 3,500 foot gravel runway for emergency taxi service, air carrier service and a "landing field for important visiting personages." The airport was transferred to the County in October 2008.



### **History Continued**

Los Alamos has seen airline service to Albuquerque since the airport opened in 1947.

- Carco Airlines operated Beechcraft Bonanzas through 1969
- Ross Aviation flew DeHavilland Twin Otters through 1995
- Peacock Air provided flights in late 1995 using Metroliners
- Mesa Airlines flew in 1997 with Beechcraft 1900D
- Rio Grande Air served the route in 1999 using Cessna 208
- New Mexico Airlines, using Cessna 208, served 2013 to 2015
- Boutique Air operated 2015 to 2016 using Pilatus PC-12s

Pedestrian Crossing Issues

#### ...Body

The Los Alamos Planning and Zoning Commission has approved the Final Subdivision Plat for 161 new residential lots and one commercial lot, located on the north side of State Road 4, NM 4, west of the Visitor Center in White Rock. The project, formerly known as A-19, is now named Mirador. It is anticipated that house construction could begin before the end of this year. The project reflects several years of planning and review, including the White Rock Center Master Plan & Economic Development Strategy.

During the course of their review, the Commission raised concerns in regard to safe crossing of NM4 by pedestrians and bicyclists. Directly across that road are several key activity, educational and retail centers that would attract new residents of Mirador. In response to those concerns, Public Works staff members Eric Martinez and Dan Erickson presented a "toolbox" of pedestrian crossing options to the Commission. The Commission was reassured by knowing that there are alternatives to a full traffic signal and that the Public Works staff, as well as the Transportation Board, will monitor the project and consider options to ensure pedestrian safety.



On April 11, 2018, the Los Alamos Planning and Zoning Commission approved the Final Subdivision Plat for 161 new residential lots and one commercial lot, located on the north side of State Road 4, west of the Visitor Center in White Rock. The project, formerly known as A-19, is now named Mirador. It is anticipated that house construction could begin before the end of this year. The project reflects several years of planning and review, including incorporation of elements of the White Rock Center Master Plan & Economic Development Strategy, adopted by Council in 2008.



Mirador Subdivision: 161 single-family lots and one commercial lot, Tract D

During the course of their review, the Commission raised concerns in regard to safe crossing of SR 4 by pedestrians and bicyclists. Directly across SR 4 are several key activity, educational and retail centers that would attract new residents of Mirador. (See graphic.) In response to those concerns, Public Works staff members Eric Martinez and Dan Erickson presented a "toolbox" of pedestrian crossing options to the Commission. The Commission was reassured by knowing that there are alternatives to a full traffic signal, and that the Public Works staff will continue to monitor the project and consider options to ensure pedestrian safety.

A number of conditions, as recommended by staff, and accepted by the applicant, were associated with Final Plat approval. Two of the conditions of approval relate directly to traffic impacts at or during buildout of the project:


- 1. The developer shall be responsible for future installation of a traffic signal and related equipment at the NM 4/Mirador/Sherwood Boulevard intersection if engineering warrants are met. This shall not preclude the developer from seeking financial participation from other sources.
- 2. The developer shall provide an updated Traffic Impact Analysis (TIA) at the time of any of the following:
  - Site Plan submittal for Commercial Tract D, or any portion thereof; or
  - As may be required by the County Engineer based on traffic operational performance, safety and/or capacity issues upon completion of Phases I, II or III of residential build-out; or
  - As may be required by the New Mexico Department of Transportation.

It is anticipated that a traffic signal will be warranted and installed at the intersection of SR 4 and Sherwood/Mirador at some time in the future. Prior to such time as the warrants are met, Engineering staff anticipates that other, perhaps incremental, traffic safety devices could be installed. These range from the least technical and least expensive, such as crosswalk striping, to flashing beacons. These would eventually be replaced with or supplemented by full signalization.

It should be noted that a traffic study was prepared in 2011 by the Albuquerque firm Bohannan Huston, and updated specifically for the Mirador project in January of 2018. The study examined four current and proposed intersections on SR 4: two existing signalized intersections at Rover and Pajarito, and two intersections at Sherwood and La Vista. It looked at existing conditions, a no-build scenario, and full buildout of the site. The study concluded that the two existing signalized intersections at Rover and Pajarito, as well as the unsignalized intersection at La Vista, will perform at acceptable levels of service (LOS) in all three scenarios. It further concluded that the left turn movements out of Mirador onto SR 4 would operate at LOS F in the full build condition. The study also noted that, "The high volume of traffic will impact the ability of pedestrians to cross SR 4 and a traffic signal will promote the viability of pedestrians to walk to the commercial center, a key objective of the Master Plan."

Underground conduit for signalization, as well as pole pedestals, have already been installed at both the Sherwood/Mirador and La Vista intersections. The study recommended monitoring delays and operations at these intersections to determine if and when warrants may trigger the need for signal installation. This recommendation is reflected in and further detailed in the conditions of approval for the Final Plat, above.

At their meeting of April 25, 2018, and upon hearing the presentation by Public Works staff, the Planning and Zoning Commission expressed their desire to inform the Transportation Board of this forthcoming project, share their concerns and encourage the Board to pro-actively address pedestrian safety issues.














### Traffic Devices for Pedestrians Flashing Beacons

# **Traffic Signal Warrants**

An engineering study of traffic conditions, pedestrian characteristics, and physical characteristics of the location shall be performed to determine whether installation of a traffic control signal is justified at a particular location—*Source MUTCD, 2009* 

- 1. Eight-Hour Vehicular Volume
- 2. Four-Hour Vehicular Volume
- 3. Peak Hour
- 4. Pedestrian Volume Function of Major Street Volume & Ped Volume (75 to 107 PPH, lower threshold)
- 5. School Crossing
- 6. Coordinated Signal System
- 7. Crash Experience
- 8. Roadway Network
- 9. Intersection Near a Grade Crossing

### Pedestrian Hybrid Beacon Warrants

A special type of hybrid beacon used to warn and control traffic at an unsignalized location to assist pedestrians in crossing a street or highway at a marked crosswalk...may be considered at a location that does not meet traffic signal warrants.





#### **Body**

As part of Council's action on February 27, 2018 to accept the Los Alamos Tourism Strategic Plan, the Tourism Implementation Task Force was formed and staff was directed to bring back a charter for the task force. This task force was modeled after the White Rock Master Plan Implementation committee and will provide guidance and expertise to the Council and County staff on implementation issues. Council approved the charter (Attachment A) and Council will consider membership on the Task Force on May 1, 2018 meeting.

This charter defines the purpose, scope of work, representation, and member term among other items. The highlights of this new Task Force are:

- Task Force is initially chartered for two years.
- Task Force will be comprised of various tourism stakeholders including the community-at-large, Business community and assets/attractions
- Total number of members not to exceed eleven (11) members
- Task Force will also include representatives from Historic Preservation, Lodgers' Tax Advisory, and Parks/Recreation Boards
- Members will be initially appointed for a two year term
- The Assistant to the County Manager will be the staff liaison to this Task Force

Although the Transportation Board is not specifically called out in the charter, it would be beneficial to assign a liaison from the Transportation Board to the Task Force. This liaison would attend meetings and report out on the business of the Task Force to the rest of the Transportation Board.

#### **Tourism Implementation Task Force Charter**

#### I. Purpose

The Tourism Implementation Task Force ("Task Force") was created through an action of the County Council on February 27, 2018 when the Council formally accepted the Los Alamos County Tourism Strategic Plan. The Task Force serves as an advisory body to the County Council for the purpose of building the tourism economy as a way to economic development through implementation of the principles, objectives and associated actions as provided in the Tourism Strategic Plan. The Task Force provides guidance and serves as a resource to the County Council and staff in the formulation, development, championing and execution of specific actions and projects. The committee will also serve a valuable role in communicating implementation of the Tourism Strategic Plan recommendations to the general public and County Council.

#### II. Scope of Work

The Tourism Strategic Plan is a practical roadmap detailing the strategies and actions needed to develop the tourism economy while improving community quality for residents, businesses and LANL. The Task Force's mission is to be primary stakeholder group that helps to lead this economic development effort and works closely with Staff and other members of the community. The Task Force will also advise staff in the process of implementing the recommended tactics and actions delineated in the Tourism Strategic Plan. The Task Force will advocate for the promotion of tourism as an economic driver for the County. Meetings of the Task Force will also serve as a venue for communicating and receiving information from the general public on plan implementation.

The Task Force will initially be chartered for two years.

#### III. Task Force Representation

The Task Force will be comprised of volunteers representing the various tourism stakeholders within the County including: the community-at-large, Business Community (Retail, Hospitality, and Service), and assets/attractions such as Los Alamos History Museum, Nature Center, Pajarito Mountain and Bradbury Science Museum. Historic Preservation, Lodgers' Tax Advisory, and Parks/Recreation Boards shall select one member from their board to serve on the Task Force and also select an alternate to attend meetings in case the member cannot attend. The total number of members shall not exceed eleven (11) persons including the representatives from Council Advisory Boards.

Committee members will be individually appointed by the County Council.

#### IV. Member Term

The initial term of all task force members will be two years. At that point in time, the charter and membership will be evaluated for possible renewals.

#### V. Quorum

A quorum of the committee is defined as a simple majority of the appointed committee members. Committee actions can be taken and considered valid only if a quorum has been established at the meeting. Information can be shared during a meeting even if a quorum is not established.

#### VI. Resources

The County will provide a staff project manager responsible for coordinating the committee in its exploration and development of implementation actions including meeting logistics and other needs. Other County staff will be available based upon identified needs or specific topics of discussion but all staff members will be non-voting members of the Task Force.

#### VII. Meetings

Meeting dates and frequency will be established by the Task Force and staff. All meetings will be open to the public. Meetings will also serve as a venue for communicating and receiving information from and to the general public on project implementation.

#### VIII. Subcommittees

The existing Manhattan Project National Historical Park (MAPR) subcommittee is be transitioned over to this Task Force. This subcommittee will focus on the issues that must be addressed to support the implementation of the new national park.

The Task Force may form any additional subcommittees it deems appropriate but all recommendations to the Council should be that of the full committee, as indicated by a majority vote of the committee members. The subcommittees may include persons not otherwise identified as a member of the committee, however subcommittee membership does not convey an ability to vote on any recommendations.

#### In the Works.... Public Works Update – April 2018

#### **Administration Division**

**Transportation Board** 



The Transportation Board meets the first Thursday of the month at 5:30 p.m. Meetings are held at 1000 Central Avenue, Room #110.

#### **Airport Division**

#### New Aircraft Hangar Construction



The Los Alamos Airport has a very high demand for aircraft hangars – all the current hangars are fully occupied and there are 15 aircraft on a waiting list. In response, the county purchased a metal preengineered hangar that requires on-site assembly. The county issued a request for bids for assembly – neither of which resulted in favorable bids. As a result, Public Works personnel will be assembling the building. A construction crew was selected on a volunteer basis

and will be scheduled so as not to conflict with other county projects. Public Works personnel have the qualifications and experience to complete this project, and received refresher training from the Risk Division on construction safety and equipment that is specific to this project. Construction began in mid-April and is scheduled to be complete in June, weather permitting.





#### Airport Engineering, Architectural & Planning Services Request for Qualifications (RFQ)



The County issued a RFQ for Airport Engineering, Architectural and Planning Services as is required by the FAA. These services will be used for Capital Improvement Projects as contemplated in the Airport Master Plan with grant funding from the FAA, NMDOT and the County. The selection committee

reviewed the six qualified responses, selected a firm, and negotiated a 5-year agreement for Council's consideration at its May 1<sup>st</sup> meeting.

#### Wildland Fire and Search and Rescue Firefighter Training

Classic Air Helicopter primarily provides emergency medical air transport services for Los Alamos County. In addition, Classic provides wildland fire and search and rescue services in coordination with County Firefighters. To ensure the Firefighters are ready in a moment's notice, Classic conducts annual helicopter safety and familiarization training at the airport. Classic provides this training at no cost to the county. In fact, in the case of a wildland fire or search and rescue mission, the first hour of helicopter time is also free of charge. Once trained, Classic can pick up 1 to 3 firefighters and get them to the location quickly, saving time and perhaps lives and property.



#### **Aircraft Tours**



The airport hosted group of children and their parents for aircraft tours. Major Mark Peters from the local Civil Air Patrol Squadron, a US Air Force Auxiliary that provides aerial search and rescue, disaster relief, and leadership training for



local youth, and Roger Smith, the President of the local Experimental Aircraft Association, volunteered the aircraft, their time and a pilot's perspective.

#### **Custodial Division**

- The Custodial Division supported 248 events during the month of April.
- The Golf Course restaurant patio concrete was polished to improve the overall look of the enclosed outdoor dining area.
- The Airport was detailed cleaned in preparation for the Transportation Board tour.

#### **Engineering & Project Management Division**

#### White Rock Branch Library



The LEED plaque was received and installed in the White Rock Library. This project achieved a 'Silver' status. Thanks to Allen Sherwood of Facilities for the installation!

#### Structural Systems Award for the Canyon Rim Trail Project Phase 2

**Category Winner:** Structural Systems Wilson & Company, Inc., Engineers & Architects Los Alamos Canyon Rim Trail Project Phase II Los Alamos County This second phase consisted of the study, design, and construction of a 180foot prefabricated steel truss bridge, retaining walls up to 18 feet in height, and approximately 2,800 lineal feet of a 10-foot wide asphalt path along a steep canyon wall. During the study phase, three separate alignments were reviewed to determine the most cost effective alternative. One of the most challenging aspects of the project was identifying a bridge alignment to stage a series of cranes to erect the bridge during constriction. Once a preferred alternative was selected, preliminary design began, working through the local government process with the NMDOT and FHWA in accordance with the requirements of the PIF agreement. Los Alamos Canyon Rim Trail Project Phase II

On April 6, 2018, the Canyon Rim Trail Phase II Project was recognized as the Structural Systems category winner by the New Mexico American Council of Engineering Companies. Congratulations to the entire project team that made this an award-winning project!

#### Welcome to the Team!

#### Server Room Cooling Improvements

This project improves the reliability of the server room cooling. The curtains that separate the hot side and the cold side of the server racks were installed in February. The controls work was completed early April. The installation of the Rawal valves on the compressors is being delayed to see if the air conditioning units run consistently without the valves. If that is the case, the valves will not be installed as this is the best configuration for the longest life span for the equipment.

#### **Kiddie Pool Project**

Proposal were accepted and reviewed following an RFP advertised by the County in March. A firm has been selected. A kick off meeting for the project design with the architect and the stake holder team will be held in mid-May.

#### **Municipal Building HAVC**

An evaluation was completed by a 3rd party engineer to establish the cause of the HVAC noise, and have since recommend solutions. Jaynes and their sub-contractors have agreed to perform the work which entails replacement of ducts throughout the building identified as those causing the noise. County Project Management is meeting with the contractor to coordinate the work and how it impacts the building, occupants and operations. When this is better understood, meetings will be held with the appropriate departments to minimize the impact.

#### Ice Rink Locker Room Improvements

Project Management staff is currently working on an RFP to solicit an architectural firm for design services. The RFP is scheduled to be advertised in May, after the Park and Recreation Board presentation of the shade study.

#### Mesa Library Fire Panel Replacement

Acceptance testing took place February 23rd and passed. Installation of Exit signs is 99% complete and approved by the Fire Marshal's office.

#### Fire Station 6 Restroom Remodels

The restrooms at Fire Station 6 will be refurbished as it has been a little over 10 years since they were last re-done and is looking worn. Riskin and Associates, one of the County's on-call architects, is providing the design. It is anticipated that construction could begin after July 1 and completed mid-Fall.

#### **Fire Station 3**

The project includes reroofing, as well as a new wall system, window replacement and HVAC system modifications to better insulate and control the temperature in the bunkrooms. Bids were received and are still be evaluated for award, which is now tentatively scheduled for May 22. If it awarded, construction is anticipated from July through the end of the year.

#### **Mesa Library HVAC Improvements**

One bid was received and the project is seeking a rebid of the project.

#### Canyon Rim Trail Phase 3

The easements for DOE property along the preliminary alignment have been approved by Council on the March 22nd. The County has been working with the consultant to prepare to obtain easements with the private owners within the project limits between Knecht Street and the 20th Street Extension.

#### **Canyon Rim Trail Underpass**

The project was awarded federal FY2018 funding under the Transportation Alternatives Program (TAP) for project study and design in the amount of \$320,000 and FY2020 TAP funding for project construction in the amount of \$2,020,000 for a total award of \$2,340,000.

#### North Mesa Phase 2 Improvements (Cumbres del Sol Subdivision)

Staff is working on completing the bid package for improvements to Camino Manzana/Mora/Cereza. An invitation for bids is tentatively scheduled to be advertised on May 6<sup>th</sup>, and construction is anticipated to begin in July and be completed by late Fall. The project entails new compacted base, new asphalt throughout, and intermittent concrete sidewalk, drive pads, curb & gutter, ADA curb ramps, as needed.

#### **Supplemental Environmental Projects**

NM 4/East Jemez Rd. (Truck Route) Intersection: Staff continues to work with DOE, NMDOT Bandelier, and Army Corps of Engineers to program, design and construct intersection upgrades to improve capacity and safety. The USACE is in the process of developing an RFP for design services.

#### Future Projects...

 NM 502 Reconstruction, Knecht St. to Tewa Loop: Staff continues to coordinate with NMDOT on this state lead project. NMDOT bid the project for a third time on December 15<sup>th</sup> and received no bidders. The County awaits further information from NMDOT management on the future of the project.

#### **Environmental Services Division**

#### Landfill - Gas Extraction and Control System

Engineering and Environmental Services staff have worked with Stearns, Conrad and Schmidt Consulting Engineers (SCS Engineers), an engineering consultant to develop design plans for a permanent gas extraction system for the landfill to comply with New Mexico Environment Department methane gas limits.

The Project consists of the installation and construction of a Landfill Gas Collection System at the closed landfill to prevent subsurface landfill gas migration off the landfill property in accordance with New Mexico Environmental Department regulations. The project will include the installation of two (2) systems, which will either destroy the gas in an open flare or vent it to the atmosphere. Both systems have been designed to disburse any emissions above ground level, whereas the open flare system will also combust any potential pollutants.

The permanent extraction system project was advertised for construction in December, Council awarded a bid on February 27th to American Environmental Group (AEG) with SCS oversite for \$1,281,490.

Notice to Proceed was given to the contractor on March 14th. Construction activities began on April 23rd. The Substantial Completion date is August 1, 2018 with a Final Completion date of August 22, 2018.



This is a summary of results for March 2018 methane monitoring for the Los Alamos County closed landfill.

- 1. 1The LFG Vents ranged in methane concentrations from 48 (LFG vent 7) to 59.9 (LFG vent 1) percent gas in air.
- 2. The gas probes near the toe of the landfill materials ranged in methane concentrations from 2.3 (MP-12) to 51.7 (MP-8) percent gas in air.
- 3. The gas probes near the boundary of the landfill ranged in methane concentrations from 1.1 (MP-8R) to 19.8 (MP-9R) percent gas in air.



**Curbside Yard Trimmings Roll Cart** 



Online registration is now open for the curbside yard trimmings roll cart program. The yard trimmings roll cart program will begin July 2018. To date Environmental Services has received over 1,850 registration entries for a roll cart, this is over 20% of the residential customer base. By implementing the yard trimming roll cart, Los Alamos residents have an opportunity to divert 14% of our waste

stream from the landfill each year. The diversion efforts have the potential to divert 1,107 tons of yard trimmings annually and will reduce hauling and disposal costs, greenhouse gas emissions, extend the life of the landfill, and provide high-quality garden and landscaping materials for residents. Environmental services received 1,872 roll carts and has begun to assemble them. Starting now and continuing through June Environmental Services staff with help from Code Enforcement staff will be assembling and delivering carts to residents that have registered.

#### Yard Waste Mulching Operations



In preparation for the new curbside yard trimming program Environmental Services staff is busy mulching the current brush pile at the Eco Station. To date staff has reduced the brush pile by half. Over the last 30 days Environmental services has diverted over 160 tons of mulch from the landfill to be used as ground cover or turned into compost.

#### **Environmental Services Recruitment**



Environmental Services would like to congratulate Lucas Gomez on his promotion to Scale Operator. Lucas started with Environmental Services 1 year ago as an Environmental Services Trainee. Lucas showed his commitment to the operation and is a great asset to the division.

Environmental Services currently has two vacancies; recruitment efforts are underway for Two Environmental Services Trainees.

Environmental Services hosted a booth at the 2018 Earth Day event at the Nature Center on April 21. In the below left pictures ESB Member Heather Ward plays the recycle game with residents. The recycle game helps teach what is and is not recyclable. Bob Osborn from the New Mexico Department of Game and Fish attended the event. Mr. Osborn was promoting and demonstrating how to use the new Bear Tough rollcarts that Environmental Services

purchased in collaboration with federal grant funds from New Mexico Game and Fish. Bear Tough carts are available for sale at a reduced price of \$77 per cart. The original price was \$200.

#### **Clean-Up Los Alamos Day**



On Saturday April 28<sup>th</sup>, Environmental Services hosted the 15<sup>th</sup> annual Clean-Up Los Alamos Day. 














#### Month by Month Recycling Comparison



Benefits of Recycling

Recycling of aluminum cans saves 95% of the energy required to make the same amount of aluminum from its virgin source. One ton of recycled aluminum saves 14,000 kilowatt hours (Kwh) of energy, 40 barrels of oil, 238 million Btu's of energy, and 10 cubic yards of landfill space.


#### **Transit Division**

In preperation, the division hires and trains additional drivers to perform the service. We would like to welcome the following new employees to the Transit Divison.






