ESB Chair Robinson reported that he has been elected to County Council and will no longer be on the ESB as of January 2019. He attended the Boards and Commissions luncheon.

#### B. Board Member Reports (3 Minutes Per Member)

Member Barns reported on the Recycle Craft Fair and Fashion Show held at Chamisa Elementary School and noted the event was zero waste.

#### C. Liaison's Reports (3 Minutes Per Member)

#### 1). Board of Public Utilities - Sue Barns

No report provided

#### 2). Planning and Zoning Commission - Vacant

Chair Robinson reported that items discussed during the last Planning and Zoning Commission meeting included approval of a lot split and lot line adjustment. LANL project manager, Dan Pava, presented on land transfer and conveyance. Dan Erickson from Los Alamos County Traffic and Streets discussed traffic calming measures implemented by the County near the golf course and the new A19 development in White Rock.

#### 3). Transportation Board - Heather Ward/Don Machen

Member Ward reported that items discussed during the last meeting of the Transportation Board included a contract has been awarded for the major highway 502 road work including the roundabout at the intersection of Central Ave. and Trinity Dr. A request for approval of the installation of a rapid flashing rectangular beacon for pedestrian crossing near the golf course has been sent to Council for approval. NM 4 and E. Jemez Rd. intersection reconstruction to include a parking lot for the National Park Service. The fence project at the Los Alamos Municipal Airport is well underway and the hangar project is nearing completion. Atomic City Transit had 96,000 riders took the shuttle to Bandelier.

#### 4). Parks and Recreation Board - James Robinson/Heidi Rogers

Chair Robinson reported that items discussed during the last Parks and Recreation Board meeting included that the CIP projects including the pool, splash pad, shade structure and golf course improvements are on hold until the LANL tax status is settled. Selection of a flow trail site is moving forward with Bayo Canyon being eliminated. Canyon Rim Trail Extension is moving forward.

#### 5). County Council Liaison - Pete Sheehey

Council Liaison Pete Sheehey reported that the Council approved to go ahead with financing for the new Waste Water Treatment Plant in White Rock. Construction and operation of a columbarium at the Guaje Pines Cemetery was approved. He commented on the County Council election and that a vote to take away the sunset date for NCRTD funding passed.

Due to Christine Chandler being elected to the State Legislature the Council will appoint a replacement.

Staff Liaison Angelica Gurule reported on the Recycle Fair and Fashion Show and thanked the participants and all who helped with the event.

Member Bakosi reported that the presentation to the Walden School has been moved From December to January.

#### 2). Zero Waste Los Alamos - Sue Barns

Member Brown reported that items discussed at the Zero Waste Team meeting included setting specific goals on how to reduce food waste. Desirae Jimenez is willing to help with presentations and developing pilot programs for reducing food waste at Los Alamos Public Schools.

The Zero Waste Team toured Reunity Resources, a food composting facility in Santa Fe. The November Article for the Daily Post will be about zero waste holiday ideas by Member Ward.





• Sec. 8-232. - Membership, terms and qualifications. The board shall consist of seven members. The members shall serve for staggered two-year terms beginning on August 1 and ending on July 31, except that three members on the initial board shall only serve for one-year terms.

(Ord. No. 02-078, § 2, 10-3-2006; Ord. No. 02-094, § 3, 6-10-08)

• Sec. 8-233. - Duties and responsibilities. The environmental sustainability board shall serve in an advisory capacity to the county council and shall have the following functions, responsibilities and duties:

- (1) Gather and provide citizen input to staff and council on ways to improve the county's environmental sustainability and on proposed environmental sustainability policies, programs and services. For this purpose, the board shall gather public input in ways appropriate to the circumstances.
- (2) Recommend ways to involve and educate the community on environmental sustainability issues. Review and comment on public involvement and information plans (PIIPs) related to environmental sustainability projects outside the department of public utilities.
- (3) Review and comment to council on environmental sustainability master plans.
- (4) Review all environmental sustainability related matters submitted to the board by council.
- (5) Coordinate with other boards as appropriate on environmental sustainability activities.

(Ord. No. 02-078, § 2, 10-3-2006; Ord. No. 02-094, § 4, 6-10-08)
