Title

White Rock Cliff Cave - Hell's Hole Gate Project

Body

In July of 2017, a local teenager fell approximately 400' from a ledge outside of Hell's Hole cave, resulting in his untimely death. Prior incidents in the same location have also resulted in death and/or serious injury. While recognizing that there are many natural hazards in Los Alamos County, the family of the teen have approached County staff requesting that the County consider eliminating this particular hazard, either by blocking the specific entrance to the cave or by other means.

Harry Burgess (County Manager), has been a caver for the majority of his life and when he first heard of this request, Harry met with the family to discuss their concerns and potential suggestions. Following this meeting, Harry and his son Garron visited the cave, assessed the hazards, and took many pictures of the concerning areas. These pictures were then presented at a local caving club meeting (Pajarito Grotto), and the members of the Grotto offered their support in determining an appropriate solution that seeks to protect both the cave and the people visiting it. In November, several members of the Grotto visited the cave along with Mr. Burgess, and various solutions were discussed along with additional pictures taken and an initial survey of the size of the entrance (see attachments).

The purpose of the discussion this evening will be to obtain input from the committee as well as members of the public regarding the appropriate solution. At present, the suggested action would be to close/block the southernmost entrance to the cave, as this entrance provides access to a particularly exposed ledge - roughly two feet wide and covered with pea-sized rocks (rendering the ledge slippery) - that overlooks an approximate 400' drop. The cave has several other entrances that are safer to utilize (albeit still exposed), and therefore a blockage of this particular entrance would not prevent normal visitation of the cave. The purpose of the chosen suggested closure would be to prevent visitors from using this entrance as an exit, as the returning climb from this entrance is particularly exposed and its use is believed to be the cause of prior accidents/deaths.

This issue brings forth numerous other considerations, including:

- Should the County be altering the natural landscape in its open-space areas
- What are the liability concerns of addressing naturally occurring exposures
- Are there other similar, necessary improvements for public safety
- Does the County need to develop a policy for memorials within open space areas
- Are there other, less-impactful remedies such as signage (others?)
- Would this activity negatively affect the cave or wildlife it harbors

It is hoped that through a discussion, these concerns and any others may be identified and expanded upon in order to inform any potential solution that is considered.

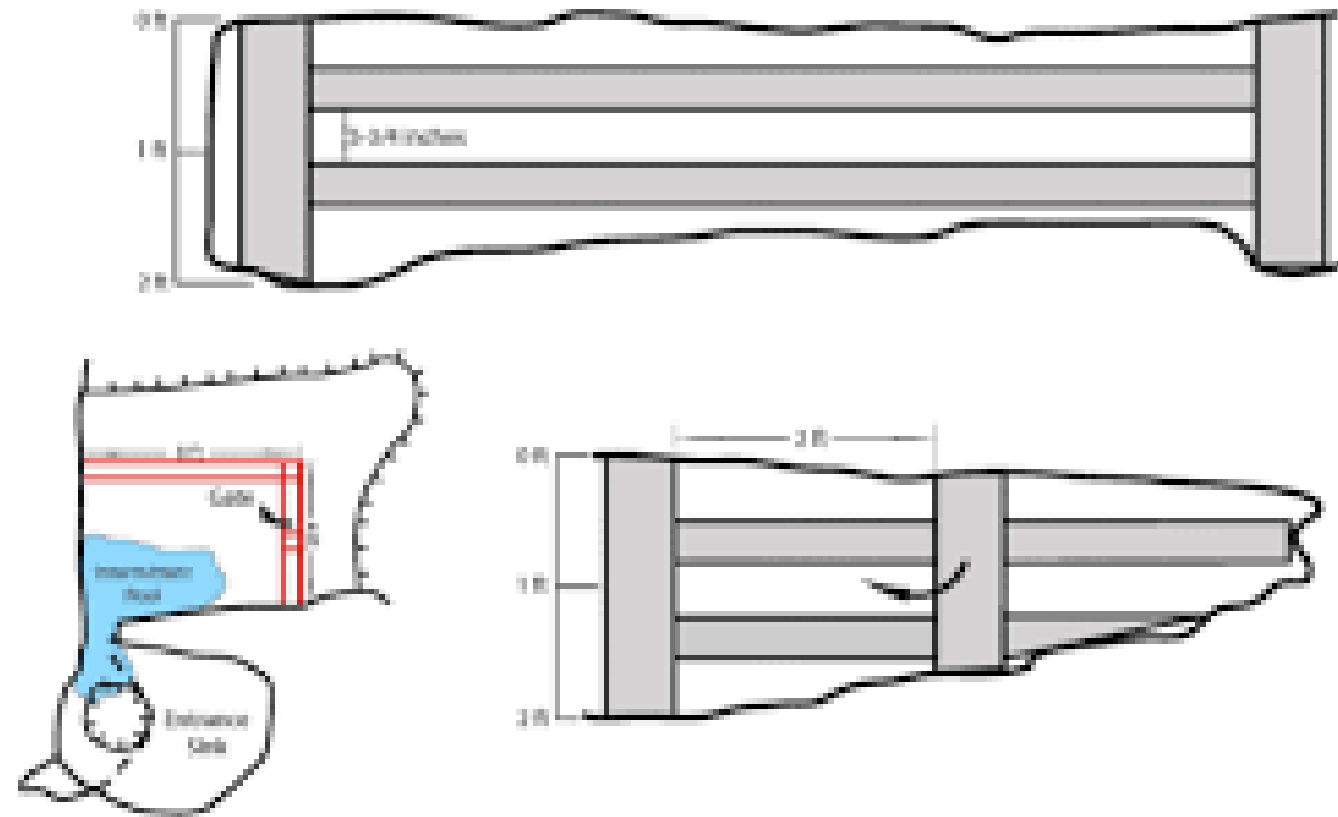

Update on the Reallocation of Portable Outfield Fencing Funding

Body

Status on the ball fields:

- Initially, a quote was obtained from an Albuquerque based fencing contractor to install the entire system including aluminum poles and the netting. It was found that the price was rather high, so another approach was considered to save cost.
- The next approach considered was to have the Department of Utilities provide engineered drawings and install "telephone poles", followed by a vendor to install the netting. Utilities has the ability to do the engineering for poles, but they are electrical engineers and do not have the ability to provide a Professional Engineers stamp for the structural requirements for obtaining a building permit from the State. It was considered to hire a structural engineer to provide the needed drawings, but it was thought that it would be more efficient to have a vendor provide the engineered drawings since it is common for netting installations that the vendors provide the engineering for their netting systems.
- A vendor was located that has an existing GSA contract so the specifications were sent to them. They responded that they could only do one ball field for the allotted budget.
- We are now taking the approach of issuing a Request For Proposals (RFP) to find the best price and get the most from the budget. The RFP is expected to be advertised by January 16th.

Update on Ice Rink Programs

Body

Los Alamos County Ice Rink - Youth Stick & Puck Program History

Started in November 2009 by Los Alamos Hockey Association (LAHA) Coach Dash Weeks. LAHA requested this low use ice time and provided supervision by volunteer coaches and all equipment (pads, helmets, sticks, pucks).

- o Requested program to help build youth participation in hockey.
 - o Registered LAHA players allowed to use their season pass for stick & puck.
 - o 2009 - 2018: Non-LAHA paid attendees averaged four to six participants per month (Nov, Dec, Jan, Feb).
- Summer 2018: LAHA requested to discontinue the program and utilize the ice time for practices.
- Fall 2018: Email received from a LAHA parent requesting the return of Youth Stick and Puck at the Los Alamos Ice Rink.
 - o During the current season I have been approached by a community member who has requested the same as they were going to bring their children.
 - o I have also been approached by a couple LAHA players who miss this unstructured ice time.
 - o Have spoken with all concerned that we are looking into what other programs are doing across the program and what it could take to bring back as a County program.

Reviewing other Youth Stick and Puck programs across the Country:

Stick and Puck is an opportunity for youth to practice hockey skills in an open ice environment. All participants must have a signed waiver (parental consent and signature needed if under 18 years of age) before entering ice.

- Each player must have their own helmet, skates, gloves and stick.
- Helmets MUST be worn at all times (helmets should be USA Hockey approved)
- Full face shields are strongly recommended
- There are to be no small/full ice games/scrimmages or goalies
- Be aware of those around you when shooting/skating for a puck
- Fighting and horseplay are not tolerated
- No private lessons, organized practices
- No slap shots

Most programs are loosely supervised, like Open Gym sessions, that allow players to practice skating and puck handling. (The Pond, Chagrin Falls, OH; Flint Iceland Arenas, Flint, MI; Big Bear Ice Arena, Denver, CO).

- All charge a fee, between \$6.00 - \$12 per person for each session. Hockey season passes are not accepted. Only punch passes for Youth Stick & Puck.
- Per my contact at USA Hockey, their facilities in Michigan required a staff member on the ice during youth stick and puck.
- Some Youth Stick and Puck programs separate players by ages and school level.
 - o 10 & Under
 - o Grade 8 & Below
 - o 9th - 12th Grade

Some require pre-registration and limit the number of youth on the ice.

The Aquatic Center gave away 100 bags of free cotton candy to pool patrons throughout the day. Both kids and adults were thrilled to receive treats after their lap swims.



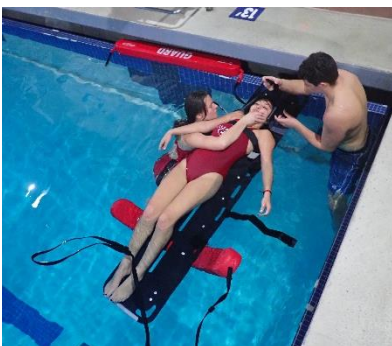
Holiday Fun Wacky Wednesday – December 19, 48 participants:

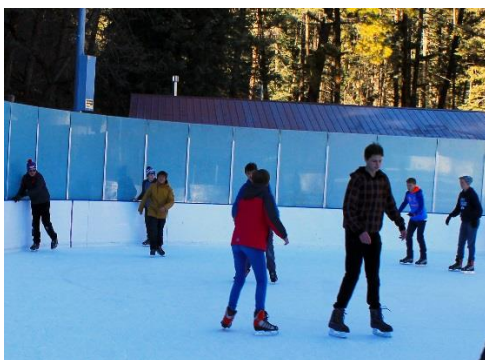
First Session Ice Skating Lessons – 17 group lesson participants, 5 private lessons

Students, teachers and chaperones enjoyed a day on the ice that included treats and hot cocoa.



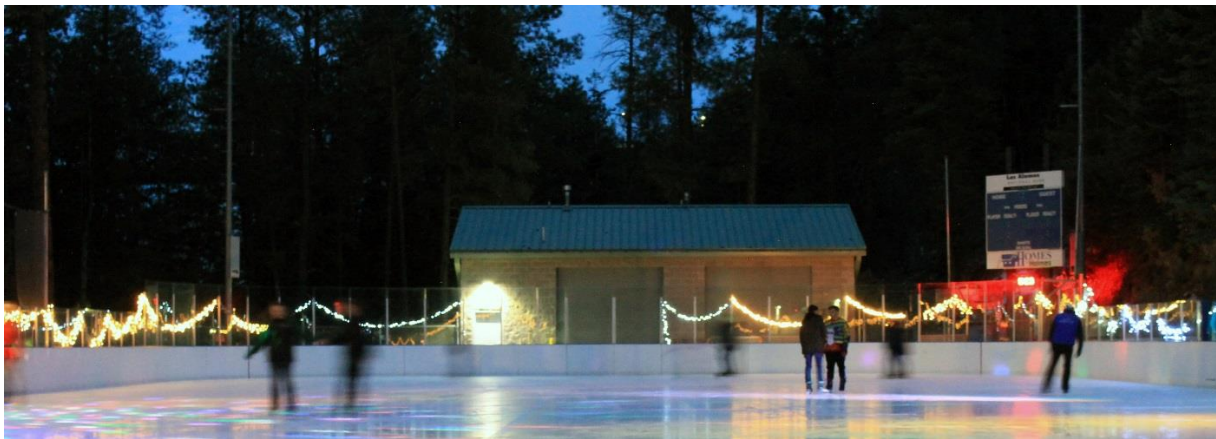
Piñon Elementary School – December 21, 65 – 6th graders & 12 chaperones

Students, teachers and chaperones enjoyed ice time on the last school day before the Winter Break.



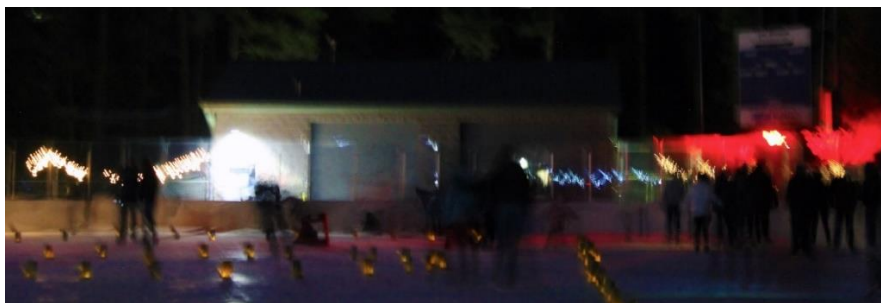
Ugly Sweater Holiday Party – December 21, 27 participants

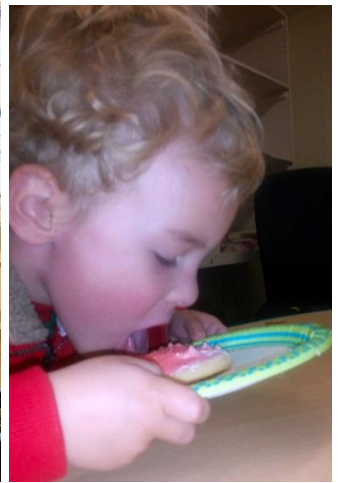

Columbarium Sales began December 21 – 100% complete
