In accordance with the "Los Alamos County Council Appointment Process for Selection of Board of Public Utilities Member" (Process), the Board of Public Utilities Member Selection Committee (Committee) interviewed eight candidates who have expressed an interest in being a member of the Board of Public Utilities. The Committee must therefore decide on the final list to be forwarded to Council in such an open meeting.

The Process only allows for a limited number of names to be considered by Council, so the only alternatives available are to decide which names are to be forwarded, from a minimum of two up to a maximum of six.

I would like to participate in my community in an activity where I have a genuine interest. I think the manner in which our community operates the water, electrical, gas and waste systems is important. These activities are at the interface between people and environment. It involves economics and technology. I know I have a lot to learn and would enjoy the process of becoming educated so as to help formulate good decisions for our community.

What volunteer or professional activities have you participated in that could apply to this appointment?

I am an experienced researcher, having worked at LANL for 20 years as a technical staff member. I have also been employed as a university lecturer in physics and a high school teacher. I lived in France for 4 years and Sweden for 2 years. I mention these re-locations because I gained first hand experience with how these countries, and the local municipalities within which I lived, managed the utility needs of their communities including how they heated their homes, managed waste, compost, internet service, public transport, electricity generation, gas, etc. The case of Sweden is particularly interesting because the Swedes have the lowest carbon footprint per capita among the developed economies of the world. In the past year I have been active in utility related matters. Of note, I participated in the March 3, 2019 informational meeting in Taos that was focused on learning how Kit Carson Electrical Cooperative and Guzman Energy managed to transition the energy supply in the Taos region from coal to solar. Furthermore, I have participated in small group meeting with individuals at both the LA County and at LANL who participate in the day to day running of our electricity infrastructure.

Yes, I will be able to dedicate the necessary time.

I have lived in 8 states in towns as small as 4,000 people to large cities including Los Angeles and Houston. I lived in the Phoenix Metropolitan area (Mesa) when that state first deregulated electricity and Las Vegas, NV and Houston, TX when deregulation was being debated. Living in all these places has exposed me to various rate structures and pricing for utilities as well as when smart meters first came to Phoenix, Las Vegas, NV and Houston. All in all I feel very qualified to represent the citizens, as well as to be able to explain to the citizens any and all decisions the Board makes.

I have been a contract specialist in the U.S. Air Force which required the knowledge of a 52 volume set of regulations (in the pre computer age) as well as writing, soliciting, reviewing bids, awarding contracts, managing contracts, administering the Zero Overpricing and Construction Supply offices at Nellis AFB NV. Also researching and advising the base attorneys and superiors up to and including the base General. I have worked 10 years in construction. 4 years as a Sheet Metal worker in construction of casinos in Las Vegas, NV and 6 years as an Electrician in residential, small commercial and casinos in both Las Vegas, NV and Phoenix, AZ. I worked 5 years as a Stationary Engineer (building maintenance) at the Sahara Hotel/Casino and Caesars Palace. This work experience has given me an in depth understanding of not just electrical distribution and loads but also by seeing and asking questions of the other trades the basics of water supply, wastewater removal, and gas lines and regulators including working on gas lines in the kitchens at the Sahara.

I would follow the lead of the County Council and be present myself and encourage other members of the BPU and DPU to attend Farmer's Markets, have Town Hall meetings, be at other events like the Rodeo Parade and Friday Night Concerts, and work for citizens to have more than 3 minutes at meetings of the BPU and County Council to adequately express themselves and their questions and frustrations or problems. As well as as discuss those at the same open meeting which is allowed under the Open Meetings Act as long as no action is taken on anything not already on the published agenda.

I communicate frequently with Mr. Westervelt about general public matters as well as my personal utility bill (being disabled and on limited income it sometimes is hard to make ends meet especially in the summer months). I also frequently email and speak in person with members of the County Council in regards to various public matters. I do not know any of the mentioned people personally, nor do I associate with them outside of public matters except for the mentioned personal utility bill payment plans.

The only one I can think of is if the BPU makes any decisions on who and/or how much public assistance citizens may get for their utilities bill.
