Instead of two categories the ESB expanded it to five categories: Schools, Businesses, Non-Profit Organizations, Small Businesses and Restaurants.

Member Barns received a comment about the questions for Recycler of the Year Nominee that it had too many questions. The ESB shortened the questions to six questions instead of eleven.

Member Rogers suggested to change the title of the award to Zero Waste Champion. All members were in agreement.

The Zero Waste team presented their findings from visiting local restaurants to understand how to help reduce (primarily) food waste. With the conclusion that restaurants are eager for the County's proposed food-waste composting, they want the County to re-offer energy audits, want more recycle dumpsters more conveniently located closer to their businesses as well as cardboard dumpsters for each individual business.

6. **REPORTS**

A. Chair's Report - Lisa Bakosi

ESB Chair Bakosi thanked everyone for their time and efforts working towards sustainability. She met with the Co-op manager and found out that starting on Earth Day they will offer 15% off their bulk items, then once a month after that.

B. Board Member Reports

Member Barns received a comment from a resident regarding county vehicles idling while on the job. She wanted to know if there was any rules or regulations about idling cars.

C. Liaison's Reports

1). Board of Public Utilities - Sue Barns

Member Barns reported on the SMART meters that will be kicking off in June. The expectation of the first installments in August or September. The Board of Public Utilities had nine applicants for one open seat. The utilities manager Tim Glasco will be retiring this summer. Billing is getting better but there is still a lot of issues with the billing system and with the mobile app interface. There were ten water break lines due to the ground thawing and corrosion. They started to test the new water well in Otowi well #2 but NMED wanted proof that the water that will be pumped out is safe before they test with the pumping system. In the May meeting there will be a presentation on community solar garden and they want to increase solar at the landfill. The June meeting will include the quarterly conservation report.

2). Planning and Zoning Commission - Vacant

No report was provided.

3). Transportation Board - Heather Ward

Meeting was cancelled.

4). Parks and Recreation Board - Heidi Rogers

Member Rogers reported that the Parks and Recreation Board has the Youth Conservation Core Trail Building projects coming up in the summer. As well as they replanted the trees that were located where the new round-a-bout will be. They are going to talk about Round Up at another meeting and she proposed that the ESB put Round Up in the upcoming agenda.

5). Community Development Advisory Board - Warren Mazanec

Member Mazanec reported that the board reviewed code changes. He also mentioned that he will be talking at their next meeting about presenting for the Save As You Throw team.

6). County Council Liaison - Antonio Maggiore

Councilor Maggiore reported that the council is half way through their budget meetings. He also thanked the ESB for all the work they are doing.

She also reported about the meeting Angelica and herself went to with Los Alamos Public School Superintendent Kurt Steinhaus to discuss greener cafeteria and recycle in school.

Member Barns reported that the Zero Waste Team met and had a presentation by Tiffany Pegoda. Discussed ways to promote backyard composting. They also got to watch the Zero Waste Team - Food Waste Reduction for Los Alamos Restaurants presentation.

Staff Liasion Angelica Gurule reported that the County Green Team will hold their Earth Day event at the municipal building and that they worked to get water bottle filling station for the County employees. Environmental Services has sent two loads of glass to Coors Miller. She also asked for volunteers to help at the Earth Day Festival at PEEC and upcoming xero waste concerts.



The Issues

Residential waste disposal by LAC Environmental Services is paid for through monthly fee (\$25) charged on Utility Bill

- provides support for all residential disposal services:
 - curbside trash, recycling and yard trimmings collection, transport and disposal; Eco Station services: "12 free loads", household hazardous waste, electronics recycling, gast recycling, icir erecycling, mulching, assisted refuse service, Sullivan Field Recycle Center, Overlook Ctr., etc

Costs go up annually for pretty much everything

many are external (transportation, recycling, landfill, HHW, etc.) recouped by rate hikes

LAC Strategic Goals: environmental stewardship, sustainability, quality of life, appropriate levels of county services

LAC Sustainability Plan Goals: reduce waste and Greenhouse Gasses, increase recycling

One approach that can address all of these is switching to Tiered Rates aka. "Save-As-You-Throw" (SAYT)





Why Change?

Tiered rates are more equitable, charge based on use, like electricity, gas, food, etc. Gives residents more control over budgets

Well-documented (>7000 US communities; >25 yrs.) to reduce trash, increase recycling Saves \$\$, landfill space, resources, GHGs, etc.

Reduced Waste = **Reduced cost to LAC**, reduced rate hikes


Preferred by citizens (once implemented)


- Third most favored approach to increasing LAC recycling, based on meetings and poll of residents
- Raises awareness of environmental/sustainability issues

















Why not change?

Concerns include:

- "Change is hard and scary!"
- Time and effort needed to engage and educate residents
- Temporary increase in T&E for Environmental Services staff
- Some \$ outlay for materials (carts, education, etc.)
- Difficult to implement in multi-family units
- Rate-setting can be tricky

Comments from Earth Day

- 1. I live in an apartment
- 2. Nice- good idea
- 3. More fair because some people go way over and some people go under
- Sweden does a bag based system where different colors mean different types of material, we should look into it.






March Diversion Rate: 24%


April Diversion Rate: 30%


The diversion rate is the percent of recyclable and compostable material diverted from the landfill.
