III. APP Board Business

- a. Approval of Minutes from May 23, 2019

Board Member Carson moved to accept the minutes from the March 23, 2019 meeting. Board Member Mackey seconded. All voted in favor (4/0)

IV. Updates and Possible Action on Current Projects

- a. Donation offer of "Sunflower" created by Ed Grothus
Board Member Baker will follow up with Joe Lindsay of Sculpture Smart and Steve Huebner on the details of the engineering report and refurbishment proposals.

Motion:

Board Member Mackey moved that the Board continue to explore the feasibility of accepting the "Sunflower" sculpture and installing it on the Eco Station Building with the assumption that engineering reports, disassembly, refurbishment, and installation costs would not exceed \$35,000 including contingency. Board Member Carson seconded. All voted in favor. (4/0)

- b. Donation offer from Richard Swenson
A staff report has been prepared and the item will go before Council on August 6.
- c. Art for White Rock Senior Center
Public opinion on the relocation of "Apache Harvest" has been positive.

- d. Evelyn Rosenberg commission
The artist has started to design the piece and has submitted an initial invoice.
- e. Don Taylor photograph
Board Member Mackey will prepare a staff report for Council to consider. If completed by August 16 it could be on the agenda for the August 27 Council Meeting.
- f. Jeff Segler painting proposal
The Board plans to gather public opinion at the Art Show on the Fuller Lodge Lawn on August 10. Alternate locations inside Fuller Lodge or at another location could be considered.

- a. Joe Lindsey of Sculpture Smart has recommended restoration work on three pieces: The fountain at the White Rock fire station, "Nexus" at the golf course, and "Strange Trio" at the entrance to Overlook Park.
