- Project Improvements include - Landscaped median installation, sidewalk, ADA ramps, landscape buffers, pedestrian crossing improvements, traffic signalization, roadway & pedestrian lighting improvements, bicycle lanes, and transit bus pullouts.

12327-19**FY20 Snow and Ice Control Plan - Juan Rael, Traffic & Streets Manager**

Discussions were held with County employees, residents, and the Transportation Board regarding the FY20 Snow and Ice Control Plan. Mr. Rael provided a list of changes that were made to the Plan that derived from the meetings.











TAXIWAY TOO NARROW WITH INADEQUATE CLEARANCE



TAXIWAY HOLDING POSITION LINES TOO CLOSE TO RUNWAY




AIRCRAFT HAVE DIRECT ACCESS TO THE RUNWAY FROM RAMPS


ENVIRONMENTAL REMEDIATION LIMITS AIRPORT DEVELOPMENT




FAA SAFETY AREAS LIMITS AIRPORT DEVELOPMENT


LAST DEVELOPABLE AREA ON THE AIRPORT...



...IS LANDLOCKED BY AIRPORT ROAD AND HANGARS





# Private Sector Initiative

- Scooters owned and delivered by for profit vendor
- APP based user interface with credit card requirement
- Scooters have GPS and can be located using the APP
- Fees typically charged per use (*50¢ to \$1.00 to unlock*) and for time-in-use (*per minute charge usually around 15¢*)
- Users responsible for leaving scooter in suitable public locations
- Private firm responsible for maintaining/charging/relocating
- Local government responsible for ordinance to regulate use

# Benefits to Local Communities

- Inexpensive user option for short trips or first/last mile of trip to/from transit
- No public sector investment in capital or ongoing equipment upkeep/maintenance
- Typically more successful in terms of usage than bike-share programs
- Enjoyed by tourists and locals alike
- Available to most (*requires smart phone and credit card*)

# Challenges for Los Alamos Deployment

- Deployment is market-based: vendor decides when, where, and number of scooters to be located in a community
- Vendors not willing to disclose metrics involved in deployment decision
- No interest expressed by firms to initiate non-subsidized pilot program in Los Alamos

# Staff Recommendations

- Discuss prospect of non-commercial deployment within Los Alamos National Laboratory
- Have example ordinances and policies from communities where successful deployments have occurred “at the ready” should future deployment occur in Los Alamos (*Santa Monica, CA model widely used*)
- Ensure ordinance and/or policy addresses identified challenges such as, but not limited to, the following:
  - Regulating rider behavior (*where they ride on road and within community*)
  - Encouraging rider safety (*helmet laws and rider training opportunities*)
  - Controlling parking of scooters when not in use (*define areas to which parking is limited*)

## Airport Division

### Sweeping Operations

Crews from the Streets Division of Public Works recently undertook sweeping operations on the airport runway, taxiways and ramps. Keeping these surfaces clean and free of debris is vital for the safe operation of aircraft. Debris on runways and taxiways can pose a significant risk to aircraft, pilots and passengers – with takeoff and landing speeds that can exceed 100 miles per hour, even small debris can puncture tires, cut break lines, damage landing gear and destroy aircraft propellers and jet engines. Daily inspections and regular sweeping operations help to ensure a pristine, debris-free, environment for aircraft operations at Los Alamos Municipal Airport.



## Custodial Division

-  The Custodial Division supported 368 events during the month of October.
-  The Custodial Division purchased three new snow blowers for supporting snow removal efforts this winter.
-  Floor work was completed at the Police Department.
-  Exterior windows were cleaned at the Community Building.

## Engineering & Project Management Division

### In Memoriam



Desirae Lujan passed away on October 20, 2019. She began her employment with the County Public Works Department in 2015 where she currently held the position of Senior Engineer. She earned a Bachelor of Science in Civil Engineering and a Minor in Mathematics from NMSU and a Master of Engineering Degree from UNM in 2019. She was a Licensed Professional Engineer, Certified Floodplain Manager, and Certified Storm Water Manager.

Some notable projects managed and completed by Desirae while with the county include the recently completed Diamond Drive Resurfacing Project, Tsikumu Village Road Improvements, 20<sup>th</sup> Street Extension, Knecht Street Improvements, and Central Avenue Phase II Improvements. She helped author the Bicycle Transportation Plan, implemented bike to work activities, and was instrumental with acquiring

Bicycle Friendly Community designation for Los Alamos from the League of American Bicyclists.

She represented the county and department well as a member of the Regional Transportation Planning Organization including project review and coordination with DOE/LANL, NMDOT and developers. She was currently managing the Canyon Rim Trail Underpass Project (slated for construction next year), Canyon Rim Trail Phase 3, Urban Multiuse Trail and Barranca Mesa Road Improvements. Desirae was instrumental in acquiring and managing over \$6M in federal funding for transportation improvements in Los Alamos County.

Desirae was well-respected in her field and was a thoughtful, considerate co-worker, colleague and friend to many. She will be deeply missed.

### **NM 502 Reconstruction, Knecht St. to Tewa Loop**

Staff continues to coordinate with NMDOT on this state lead project. Agency coordination is ongoing for projects occurring on or near DP Road for public outreach.

### **Canyon Rim Trail Underpass**

A final submittal was sent to NMDOT. Final plans are anticipated following the approval of the plat by NMDOT and receipt of NMDOT certifications. Construction is anticipated to begin in March 2020.

### **Tracts A-13/A-12 The Hill Apartments Offsite Improvements**

Following the May 2<sup>nd</sup> Transportation Board meeting the traffic analysis was completed and was submitted to NMDOT for their review and approval, as Trinity Dr. is a State facility. The recommended alternative was presented to County Council on June 25<sup>th</sup> and comments were received to refer to NMDOT for their review. Final design is ongoing and is anticipated to be complete before the end of 2019, pending NMDOT review.

### **Piñon Park Splash Pad**

A public meeting was held August 28<sup>th</sup> at Fuller Lodge where the Design Professionals (Surroundings) presented two conceptual designs and solicited public comments. After analysis the consensus was to utilize a 'nature and science' theme much in alignment with the County logo. The design team is working on the schematic design which will be presented at the November 14<sup>th</sup> Parks and Recreation Board meeting.

### **Golf Course Irrigation Project**

MRWM Landscape Architects is preparing for a presentation to the Parks and Recreation Board to be held on November 14<sup>th</sup>. County Staff has reviewed the design and formulated comments and were incorporated by the design team. An RFP is being developed to address additional golf course improvements in accordance with the prior council presentations.

### **Golf Course Clubhouse Patio Enclosure**

A design is currently being reviewed and evaluated for additional scope by County Staff.

### **Aquatic & Airport Roof Renovations**

Aquatic Center: Work includes re-roofing the flat roof portion of the center's roof, correcting structural issues with a portion of the roof structure in the mechanical room area damaged by excessive humidity, install an exhaust fan to address humidity build-up and create air flow, and add roof-mounted electric heat mats for the northern side.

Airport Roof: Work includes re-roofing, adding posts for the Civil Air patrol radio antennae system to increase its range, and new fascia and downspouts.

The project is designed by FBT Architects. This project went out to bid and had one incomplete bid. It was re-bid and bids are due Oct 31. Target award is November 26<sup>th</sup>. The project is scheduled to begin mid-March, starting with electrical work at the Aquatic Center, with roofing work at both facilities the following month.

### **Fire Station 6 Restroom Remodels**

Crews with Allied 360 continue work on the larger of the 2 restrooms and should be finished in November. The new walls are installed with tile placement and the re-building of the shower pan to follow. The new epoxy floor will then be installed. Work on the smaller restroom will begin thereafter. Work will continue until early January with a Final Completion at the end of February 2020.

### **Ice Rink Improvements**

Public meetings were held September 25<sup>th</sup>, 5:30 pm at Fuller Lodge and October 23rd at the library, with layouts and potential building elevations depicted. A combination of the layouts and a building elevation was unanimously chosen and the design team, NCA Architects, is working through design completion. The project will also go to Planning and Zoning November 13<sup>th</sup> for a site plan amendment. Once the design is complete, construction bids will be solicited. Construction is tentatively scheduled for March thru October 2020, and final completion slated for the end of the year.

### **Mesa Library Drive-thru Roof Change**

The roof over the drive thru is being re-worked to allow the drainage to flow directly off onto the landscaping below rather than thru the roof drains which had a tendency to freeze and plug during the winter, causing damage to the ceiling of the drive-thru. Work should be complete by early to mid-November, weather permitting.

### **Kiddie Pool Project**

FBT architects has been working on design development phase of the design. A public meeting with the Parks and Recreation Board is planned for November 14<sup>th</sup> and a site plan review with the Planning and Zoning Commission is planned for December 11th.

## Eco-Station Ventilation Fans Upgrade

This project increases the size of the ventilation fans for the transfer station to better manage a high level of dust and improve safety for the public and staff. The design is complete and a contract for installation is currently under review by purchasing.


## Sunflower Art Piece

Engineering design and cost estimate is being procured through the engineering and architectural services on-call contract for reinforcing the sunflower art piece and for the reinforcing the transfer station building structure for installation. This project is funded with Art in Public Places budget.

## Environmental Services Division

### Los Alamos County Landfill Gas (LFG) Update

With the installation of the Landfill Gas Control and Collection system, the methane concentrations have decreased, and methane levels are in compliance with NMED Solid Waste Rules. Environmental Services has received approval from New Mexico Environment Department (NMED) to reduce monitoring from weekly to quarterly as prescribed by NMAC Solid Waste Rules.



## Professional Development



Office Specialist, Sara Thurgood, went to Albuquerque for training to become a certified Compost Facility Operator. The training was presented by the New Mexico Environment Department, Solid Waste Bureau. The course teaches different composting methods, composting processes, and the benefits of compost. 

## National Bioneers Conference 2019









### Crews Installed Re-Useable Bottle Filling Stations Countywide



The Los Alamos Environmental Services Division received a grant to purchase and install new drinking fountains that serve a dual purpose as re-useable bottle filling stations. Several locations have already received the new equipment (*Eco Station and Fire Station #3 pictured here*) which features a counter that displays the number of re-useable bottles filled – suggesting that number of single use plastic water bottles were kept

out of the waste or recycling stream.

### White Rock Senior Center – Electric Vehicle Charging Station Upgrade



The White Rock Senior Center has a dual port electric vehicle charging station that has become increasingly popular with the public. The impact of the popularity has resulted in more than one vehicle charging at the site at the same time. Although the charging equipment allows for multiple cars charging simultaneously, until recently the increased load on the electrical feed tripped the breaker in such instances causing the entire charging system to become inoperable. But now, due to the good work of Facilities Div. electricians, a new heavier duty service line and breaker has been

installed which allows multiple cars to charge at the site simultaneously - which is a great improvement in reliability and much appreciated by those who make use of the facility.


Fleet Division




Fleet received a new Tymco Sweeper for the Traffic and Streets Division. It replaced the old Elgin Sweeper which was a 2005 model.

## Traffic and Streets Division



Crews installed a new Rectangular Rapid Flashing Beacons (RRFB) on Diamond Drive at the Golf Course crosswalk. The RRFBs are push button activated amber LEDs that supplement the warning signs at the crosswalk. They use an irregular flash pattern that is similar to emergency flashers on police vehicles. This flash pattern has shown to elicit a greater response from drivers than traditional flashers.






