





RECOMMENDATION FOR IMPROVEMENT

Thanks so much for meeting with us today. We are the CyberSonics—a First Lego League team, and we have been working on a project about how to improve our community, and we want to share it with you!

Two Serious Problems

2

- ▶ Our town's playgrounds aren't meeting the needs of older kids
- ▶ North Mesa Park is seriously unattractive and un-utilized

We love living in Los Alamos! This is a great place to be growing up, and we're really happy to be part of this community.

Having said that, we have become aware of two very serious problems in our town.

First, our town's playgrounds are not meeting the needs of older kids. For us, they are actually quite boring.

Second, there is a very large area of county land on North Mesa that is unattractive and under-utilized.

Let us explain what we mean...

Problem 1: Boring Playgrounds

Our town has a lot of parks—which is great! This slide shows pictures of the play structures from the biggest and most popular parks on the hill. Unfortunately, not a single one these playgrounds offers anything exciting, risky or challenging for older kids or pre-teens. One problem we see are that there isn't anything taller than one story. Also, they pretty much all just have two slides and a climbing element. The slides don't even go fast. There isn't anything that really gets any of us excited play.

Playgrounds Are Important

"A growing body of scientific research states that good playgrounds are important for developing children's physical literacy...Physically challenging play actions teach children to handle risk, but also how to handle stressful situations. In brief, playgrounds encourage and provide physical activity, social interaction and learning."

--Jeanette Fich Jesperson

International Manager at the KOMPAN Play Institute and vice-president of the European Network for Child Friendly Cities

- Older kids need challenging equipment that provides an element of risk.
- The majority of children above 10 years old fail to meet recommended 60 minutes of physical activity a day.
- Some studies link a lack of outdoor play opportunities to poor health and learning outcomes for children of any age.
- Appropriate play opportunities can help kids and pre-teens maintain healthy body weight and improve their mood and self-esteem.

There is a lot of research out there that talks about the importance of age-appropriate risk or danger in playground design. Playgrounds also need to be challenging—they should offer things that are hard to climb or balance on or reach or hold on to.

Besides the fact that an innovative playground would be fun and exciting for us kids, it's also an important motivator to get us outside and moving around. Our generation (like all the others) is way too sedentary! The majority of kids over age 10 fail to meet recommended 60 minutes of physical activity a day.

Having playgrounds designed with older kids and pre-teens (like us!) in mind would help us stay active, which, in turn, will help us maintain healthy body weight, and improve our mood and self-esteem.

Problem 2: Wasted Space

- Key qualities of effective public spaces:
 - Accessible
 - People are engaged in activities
 - The space is comfortable and has a good image
 - ▶ It is sociable

The second problem we want to discuss is this large, undeveloped "park" on North Mesa.

The Project for Public Spaces says "Vital public spaces have four key qualities: 'They are accessible; people are engaged in activities there; the space is comfortable and has a good image; and finally, it is a sociable place: one where people meet each other and take people when they come to visit."

North Mesa park is very accessible (there's a bus stop right there and is close to many houses), but it unfortunately doesn't meet the other three requirements of an effective public space.


So Much Potential

Look at how much wasted land this "park" represents! Every one of us in this room live on North Mesa. You can see where we live marked by the stars on the map. We would love to have a functional, beautiful park with green space and an exciting playground that we could walk or ride our bikes to.


Given that there are already baseball fields, a soccer field, the BMX track and rodeo facility nearby, we believe this could be a center of recreation for the whole town!



But we're not just here to complain. We have come with a solution!

We recommend developing North Mesa Park into a park that will meet all the elements of an effective public space and that is designed to meet the needs of people of all ages in our community.

Let's take a closer look at some of the elements of our proposed park design.



We need an exciting and innovative playground structure! Some key elements that we think are essential are:

- It has to be tall! At least three stories high.
- We want some really big slides that go super fast.
- We really want a zipline or gravity rail. Something that makes you feel like you're flying and is unique.
- We want some big climbing elements like a spider net that's really tall or a bouldering rock wall or something that provides a chance to work our muscles and challenge our minds.
- We want some fun balance elements (like a wobbly balance beam).
- We love gravity swings as well. The kind that multiple kids can sit on, and you can push it really high.
- You can see based on the pictures on the screen that there are some really exciting play structures out there. We really need something like this in our town.



Kids aren't the only ones who are too sedentary. Teens and adults could use some fun outdoor play options as well. That's why we recommend that this park should also include a ninja warrior course.

We think that many people in town would enjoy utilizing some sort of challenge course to make their fitness time more enjoyable. With the proximity of this park to the Middle School, we also think that many kids might take advantage of playing after school. It will promote a healthier lifestyle for community members of all ages!


Pickelball In the space that is currently tennis courts, we recommend replacing with pickleball courts. You can fit four pickleball courts in the space that one tennis court takes up. Pickleball is easier to play, which makes it a sport that is fun for all ages and abilities.


The current tennis courts at the park aren't in very good shape. Since they need some up-keep anyway, we highly recommend converting these tennis courts to pickleball courts. We think pickleball is a better use for the space for two reasons: First, pickleball courts are much smaller, so you can fit up to four pickleball courts in the space that one tennis court takes up. Second, pickleball is easier to play. This makes it a much more accessible sport for young kids and older adults than tennis (which requires greater strength and more running). It is a sport that is gaining popularity throughout the country, and we don't want Los Alamos to miss out.

Volleyball courts • Volleyball courts are currently hard to access. • Sand isn't good for really playing

The current volleyball courts aren't really utilized, because they are made out of terrible sand, and they are hard to get to. We recommend moving the volleyball courts over by the new pickleball courts, BMX track and parking lot. This location will make it easier for people to use them. We also recommend bringing in good beach sand so that you can dive and fall without worrying about scraping up your body.



We want to make this park a social gathering place, so we think there should be a picnic pavilion close to the playground. This would be great for birthday parties, church parties, scout parties...any party where adults want to talk and kids want to play!




We also recommend including a basketball court near the playground as well, since so many people love to play basketball.




We recommend leaving the Tot Lot as-is. There's no point in getting rid of it since it's already there.




The dog park needs some upgrades. For example, it needs some trees for shade, more seating, and better grass.




The soccer field can remain as-is, but we'd recommend creating a path from the soccer field to the rest of the park.




The County Council just approved \$100,000.00 to spend to improve the BMX track. It is going to be a really great asset to our town, and we think it would be great to have multiple things in addition to the track to bring people in the community together.




One important aspect of an effective park is that it is beautiful and provides space for people to relax. We think that having an area set away from the more rambunctious elements of the park, like the playground and ninja warrior course, that is beautiful and peaceful would make this park the perfect public space. We recommend planting flowers and bushes that will look beautiful and attract butterflies.




Since many people will want to come to the park, we also think it's important to provide adequate bathroom and drinking fountain facilities as well as trash receptacles. This is a very large park, so we'll need to include bathrooms in several areas.



We also would add two additional parking areas so that each area of the park will be easily accessible, and therefore more likely to be used.



The final feature that we want to highlight is a running trail around the perimeter of the park. It's hard to find places to run in Los Alamos that aren't too hilly. The area of this park is mostly flat, and we think that people will enjoy having a beautiful area to run around. We recommend either paving in asphalt or hard-packed with gravel so that it creates less impact on peoples' joints.



As you can see, our plan would create a park that is easily accessible, provides many diverse activities to engage in, is beautiful, and would be a great place to bring people in town together to enjoy the outdoors. We hope you will consider our recommendations.

Gehl's research underscores the fact that outstanding common spaces spur economic vitality.

"What separates a great city from an O.K. city are great parks and public spaces." PPS says vital public spaces have four key qualities: "They are accessible; people are engaged in activities there; the space is comfortable and has a good image; and finally, it is a sociable place: one where people meet each other and take people when they come to visit."

COMFORT and IMAGE: Whether a space is comfortable and presents itself well, has a good image, is key to its success. Comfort includes perceptions about safety, cleanliness, and the availability of places to sit. The importance of giving people the choice to sit where they want is generally underestimated.

It's also possible to transform mediocre and deficient public commons by smartly addressing their drawbacks—sometimes with even modest outlays of cash. Collectively valuing all public places—and adequately supporting them—is essential to fostering livable and prosperous communities.

Proposed Amendment to Section IV "Services Provided by Los Alamos County", Part I of the "North Mesa Horse Stable Rules and Regulations" dated October 22, 2014:

<u>Current wording in the 2014 Rules and Regulations</u>: "Any request for services must be made by a Licensee. A report of conditions may be made by any person."

LASOA requests the addition of the following qualifiers:

- Parks, Recreation and Open Space Division will consult with the Los Alamos Stable Owners Association concerning projects affecting all lot license fees and/or the yearly budget.
- Licensee(s) requesting projects that affect all lot licensee(s) and/or yearly license fees
 must bring that project proposal to the Los Alamos Stable Owner Association (LASOA)
 for review*. This includes projects perceived to be a safety hazard (non-emergency)
 and/or liability issue. Projects recommended by LASOA will be submitted for review by
 the Equine and Livestock Advisory Subcommittee or the appropriate Parks, Recreation
 and Open Space Subcommittee.
