#### ...Recommended Motion

I move that Council approve Incorporated County of Los Alamos Resolution No. 21-17; a Resolution Removing Uncollectible Environmental Services Accounts Receivable from the Incorporated County of Los Alamos Accounts Receivable List for Fiscal Years 2006 through Fiscal Year 2016.

#### .County Manager's Recommendation

The County Manager recommends that Council approve Resolution No. 21-17.

#### .Body

Pursuant to NMSA 1978, Section 3-37-7, it is requested that the County Council approve the write off and removal of the accounts listed in the Resolution, Exhibit A, which have been deemed uncollectible. These accounts have been uncollectible for four (4) years or more and all avenues for collection by the County have been exhausted.

The New Mexico Attorney General's Opinion 70-88 indicated that writing off such uncollectible accounts has no effect on the County's future right to collection if circumstances change, and if collection is not barred by the applicable statute of limitations.

The amount of write-off for each account was determined from the actual amounts billed.

Environmental Services is in line with Los Alamos County Utilities uncollectible accounts with a ratio of .00518 for FY2014 and a ratio of .00000 for FY2015 for an average of .0025 per accounts receivable revenue dollar. This shows for FY2014 and FY2015 Environmental Services as a utility has a ratio of uncollectible accounts in line with similar programs.

The proposed write-off is approximately 0.25% of the \$8.86M in accounts receivable collected by Environmental Services in fiscal years 2006 - 2016. Environmental Services write-offs for fiscal year 2006 - 2016 consist of 11 accounts totaling \$19,987.39. Please note the balance due listed on Exhibit "A" includes GRT & GGRT in the amounts of \$999.36 for fiscal years 2006 - 2016. Environmental Services made numerous efforts to collect the unsecured receivables and were unsuccessful in collecting payment.

For a normal billing year, in fiscal year 2019, Environmental Services averaged \$42,549.39 in monthly charges, along with \$42,464.30 in monthly payment collections leaving an average net uncollected receivable of \$85.09 per month.

#### .Alternatives

The alternative is to maintain these amounts as receivables, an asset, on the County's books, with an offsetting liability, allowance for uncollectible accounts.

- WHEREAS, collection efforts with respect to the uncollectible accounts have been either unsuccessful and the uncollectible accounts remain on the list of accounts receivable of the Incorporated County of Los Alamos ("County"); and
- **WHEREAS,** County wishes to remove the uncollectible accounts from the list of accounts receivable as authorized by NMSA 1978, Section 3-37-7.

The LGD's information indicates that you are in compliance with this requirement. Therefore, in accordance with Section 6-6-2E NMSA 1978, the LGD certifies your entity's final Fiscal Year 2020-2021 budget.

Please take note that state statute requires all revenue sources be expended only for public purposes, and if applicable, in accordance with the Procurement Code, Chapter 13, Article 1, NMSA 1978. Use of public revenue is governed by Article 9, Section 14 of the Constitution of the State of New Mexico, commonly referred to as the anti-donation clause.

Budgets approved by the LGD are required to be made a part of the minutes of your governing body according to Section 6-6-5 NMSA 1978. In addition, Section 6-6-6 NMSA 1978 provides that the approved budget is binding on local officials and governing authorities; and any official or governing authority approving claims or paying warrants in excess of the approved budget or available funds will be liable for the excess amounts.

Due to estimated expenditures and transfers exceeding estimated revenue, your entity's General Fund cash balance is being depleted. Careful control of expenditures and attention to revenue collection efforts is recommended to avoid further depletion of reserves.

Finally, as required by Section 6-6-2H NMSA 1978, LGD is required to approve all budget increases and transfers between funds not included in the final approved budget via submission on the Local Government Budget Management System (LGBMS).

Appropriately balancing maintenance of existing infrastructure with new investments in county utilities, roads, facilities and amenities, which will help improve environmental stewardship, sustainability, and quality of life, while allowing for sustainable growth.

### 2020 Pavement Condition Survey



The first stage of pavement survey was completed on September 17th with the second and final stage beginning on September 28th. The survey is scheduled for completion before November 2020, with the report finalized in February 2021. The airport runway was included in the scope of the work and will provide important information to have for future aviation grant application consideration.

#### Barranca Mesa 3 Subdivision

Roadway infrastructure improvements include removal and replacement of existing asphalt surface and base material on Camino Encantado. For the side streets (Turquoise, Kachina, Encino, Obsidian, Tecolote, and Escondido), the work includes a recycling method of processing, placing & compacting existing pavement for use as a base with installation of new asphalt surface. Removal and replacement of selected concrete sidewalk, ADA ramps, curb, gutter and driveways is also included.

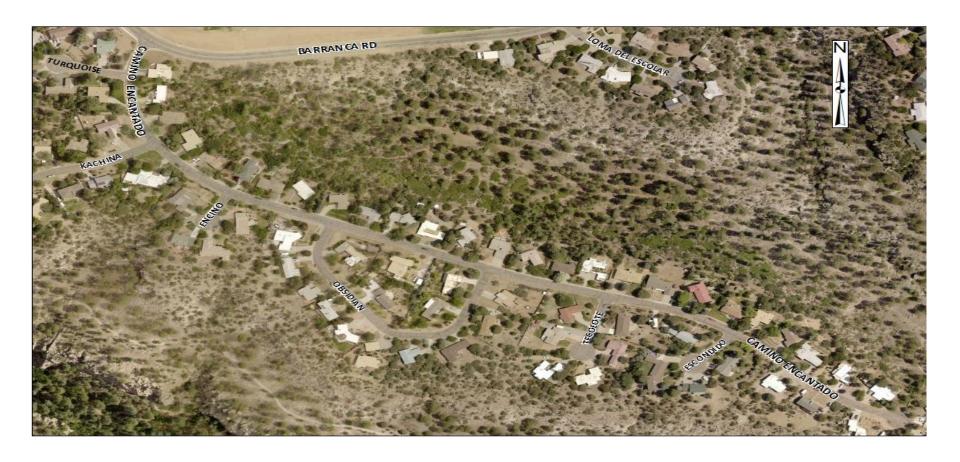

Schedule: Scope of work and cost estimates in progress for in-house design to address reoccurring waterline breaks and deteriorating pavement conditions on 33<sup>rd</sup>/34<sup>th</sup> St. Pavement rehab. is proposed for Arkansas Ave. to address deteriorating pavement conditions and upcoming utility cuts associated with the Arkansas Townhouses.

### **Mirador Residential Subdivision (Tract A-19)**

- Phase I roadway infrastructure is near completion and formal county acceptance of roadway and utility infrastructure for council approval will be forthcoming.
- Staff continues to provide construction inspections and participating in project meetings. Crews continue work on Phases 2 & 3.

### **Mirador Mixed Use Development**

 Engineering staff has reviewed the site plan application and updated traffic impact analysis and provided technical comments regarding traffic mitigation and pedestrian safety measures for consideration at an upcoming Planning & Zoning Commission meeting.

#### **Marriott TownePlace Suites**

- The applicant continues to follow up with comments from IDRC members in preparation for future consideration by the Planning & Zoning Commission.
- Trinity/20th Street Intersection Traffic Signal
  - In accordance with the Project Participation Agreement between the County and the land developer, the County is responsible for the design and installation of a traffic signal at this intersection.
  - Staff is coordinating with our on-call engineering consultant and NMDOT staff to update the traffic study to comply with NMDOT's permitting requirements for the new traffic signal installation.
  - Staff awaits a project timetable from the development team to coordinate the signal design and installation schedule.
  - \$400K for the installation is included in FY21 budget.

### The Hill Apartments (Tracts A-12/13)

- Staff reviewed a summary plat prepared by the development team with recommendations provided for the establishment and vacation of easements.
- Trinity/35th Street Intersection Improvements
  - Design is complete. An Access Permit from Trinity Drive to the site was issued by NMDOT on 5/12/20. The associated road diet configuration for Trinity (NM 502) was approved by County Council on June 9<sup>th</sup> and implemented by NMDOT. Staff is currently working on the transfer of a portion of right of way to NMDOT which was a condition of the permit.
  - The developer is responsible for construction of intersection improvements. Staff awaits a schedule from the developer for the work to begin.

### Canyon Walk Apartments (Tract A-9) - DP Road Phase I

Staff attends weekly construction progress meetings with the development team and reviewing roadway material submittals for compliance with County specifications. Developer's crews have milled the asphalt through the project area in preparation of utility and storm drain infrastructure installation. Trenching for storm drainpipe along western Fire Station boundary to the canyon has begun and will require temporary closure of the Canyon Rim Trail so that crews can install the outfall section of the pipe. Utility trenching is scheduled on the section from Trinity to the Canyon Rim Trail Crossing, with roadway work to follow. Work on the next segment, from the Trail Crossing to end of project near Fire Station 2 will follow.

### Bluffs Senior Housing (Tract A-8-b) - DP Road Phase I

 Staff has reviewed the site plan application and provided technical comments for consideration and was approved by Planning & Zoning Commission at the September 23<sup>rd</sup> meeting.

#### **Ponderosa Estates Phase 3**

 Engineering staff has reviewed the site plan application and updated grading and drainage plan and provided technical comments for consideration at an upcoming Planning & Zoning Commission meeting.

### **Natural Grocers – Trinity Drive/15th Street**

 Trinity Drive utility tie-ins ongoing and scheduled for completion late October.

### **Arkansas Place (former Black Hole site)**

Arkansas Ave. utility work is pending.

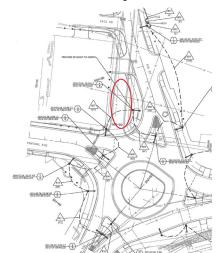
### NM 502 Reconstruction (Roundabout) – Knecht St. to Tewa Loop

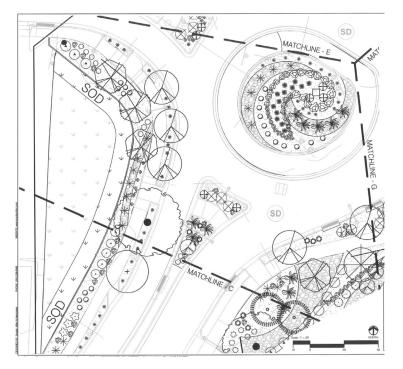
- Repaving from Knecht St. to DP Road complete
