This work included close collaboration with the county recreation division. I was a board member of the Triatomics Multisport club for 2 years.
I helped start the Triatomics Splash N Dash summer series with county's rec dept support and was the main organizer for 2 years. I helped with Los Alamos Triathlon by volunteering
I'm the current secretary of the Southwest Nordic Ski Club and have been on their board for more than 5 years. I coach the youngest kids (ages 2-7) in our club's kids xc ski group.
All these positions are/were volunteer positions.
