4. BUSINESS

A. Briefing to Council by John Bliss, Chair of the Environmental Sustainability Board

Mr. John Bliss, Chair of the Environmental Sustainability Board and Ms. Angelica Gurule, Environmental Services Manager, briefed the Council.

Councilor Izraelevitz, announced that the Council met in closed session earlier and no action was taken.

B. First Amendment to Lease Agreement No. AGR13-3950 with 999, L.L.C. for the Purpose of Acquiring Suitable Office Space for Fire Administration and modifying the term

Councilor Reiss recused himself.

Fire Chief Troy Hughes, presented.

A motion was made by Councilor Chrobocinski, seconded by Councilor Sheehey, to move, pursuant to County Ordinance §31-285 and §10-16-7, NMSA 1978, that Council grant a waiver from the conflict of interest of Councilor Rick Reiss who maintains a substantial interest in the property for which the County seeks to enter into a real estate lease, described herein. As grounds for this motion, Council finds:

- 1. Councilor Reiss' financial interest in the subject property was publicly disclosed prior to solicitation for the subject property;
- Councilor Reiss, by abstaining from any participation in the approval of the proposed amendment to the lease, shall not exercise any apparent bias or favoritism; and
- 3. The approval of the amendment to the lease will be in the best interests of the County.

Further move that Council authorize the County Administrator to execute a first amendment to lease agreement No. AGR13-3950 in substantial conformity to the amended lease attached hereto as Attachment A expanding the space for the Fire Administration staff to 999 Central and replacing the term to one 5-year term with no renewal options.

Councilor Izraelevitz offered a Friendly Amendment to change the term from County Administrator to County Manager. It was accepted.

The motion as amended, passed with the following vote:
