**Description:** The purpose of this budget revision is to modify the Capital Improvements budget for FY2018 to reflect recreation project funding changes approved by Council at the December 5, 2017 County Council meeting. At the December 5, 2017 meeting, Council approved the following CIP project budgets: Splash Pad \$720,000; Golf Course Improvements \$4,524,000; Outdoor Ice Rink Improvements \$1,200,000 with \$15,000 shade study included in that amount. In a separate motion, Council also approved a kiddie pool up to \$6,500,000 but directed that construction on the pool not be contracted until the Los Alamos National Lab contract is awarded. Staff was directed to return to Council with a budget revision for the CIP fund to reflect all modifications to the CIP Budget [see Attachment B]. This budget revision only reflects the net changes to the adopted budget. Council also directed staff to delay the Deacon Street project by one year in the CIP fund so that the Deacon Street project moves out to 2020.

## **Budget Revision 2018-09 Mid-Year Budget Revisions**

**Fiscal Impact:** The net fiscal impact on the CIP Fund is to decrease revenue by \$21,888,507, decrease expenditures by \$1,854,000, increase transfers in by \$152,083, increase transfers out by 90,786 and decrease fund balance by \$19,973,210. The net fiscal impact on the General Fund is an increase in transfers out and a decrease in fund balance of \$152,083. The net impact on the Economic Development Housing Fund is an increase in both transfers in and fund balance of \$90,786.

**Description:** The purpose of this budget revision is to modify the Equipment Replacement (Fleet) Fund budget for FY2018 for two items. The first is an increase to spending authority for an environmental services refuse truck purchased in FY2017 and received in FY2018 which was not included in the FY2017 carryover request and did not qualify as an encumbrance roll forward. The second is to increase spending authority by \$49,000 for an error in the FY2018 Equipment Replacement Schedule. The list of vehicles for the General Fund Divisions includes a Chevrolet Express Van which was appropriately included in the planned vehicle purchase schedule by vehicle, but not properly reflected in the subtotal or adopted budget.

**Fiscal Impact:** The net fiscal impact on the Equipment Replacement Fund is to increase expenditures and decrease fund balance by \$315,294. There is sufficient working capital.

Description: The purpose of this budget revision is to modify FY2018 budgets for grants received by the County.

**Fiscal Impact:** The net fiscal impact on the General Fund is to increase revenues by \$691,649, expenditures by \$516,125 and Fund Balance by \$175,524. The net fiscal impact on the DWI Fund is to increase revenue and expenditures by \$15,000. The net fiscal impact on the Fire Marshal Fund is to decrease revenue by \$31,543, expenditures by \$6,165 and Fund Balance by \$25,378. The net fiscal impact on the Fire E.M.S. Fund is to decrease revenue and expenditures by \$1,131. The net fiscal impact on the CIP Fund is to increase revenue and fund balance by \$90,600. The net fiscal impact on the Environmental Services Fund is to increase revenue and expenditures by \$9,900.
