AMENDMENT NO. 1 INCORPORATED COUNTY OF LOS ALAMOS MEMORANDUM OF AGREEMENT NO. 15-4213

This **AMENDMENT NO. 1** is entered into by and between the **Incorporated County of Los Alamos**, an incorporated county of the State of New Mexico ("County"), and the **Los Alamos Public School Board**, the governing body of a New Mexico local political subdivision ("LAPS"), to be effective for all purposes July 1, 2018.

WHEREAS, County and Contractor entered into a Memorandum of Agreement No. MOA15-4213, dated July 1, 2015 ("Agreement"), for provision of professional services related to substance abuse and suicide prevention, to include school and community based youth prevention and intervention services; and

WHEREAS, both parties wish to renew the Agreement through June 30, 2019, as allowed for under the original term of the Agreement; and

WHEREAS, the Los Alamos County Council approved this Amendment No. 1 at a public meeting held on March 6, 2018.

NOW, THEREFORE, for good and valuable consideration, County and Contractor agree to the following:

1. To amend **Section 3** of the Agreement titled **TERM AND EFFECTIVE DATE**, in its entirety and replace it with the following:

3. TERM AND EFFECTIVE DATE.

The term of this MOA shall commence on July 1, 2015 and shall continue until June 30, 2019 unless earlier terminated as provided herein, but may be then be renewed for up to two (2) additional 1-year periods under the same terms and conditions unless modified by mutual amendment.

2. To amend **Section 4.A** of the Agreement titled **COSTS**, in its entirety and replace it with the following:

4. COSTS.

- A. Funding by County for prevention and intervention services for the life of the Agreement shall not exceed THREE HUNDRED NINETY THOUSAND DOLLARS (\$390,000.00), at SIXTY-FIVE THOUSAND DOLLARS (\$65,000.00) per County fiscal year. Funding shall be paid quarterly on a reimbursable basis upon receipt of an itemized invoice reflecting LAPS' expenses related to the prevention and intervention programs and services.
- 3. Except as expressly modified by this Amendment No. 1, the terms and conditions of the Agreement remain unchanged and in effect.
