Why would you like to serve on this particular Board or Commission?
I care about my community and want to be more involved in local government. I hike, mountain bike, road cycle, cross country ski, downhill ski, and snowboard—the outdoor environment is vitally important to me. Los Alamos is unique from other New Mexico areas, and has special needs to care for it and to promote it to users. I'd like to help our community protect and enjoy the amazing trail systems and community recreation options as part of this board.

What volunteer or professional activities have you participated in that could apply to this appointment?

I've lived in LA for just over three years, and during that time I've helped the local mountain bike group and open space crews with trail maintenance, and I volunteered with a local run and a local mountain bike race. I started a political action group called Voices of Los Alamos in February that holds meetings with about 40-50 members attending monthly, and I help maintain the website with 341 members currently. I was the publicity coordinator for the wildly successful Women's March on Washington - Santa Fe in January, and also for the March for Science - Santa Fe in April. In September, I hosted a fundraiser for a local veteran's therapy program with a documentary about a pro mountain biker's ride along the Ho Chi Minh Trail, raising nearly \$1K. Professionally, I'm a graphic designer, writer, and editor and have written about NM's outdoor environment and various outdoor groups for about eight years.

The time involved may be 10-15 hours per month or more. Are you able to serve the volunteer hours and attend training needed to perform your duties as an appointee?

Yes. I currently work 30 hours/week and can make time for scheduled events as needed. I'm child-free, but have two very needy rescue mutts.

What would you like to accomplish during your tenure on this Board or Commission? (Please identify any special interests you have that led you to become interested in serving on this Board or Commission.)

It breaks my heart that Los Alamos residents don't seem to understand that the County is working for them and cares deeply about this community. I see a lot of people complaining about everything from the Rec Bond to the painted rocks on trails being discouraged, and I'd like to see this community better understand the role of the County, the benefits that our government gives us, and how to have concerns addressed. The public image of the County needs improvement and the people need to understand why taxes help keep your community viable and wonderful. Maybe it's a lofty goal, but I'd like to help bring people together to support the Parks and Rec initiatives and to understand what PR is doing for them.

Have you had any direct or indirect involvement with this Board or Commission or with the County staff supporting this Board or Commission or County Councilors? If so, please explain.

I recently met Stephanie Nakhleh and have asked her a lot of questions, but I've not interacted with the PR Board directly. I am becoming familiar with the County Councilors through Voices of Los Alamos, our political group, as we've asked them to come to meetings and talk, and to meet with a group of us privately to help us understand issues before the Council.

Are there any issue or matters, financial or otherwise, that you are now or might become involved in that may come before the Board or Commission for which you seek appointment?

I'm a member of the Tuff Riders local mountain bike club, and the flow trail is something I've been interested in.
