**A RESOLUTION OF THE COUNCIL OF THE INCORPORATED COUNTY
OF LOS ALAMOS AUTHORIZING APPLICATION FOR FEDERAL TRANSIT ADMINISTRATION
SECTION 5339(c) BUS AND BUS FACILITY COMPETITIVE GRANTS FOR FY2018**

WHEREAS, The U.S. Department of Transportation, Federal Transit Administration (FTA) is authorized pursuant to 49 U.S.C. § 5339 (Section 5339(c)) to assist in funding state and local governing body, on a competitive basis, bus and bus facility capital purchases and projects for Low – No vehicle and facilities; and

WHEREAS, the New Mexico Department of Transportation Transit and Rail Division (NMDOT) is the oversight and planning body for the region for receive Section 5339(c) Discretionary Program 2018 Funding Opportunity monies; and

WHEREAS, eligible New Mexico recipients wishing to receive Section 5339(c) funding must submit an application first to NMDOT for review and inclusion in the Section 5339(c) program listing; and

WHEREAS, the NMDOT is required to prepare a consolidated statewide grant application to FTA toward the capital assistance for the County; and

WHEREAS, the Incorporated County of Los Alamos (“County”) is eligible to submit and receive FTA Section 5339(c) Discretionary Program 2018 funding; and

WHEREAS, County’s Transit Division wishes to submit a grant application to NMDOT for the Section 5339(c) Discretionary Program 2018 Funding Opportunity monies.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE INCORPORATED COUNTY OF LOS ALAMOS, that the County Council, by adopting this Resolution, does hereby authorize County’s Transit Division to submit a Section 5339(c) Discretionary Program 2018 Funding Opportunity grant application for the 2018 Federal Fiscal Year.

BE IT FURTHER RESOLVED, that the County Manager is authorized to execute any necessary documents with NMDOT or FTA, or related agency, for receipt of such funding and is authorized to commit to the required local match for the 2018 Fiscal Year of THREE HUNDRED SEVENTY-ONE THOUSAND EIGHT HUNDRED SEVENTY-FOUR DOLLARS (\$371,874.00): (ONE HUNDRED EIGHTY-FIVE THOUSAND NINE HUNDRED THIRTY-SEVEN DOLLARS (\$185,937.00) for Fiscal Year 2019, and ONE HUNDRED EIGHTY-FIVE THOUSAND NINE HUNDRED THIRTY-SEVEN DOLLARS (\$185,937.00) for Fiscal Year 2020).
