CMO

Tourism Implementation Task Force

The Tourism Implementation Task Force continued to meet and discuss implementation of the Tourism Strategic Plan. Atomic City Transit Manager, Annette Granillo, recently gave a presentation to the Task Force. Her presentation included an overview of the transit system routes, usage and funding. The Task Force will be working with the Transportation Board to determine if there are any possible modifications that can be made to the current system to improve and/or enhance a visitor's ability to get to historic area from White Rock Visitor Center. Also, two field trips were scheduled to the White Rock Visitor Center so that the Task Force could view the operation during Balloon Fiesta. The Task Force will be discussing at future meetings how to enhance the visitor experience at the White Rock Visitor Center and how to better utilize the space available.

DEPARTMENT OF PUBLIC WORKS

Administration Division

Transportation Board

The Transportation Board meets the first Thursday of the month at 5:30 p.m. Meetings are held at 1000 Central Avenue, Room #110.

September 6, 2018 Transportation Board Meeting Highlights:

Dan Erickson, Traffic & Streets Division Manager presented an evaluation of the Golf Course Crossing on Diamond Drive and the available treatments for the area. He will present to the Golf Course Sub-Committee in September and the Parks and Rec Board in October. In November the comments collected by staff will be presented to T-Board for review and consideration of a recommendation.

Airport Division

Perimeter Fence Project:

The airport has secured federal and state funding, the contract has been awarded and the pre-construction meeting has been held. This project will replace the fence along highway 502 and airport road with a black vinyl-coated eight-foot chain-link fence, replaces two powered vehicle gates and three pedestrian gates. Construction is scheduled to begin in October 22nd and be completed by the end of the year.

New Aircraft Hangar Complex Construction Project:



Crews from Facilities and Streets Divisions of Public Works continue to make progress on the new hangar project. Roof sheeting, door rigging, trim, plumbing and electrical remain. Construction is expected to be completed by the end of fall. The completed hangar complex will have three small hangars that will accommodate single-engine aircraft, one large hangar that can accommodate one large aircraft, and two large storage areas. The new hangars will be leased to local aviation-related businesses and private aircraft owners, producing revenue to offset airport operating costs.



"The Secret City Unlocked" Fly-In Los Alamos Tour. Los Alamos hosted 36 participants and 10 aircraft from those attending the Aircraft Owners and Pilots Association Conference in Santa Fe. The guided tour included a visit to the Bradbury Science Museum, the Manhattan Project National Historical Park, Fuller Lodge, and an opportunity to visit downtown shops. There were many citizen volunteers and county staff that made this a huge success – THANK YOU!

















Custodial Division

- The Custodial Division supported 230 events during the month of September.
- Floor work was completed at the Teen Center, Nature Center and the Eco Station this month.
- The food warmer in the Fuller Lodge kitchen was replaced with a commercial grade warmer/proofer.
- Exterior window cleaning will begin this month and conclude in October.

Engineering & Project Management Division

Server Room Cooling Improvements:

This project improves the reliability of the server room cooling. The curtains that separate the hot side and the cold side of the server racks were installed in February. The controls work was completed early April. The engineer analyzed the performance data after the modifications were made to the server room and controls to see if installing the bypass valve in the condensing unit would be warranted. The purpose of the bypass valve is to reduce compressor cycling. The valves were installed on one of the two condenser units. In order to ensure redundancy of the cooling system, some time has been included between each installation to confirm a smooth operation before working on the second cooling system. The installation of the second set of recirculation valves has been delayed due to the need to complete repairs on the Roof Top Unit to ensure reliability before shutting down a unit to work on it. The parts for the repairs are expected early October. The valves will be installed immediately after the repairs are complete.

Municipal Building HVAC:

An evaluation was completed by a 3rd party engineer to establish the cause of the HVAC noise, and they have since recommend solutions. Jaynes and their sub-contractors have agreed to perform the work which entails replacement of ducts throughout the building identified as those causing the noise.

The engineer's analysis report shows restrictions in the supply and return ducts in certain areas are causing high velocity through the ducts, oscillations in the airflow through the supply fans, and oscillations of the sheet metal ducts. These restrictions also caused a higher than necessary fan speed on one roof top unit causing even more vibrations.

Assessment of the noise levels is in progress to determine if the results are acceptable. Some additional sealing of HVAC ducts is planned for the end of September to close-up some noisy air leaks. The engineer is also working on parameters to slow down the fan speeds of the AC units to reduce the vibration and noise. This reduction in fan speed will not reduce the performance of the HVAC as the air temperature will be lowered for cooling or raised for heating and will still have the capacity.

White Rock Senior Meals Center Kitchen Equipment Upgrade:

This project utilizes a grant from the State Aging and Long-Term Services Department to install additional kitchen equipment to improve the in house and delivered meals capacity. The Invitation for Bids was advertised on September 16th and closes on October 4th. Work is expected to be complete by the New Year if the kitchen equipment is available by that timeline.

Fire Station 3:

The project includes reroofing, as well as a new wall system, window replacement and HVAC system modifications to better insulate and control the temperature in the bunkrooms. Bids were received, and awarded to Kha'po construction by Council at the July 10th meeting. The contractor is in the submittal phase and is scheduled to mobilize on site by the end of September. Work is to begin inside one half of the bunkrooms and on the roof over the dining hall and kitchen. Substantial completion is scheduled for January 30, 2018.

Fire Station 6 Restroom Remodels

The restrooms at Fire Station 6 (Airport) will be refurbished as it has been a little over 10 years since they were last re-done and are looking worn. Riskin and Associates, one of the County's on-call architects, completed design. Staff is holding off on advertising the project until Fire Station 3 is underway to see if any additional funding will be needed, or if Fire Station 6 will have enough funding to move forward. This should be decided by February, 2019.

Mesa Library HVAC Improvements

Work is continuing with demolition of various areas in the building to accommodate new ductwork and ceilings; removal of the fan systems; construction of the new intake structure; electric upgrades and new gas lines, which includes a relocation and a new service line; installing new controller valves on the air distribution boxes above ceilings; and other associated work. One of the partial day shutdowns to install a new electric junction box is now complete. A second shutdown will be required to shift to the 480-volt electric system.

The contract has been adjusted to move one milestone date from November 16th to the 28th. This additional time fits within the planned contingency time, thus keeping the original planned library re-opening date on December 4th. However, the filter back vendor is offline because of hurricane Florence and not sure when the plant will be back online.

LAPD Remodel for Sheriff's Office:

A new office space for the County Sheriff's office is being designed inside the Justice Center to allow the public better access. The new entrance will be on the Trinity side of the station. It will consist of an office for the Sheriff and one office space for an Administrative position. Currently, visitors to the Sheriff's office

need to be escorted through the Records area, which is not ideal, either for the visitors or staff. Design will occur in October with construction occurring before the end of the year.

On Call Construction Services:

An RFP is being developed to provide on-call facility work as needed for smaller projects that are small in scale to go out to bid individually or that need to be fast-tracked. Remodels, smaller mechanical, electrical and plumbing jobs would fall into this category, generally less than \$200,000 each, many being \$50,000 or less.

Canyon Rim Trail Phase 3:

The County has been working with the consultant to prepare to obtain easements with the private owners, by first obtaining property appraisals, within the project limits between Knecht Street and the 20th Street Extension. A presentation was made to the membership at the American Legion, one of the properties where an acquisition is needed. We are awaiting a response from them following their September board meeting.

Canyon Rim Trail Underpass:

The project was awarded federal FY2018 funding under the Transportation Alternatives Program (TAP) for project study and design in the amount of \$320,000 and FY2020 TAP funding for project construction in the amount of \$2,020,000 for a total award of \$2,340,000.

A kick-off meeting with Wilson and Company was held on April 26 to begin the design process for this project. Preliminary Alignments have been received by staff. The first public meeting will be held July 26th at the Arts in Public Places Board, followed up by an August 2nd presentation to the Transportation Board and August 9th presentation to Parks & Recreation Board to discuss the scoping report and conceptual design. Minor feedback was obtained and will be considered. The consultant has now submitted the 60% design, and a design review meeting was held with the whole project team on September 18th. Follow up design meetings are anticipated in October for utility coordination and NMDOT maintenance agreements, since this project crosses through NMDOT Right-of-Way.

DP Road and Utility Infrastructure Improvements Project:

The USDOT BUILD (Better Utilizing Investments to Leverage Development) Grant application was submitted on July 19, 2018, for the DP Road and Utility Infrastructure Improvements Project. The request was for \$5 million for new asphalt road surfacing, pavement markings, concrete sidewalks, curb and gutter, ADA curb ramps, drive pads, storm drains, street lighting, and landscaping improvements. One million dollars was also requested for the replacement of the existing utilities (gas, water and electric) that will be impacted by the roadway construction. The grant awards are scheduled to be announced by December 18, 2018.

North Mesa Phase 2 Improvements (Cumbres del Sol Subdivision):

This North Mesa pavement rehabilitation project is located on Camino(s) Manzana/Mora/Cereza. The project entailed a new asphalt roadway, new compacted base, and intermittent concrete sidewalk, drive pads, curb & gutter, ADA curb ramps. The project has reached substantial completion and is fully open to the residents. The Contractor is working on corrective punch list items followed by the completion of the landscaping in disturbed areas. The project was a success as it finished on-time and under budget. Several residents have commented on the finished product and were thankful for the work.





- NM 4/East Jemez Rd. (Truck Route) Intersection: Staff continues to work with DOE, NMDOT Bandelier, and Army Corps of Engineers to program, design and construct intersection upgrades to improve capacity and safety. The USACE has entered into a design contract with Bohannon Huston, a civil design consultant, to study and design the intersection. A follow-up meeting with all stakeholders was conducted September 18th and a final report is anticipated in October. The report will document a preliminary estimate for the preferred alignment. DOE will, at that time, evaluate whether or not the remaining SEP funds available would be sufficient to construct the project. A presentation to the Transportation Board is scheduled for October 4th.
- NM 502 Reconstruction, Knecht St. to Tewa Loop: Staff continues to coordinate with NMDOT on this state lead project. NMDOT bid the project for a fourth time on August 17th and received two bidders. On September 20th the County received word from NMDOT management that the contract was awarded to the low bidder, Star Paving, and a schedule will be forthcoming.

Environmental Services Division

Los Alamos County Landfill Gas (LFG) Update:

This is a summary of results for August 2018 methane monitoring for the Los Alamos County closed landfill.

- 1. The monitoring probes near the boundary of the landfill ranged in methane concentrations from 0.0 (MP-8R, MP-9R, and MP-10R) to 1.5 (MP-11R) percent gas in air.
- 2. The landfill gas extraction wells ranged in methane concentrations from 6.1 (EW-2R) to 57.4 (EW-18) percent gas in air.
- 3. The LFG vents and gas probes previously monitored and tracked during our monthly compliance monitoring at Los Alamos are not part of this month's data. These extraction locations have been recently decommissioned following the site's transition to the permanent GCCS system that started-up on July 12, 2018.

Curbside Yard Trimmings Roll Cart Update:

The yard trimmings roll cart program began on July 9, 2018. Environmental Services staff delivered over 3,200 roll carts with another 300 registered to receive on in the next phase, this is 50% of the residential

customer base. By implementing the yard trimming roll cart, Los Alamos residents have an opportunity to divert 14% of our waste stream from the landfill each year. The diversion efforts have the potential to divert 1,107 tons of yard trimmings annually and will reduce hauling and disposal costs, greenhouse gas emissions, and provide high-quality garden and landscaping materials for residents. During the first three months of collection Environmental Services collected almost 200 tons of yard material.

Recycling Service:

With the change in the recycling schedule over 300 residents requested an upgrade to a larger or additional roll-cart. Environmental Services has filled many of the requests and has received an additional 324 - 96 gallon recycle roll-carts and began to distribute them to the remainder of customers who have requested them.







A 9% Increase in Diversion

Facilities Division

Golf Course Bathroom Odor:

Facilities staff worked over the last weeks to perform tests at the Golf Course in which smoke was forced into the sewer vent to identify the location within the building where the sewer vent was not properly sealed and thereby leaked fumes into the men's restroom in the building. Two tests were performed which clearly identified a defective urinal as the source of the sewer gas intrusion into the building. The faulty urinal is now scheduled for replacement which is expected to fully resolve the issue.

Heater Coil Replaced at the Police Department:

As the seasons turn from summer to fall, heating system concerns have started to appear such as that in the Police Department's Administrative area. Facilities staff have replaced two failed coils that prevented the system from working properly. The system will now be purged and recharged to get things up and running normally again.

Ice Rink Locker Room Heater and Rink Glass:

Another sign of the season is the work being done at the ice rink in preparation for the upcoming season. Along with the typical re-painting and touch-up work that happens annually, this year the heaters in the locker rooms are being replaced to ensure that the occupants enjoy indoor temps before they head out into the winter cold. A broken glass panel is also on the list of items that will be replaced before the facility is in shape for the season to begin.



Fifty-two (52) residential permits were issued in September 2018, with a total valuation of \$531,433.10 compared to forty-eight (48) permits issued in September 2017, with a total valuation of \$1,398,746.61.

Housing and Special Projects Division

Housing Rehabilitation Program (Home Renewal Program):

For the 2017 program, work has been completed on five homes, and work on three more homes is expected to finish before the end of October. For the 2018 program, six applications including scope of work and cost estimates were recommended for approval by the Loan Review Committee. These six recommended projects will be forwarded to the County Manager for approval of the loan amount. Work will include energy efficient windows, doors and furnace installation; repairs to roofs, decks and porches; and accessibility improvements so residents can stay in their homes longer.

Homebuyer Assistance Program:

A total of ten home purchases have been completed since the first purchase in the program in February 2018. An additional homebuyer down payment loan was approved by the County Manager in early October. Public interest in the program has remained strong and the application period will remain open as long as funds are available.

Affordable Housing Multi-Family Development:

Transfer of the County owned 4.25 acre site being Tract A-9 at 120 DP Road for the planned project for 70 affordable rental units is anticipated to take place by November 9th, 2018. The project, "Canyon Walk Apartments" has been awarded low income housing tax credits by the State to be used to acquire private financing for the project. It is expected that in the first quarter of 2019 the developer Bethel Development Inc. will submit a building permit application for the project and by summer of 2019 construction could start. The Canyon Rim Trail crosses the property and residents will have easy access to the trail.

Planning Division

Planning and Zoning Commission:

The Planning and Zoning Commission (P&Z) met twice in September. At the first meeting on September 12th they considered a Lot Split application, which is normally an administrative matter, but that was referred to the Commission due to a written protest by an adjacent property owner. The application was approved. After the hearing, Dan Pava, Project Manager for the Land Conveyance and Transfer project gave a presentation to the Commission on the history, processes and status of land transfers and conveyances.

On September 26th the Commission held a public hearing regarding the proposed "Addressing and Road Naming" ordinance, an amendment to the Los Alamos County Code of Ordinances, Chapter 34 – Streets, Sidewalks, and other Public Places. The Commission unanimously recommended that Council approve the ordinance.

Following the public hearing, the Dan Erickson spoke to the Commission about the Public Works and Transportation Board processes for Traffic Calming that the County has implemented.

Building Permit and Business License Review:

During the month of September Planning Division staff reviewed and acted on 34 Building Permits and seven Business License applications.

Planners also processed two Administrative Deviations. (Administrative Deviations allow applicants to exceed code standards by 12 inches or less and are approved administratively.) Both of the Administrative Deviations were for relief from the twelve foot (12') maximum height requirement for an accessory structure.

IDRC:

The Interdepartmental Review Committee (IDRC) reviewed three applications related to the Shrine Club property at 1459 Trinity. Due to complexities of the site and the several applications, action on two of the applications was postponed to allow for further communication with the applicant.

COMMMUNICATIONS & PUBLIC RELATIONS DIVISION

In September, the division was kept busy with major publications such as the Season of Arts and Culture for Community Services, a wide variety of proclamations, advertising, marketing, flyers and brochure updates for HR, Community Services, Economic Development and Community Development. The VIS completed work orders for marketing/promotional items and specialty items such as a bus wrap for the new electric bus, along with public outreach for events such as Customer Service Week. The PIO and VIS supported the AOPA Secret City Tour on Sept. 14 as well as working at the Santa Fe Regional Fly In (Sept. 14 and 15) where the County featured an exhibit booth with new display and photos showcasing all that Los Alamos has to offer to visitors. The County received many positive comments about the Tour as

well as at the booth, visiting with pilots not only from around the state but those who flew in from Arizona, California, Colorado, Wyoming, Nevada, Texas, Kansas and Missouri. C&PR continues to support branding efforts for community outreach and the PIO participated in the Place Making subgroup for the monthly Discoveries Action Team Meeting (Sept. 20). The PIO presented the Communications/Media Relations module at the Leadership Academy on Sept. 20.

The VIS also attended a two day training program (Sept. 24 and 25) then successfully passed the test to obtain the CMO-policy-required FAA certification to operate the drone for the division. Community Development and IT (GIS) also have completed the certifications for drone flight as stated in the policy and the PIO will update the information posted to the website. The PIO also negotiated to get a much better rate for Open Forum than the list price, and thus it did not expire at the end of September after all. The County was able to use a government contract to procure the service, which is a popular on-line forum and survey tool used by many of the divisions. OpenGov (the name of the hosting company, which purchased Peak Democracy earlier this year) is in the process of making a major upgrade to the product and it should offer some new, engaging and exciting features that will be launching in 2019.

In the month of October, work will get underway on the winter Community Services booklet and early planning/design for the graphic design layout of the year-end annual report. With drone certification accomplished, the VIS plans to capture some of the fall foliage around Los Alamos in early October to use in publications and video updates. The division welcomes back Vint Miller as Visual Information Specialist. His first day was Oct. 8 and he joins VIS Leslie Bucklin in fulfilling work orders for graphic design and photography services. Vint worked for C&PR for over a year before departing to Oklahoma for a short time in order to care for a family member, so we are delighted to have him back in NM and re-employed here in our office. Vint brings a wide range of graphic design skills to the County and was instrumental in designing the popular Trailhead brochures that are available to the community and visitors.

WHITE ROCK SENIOR CENTER HERB GARDEN

Last year, one of the Summit Garden Club meeting programs was presented by the chef for our local senior center. The topic was on herbs. Discussions with Chef Michael after the program revealed that he desperately missed having his own herb garden at the senior center like he had at his last position. Summit GC wanted to help Chef Michael get his herb garden. Los Alamos County was contacted because they own the property the senior center sits on; they were thrilled to support the project. Summit Garden Club has designed the herb garden and Los Alamos County built and installed the raised beds. The plans call for 7 separate raised beds with a total volume of 228 square feet. To date, 4 of the 7 beds have been installed (see pictures)

The White Rock Senior Center serves the entire population (20,000) of Los Alamos County, but mainly provides meals for the senior community of White Rock. Chef Michael estimates he prepares 45 meals a day and around 1,000 meals per month for our seniors. This garden will provide Chef Michael fresh herbs with which to enhance the flavor and healthfulness of the meals he provides. The garden is located at the north side of the main building of the White Rock Senior Center.





Ashley Pond Concert Sound System Pad – 20% complete:

We are constructing a 12' x 12' concrete pad with railings. It will have a permanent audio cable connected to the stage for the sound system for events at the stage. When not in use for the concerts, the pad will double for handicap seating for events. We will also place a picnic table for the public to enjoy daily.



37th Street Playground Improvements – 25% complete:

We have started working on improvements at the 37th street playground to replace outdated play equipment and improve the borders, drainage, and fall zones.

After 26 years with Los Alamos County, Randy celebrated his last day on Friday, October 5th. He will be missed!






Open Space


