## IV. Updates and Possible Action on Current Projects

- a. Donation offer of "Sunflower" created by Ed Grothus The sculpture was assessed by a welding company and they declined to work on it citing concerns with the structural integrity of the original work. Steve Heubner is contacting other companies. Village Arts would like it to be removed from their property by the end of May. Alternate storage locations will be explored.

- c. Update on Glass Kites for WRBL
  The dedication will be held on Sunday, April 28 at 2:00 p.m. Anthony Strain is working on lighting. Media will be notified when the art is being installed.
- d. Art for White Rock Senior Center

#### Motion:

Vice Chair Ozment moved to recommend to Council the relocation of "Apache Harvest" from Ashley Pond to the White Rock Senior Center. The total budget for the project is not to exceed \$3000.00 including transportation, construction of a new concrete base, lighting and contingency. Board Member Mackey seconded. All voted in favor. g. Jeff Segler painting proposal

Mark Rayburn, a former member of the Historic Preservation Advisory Board introduced Jeff Segler. He is the national artist for the Boy Scouts of America. He presented his extensively researched concept drawing of a proposed painting suggested to be placed in Fuller Lodge. The painting would commemorate the original Scout Troop at the Los Alamos Ranch School and the vibrant lifestyle and activities of the students there between 1917 and 1943. The Board was generally receptive to the proposal. Board members Carson and Mackey will champion the project. The next step will be to gather public opinion on the proposal.

Art Inventory/Maintenance Issues – Recommendations Inspections of outdoor artwork were completed: "Nexus" at the Golf Course has areas around the base of the sculpture where the coating is coming off. Joe Lindsey of Sculpture Smart will be consulted. The clown mural in front of Mesa Public Library has cracks in the stucco frame. The water fountain there is missing some large rocks from the grate at the base. The crane at the White Rock Branch Library needs more rock around the base to combat erosion. There is concern that the textile hanging in the Justice Center may be fading from the sun and UV could weaken the fibers.
