County Manager's Monthly Update

LOS ALAMOS COUNTY MAY - 2019

CMO

The official ribbon cutting for the Los Alamos Visitor Center was held April 17, 2019. The space had previously held the NMSU Cooperative Extension office but renovations were undertaken by Facilities staff. All are encouraged to stop by and check out the new space at 475 20th Street that will welcome our visitors and provide information about attractions throughout the County.



PUBLIC WORKS DEPARTMENT

Administration Division

Transportation Board Recruiting New Members:

The Transportation Board meets the first Thursday of the month at 5:30pm. Meetings are held at 1000 Central Avenue, Room 110.

Airport Division

Fence Project Nearing Completion:









Crews are nearing completion of the fence project: pavement work under one of the vehicle gates, integration with the county's access control system, and installation of new obstruction lights are the only major items remaining. We expect the project to be complete by the end of May. This project replaces the fence along Highway 502 and airport road with vinyl-coated eight-foot chain-link fence, replaces two powered vehicle gates and three pedestrian gates. An FAA Airport Improvement Grant and an NMDOT Aviation Grant are covering 95% of the project costs.

Drone-Assisted Inspections:







The NMDOT Aviation Division is using Los Alamos Airport to test the ability, fidelity and costs of conducting pavement condition inspections, as required by the FAA, using drones. This inspection is typically conducted by individuals walking and evaluating the entirety of the pavements, resulting in high costs and extended runway and taxiway closures. To reduce costs and operational impacts, the NMDOT is testing the concept of using drones to collect video that can be electronically stitched together into a single high-resolution image of the pavement surfaces and used by engineering staff to evaluate pavement condition. If the concept proves successful, it could reduce state-wide airport pavement inspection costs by \$250,000 per year.

Pavement Maintenance:

Airport pavement condition inspections serve as the foundation of a comprehensive pavement maintenance program, as required by the FAA, to preserve and extend the life of all the runway, taxiway and ramp pavements, and ensure the safety of the traveling public. To that end, NMDOT provided Los Alamos Airport with a \$50,000 grant to crack seal and patch repair over 200,000 square feet of taxiway and ramp pavement surfaces at Los Alamos Airport with minimal operational impact.



Economic Opportunity Flies into Los Alamos:

There is a common refrain amongst economists: opportunities fly into communities. The point is clear – businesses rely on air travel to expand and communities with airports are the benefactors. Alltech, an international biotech company with operations in animal feed, meat, brewing, and distilling, flew their CEO into Los Alamos to meet with senior executives from Pebble Labs, a local biotech company that is, according to their website, "developing rationally-designed disruptive technologies to address the greatest agricultural, health and environmental challenges facing the globe." While many may associate business travel with scheduled airline service, the Bureau of Labor Statics show business travelers only accounted for only approximately 25% of all commercial air passengers in 2017 – and the number has been declining for decades. An often overlooked yet vitally important (and growing) component of air travel is business-owned aircraft. FAA statistics show business-owned aircraft account 34% of the 166,167 total privately-owned aircraft registered in the US and 68% of 20,101.94.



Custodial Division

- ♣ The Custodial Division supported 191 events during the month of April.
- ♣ The Division filled 1 vacant custodial position in April along with the lead custodian position.
- ♣ The Division continued its training program (Buckeye Honors) with additional classes this month.

Engineering & Project Management Division

White Rock Senior Meals Center Kitchen Equipment Upgrade:

Work was completed, and the kitchen reopened on schedule April 1st. There are remaining funds in the grant so the County is working on purchasing a serving steam table to add to the kitchen.

Mesa Library HVAC Improvements:

The project is substantially complete as of February 20th and final completion is pending minor work. The contractor is working on punch list items and making adjustments to the HVAC system as needed. Activation and testing of the chillers has begun and will not impact the occupancy of the building. Additional minor work on the elevator is pending to complete the elevator upgrades. All items requested by the Fire Marshal have been installed.

Fire Station 2 Training Tower Work:

A consultant has been hired to verify the tie-offs and lowering structures on the tower meet OSHA safety requirements. If they are found not to meet, new installation will be completed before the July Fire Academy. County facilities crews will perform work to correct some door and wall panel issues and a proposal for an on-call concrete contractor is pending to repair some minor concrete damages on the stairs.

Airport Re-roof:

An on-call architect has been secured for design services for the re-roofing of the Airport due to damage in January. The design is anticipated to be completed by late May and work would begin in July.

Aquatic Re-roof and Structural Repairs:

Staff has secured an architect for design services to re-roof the flat roof portion of the center's roof as well as correct some structural issues with a portion of the roof structure away from public areas which have been damaged by excessive humidity. An exhaust fan is anticipated to be installed in the electrical room to exhaust future humidity build-ups and create some air flow. This project is also considering a slanted roof to keep snow from sliding onto the adjacent flat roof and down spouts to deter icing damage on the canyon side of the building.

Canyon Rim Trail Underpass:

The project was awarded federal FY2018 funding under the Transportation Alternatives Program (TAP) for project study and design in the amount of \$320,000 and FY2020 TAP funding for project construction in the amount of \$2,020,000 for a total award of \$2,340,000.

A 90% plan submittal was submitted on February 1st and a plan review was held on March 8th. A cooperative Maintenance agreement between NMDOT and the County was approved by Council on April 2nd and sent to NMDOT for final execution. A trail plat of easement was sent to NMDOT in March. Final plans are anticipated in June 2019.

Tsikumu Village:





The scope of work is pavement preservation (mill and overlay of asphalt) and intermittent concrete repair. Project bids were received on March 5th and Albuquerque Asphalt was the low bidder. The contract was awarded by Council on March 19th. A pre-construction meeting was held on March 26th and the construction is scheduled to begin on April 1st with completion anticipated by mid-June 2019.

Tracts A-13/A-12 LASO Offsite Improvements Project:

Santa Fe Engineering, the County's design consultant, presented the design alternatives to the Transportation Board on January 3rd. The board requested a road diet be considered on Trinity Drive between Oppenheimer and Diamond Drive. The road diet scope was added and is currently being analyzed by SFE. The findings and a preferred alignment, based on the model's analysis, will be presented and a recommendation will be requested at the May 2019 Transportation Board meeting.

SR4 and Truck Route:

NM 4/East Jemez Rd. (Truck Route) Intersection: Staff continues to work with DOE, NMDOT Bandelier, and Army Corps of Engineers to program, design and construct intersection upgrades to improve capacity and safety. Bohannon Huston completed a traffic study documenting a preliminary estimate for the preferred alignment of \$3.6Million including NMGRT. DOE will evaluate whether or not the remaining SEP funds available would be sufficient to construct the project and if not would begin to explore other funding options. USACE and DOE have begun the design portion of the project with Bohannon Huston and final designs are anticipated late August of 2019. Bi-weekly project team meetings are being held with all stakeholders to keep this project on schedule.

NM 502 Reconstruction, Knecht St. to Tewa Loop:

Staff continues to coordinate with NMDOT on this state lead project. The contractor, Star Paving, began work on March 18, 2019. Agency coordination is ongoing for projects occurring on or near DP Road for public outreach. A public meeting was held by the NMDOT Project team on March 20th at Fuller Lodge to discuss construction operations with the public.

Environmental Services Division


Curbside Yard Trimmings Roll Cart Update:

The yard trimmings roll cart program began on July 9, 2018. Environmental Services staff delivered over 3,800 roll carts, this is over 54% of the residential customer base. By implementing the yard trimming roll cart, Los Alamos residents have an opportunity to divert 14% of our waste stream from the landfill each year. The diversion efforts have the potential to divert 1,107 tons of yard trimmings annually and will reduce

hauling and disposal costs, greenhouse gas emissions, and provide high-quality garden and landscaping materials. The program started back up on March 18, 2019 and has already collected over 100 tons of yard debris, and more residents are registering for the program every day.

Los Alamos County Landfill Gas (LFG) Update:

With the installation of the Landfill Gas Control and Collection system, the methane concentrations have decreased and are in compliance with NMED Solid Waste Rules. Environmental Services has received approval from New Mexico Environment Department (NMED) to reduce monitoring from weekly to quarterly as prescribed by NMAC Solid Waste Rules.



Complimentary Brush Pick Up:

Environmental Services provided a Complimentary Brush Collection for residents that had broken tree branches from the wind storm. This service was provided from March 27th to April 10th. In that time frame there was 20.25 tons of wind storm brush from the 52 residents that registered for the complimentary service.



Eco Station Beautification:



Environmental Services staff working hard to turn the muddy median at the Eco Station into a beautiful rock garden. The garden is not only for looks but also helps with slowing the water runoff for this area.

Training:

Environmental Services Senior Office Specialist Joshua Levings and Equipment Operator Timothy Vigil completed training from the New Mexico Environment Depart and New Mexico Recycling Coalition to be certified compost facility operators.

Green Team Earth Day at Muni Building:



The Los Alamos County Green Team celebrated Earth Day by recruiting county employees to join the green team and having others sign a zero-waste pledge. Zero waste means that you will send no waste to the landfill and use reusable products as much as possible. Over 30 county employees pledged to be zero waste. The zero-waste team also recruited four new members and there is still space for more. 


March Diversion Rate: 24%




The diversion rate is the percent of recyclable and compostable material diverted from the landfill.

Facilities Division


Fire Extinguishers – Countywide Replacement Program:



During the FY2020 Budget approval process, the Facilities Division included a project in the "budget options" section that would replace nearly all the fire extinguishers located throughout the County with a new model suggested for consideration by the Fire Marshal's office.

Council approved \$70K to purchase the new fire extinguisher technology that has a 12-year life and can be checked/maintained annually by internal staff (rather than an external contractor – at a cost of \$10K/year - as is required for the fire extinguishers currently in service). Training in the use of the new equipment will be provided as the equipment is installed during the upcoming fiscal year.

Contractor's License Renewal:



The Facilities Department maintains a

Contractor's License for the County of Los Alamos that includes crew members with credentials in each of the required trades: structural, mechanical, and electrical. Licensure enables County staff to perform work that requires a building permit and inspections by the Construction Industries Division. Efforts occurred this month to ensure the staff included on the license are current and that the license, and associated bond, will remain valid for the coming year.

Fleet Division

Traffic and Streets crews will be assisting the Nature Center on April 25th by closing off the parking lot for their Earth Day 2019 Festival.

Administration Staff:

Administration staff attended a stakeholders meeting at Northern New Mexico College (NNMC) regarding upcoming Commercial Drivers Licensing (CDL) changes and the potential for NNMC offering CDL Classes. Darby Martinez spearheaded this project and has been working with NNMC President Rick Bailey to determine what will be required to offer these classes. The Federal Transportation Department and The State of New Mexico Motor Vehicle Department-CDL Division are planning on making changes to the way citizens obtain a CDL learners permit starting in February 2020. Presently citizens wishing to obtain CDL licensure can walk into a MVD office and take the written test and obtain a learners permit. This may change in February 2020. If the changes are made, citizens will have to take classes at an approved facility and obtain a certificate to take to the MVD office to take the written test to obtain the learners permit. Rick Bailey is working with his staff to try and have classes up and running at NNMC by the Fall 2019 Semester. They are hoping to offer classes for the written exam, classes to train for the driven portion of the exam and contract out with other entities to perform the actual driving test. Should these changes become effective in February 2020, government entities like Los Alamos County and LANL will have to submit course information indicating what will be taught in each required class to the State of New Mexico MVD office for approval so they can continue training new hires. NNMC hopes to work with all government and private agencies to offer these classes and training.

Transit Division

The Transit Division performed shuttle service for Leadership Los Alamos on Friday April 12, 2019. Approximately 27 passengers were transported from White Rock Visitor Center to Bandelier and returned later in the day.

New Mexico Transit Association held their annual Transit ROAD-EO and Conference on Saturday March 31, 2019 through Tuesday April 2, 2019. Transit Operators from around our state come together to show off their driving skills in a course designed to maneuver 40' transit buses. Atomic City Transit supported five Operators for the driving competition. Thank you to our operators – Julie AlderseBaes, Justin Chavez, Ramon Trujillo, Laura Dison, and Lloyd Ami. Atomic City Transit did very well in the competition, bringing home first and second place winners in the large bus competition.



Building Safety Division

Six (6) commercial permits were issued in April 2019, with a total valuation of \$66,386.00 compared to eight (8) permits issued in April 2018, with a total valuation of \$525,775.00.

Housing and Special Projects Division

Housing Rehabilitation Program (Home Renewal Program):

For the 2017 program, work has been completed on five homes and is expected to finish on three more homes this spring. Of the five approved projects for the 2018 program, work is scheduled to begin this spring. The work will be for repairs and improvements for energy efficiency, accessibility and general repair.

Homebuyer Assistance Program:

From now until June 2019 three home closings are anticipated. Starting July 1st, if additional funding is available, more income eligible households will be encouraged to apply.

Affordable Housing Multi-Family Development:

Two affordable rental housing projects are planned to be financed with State low-income housing tax credits and built on DP Road by Bethel Developments. For the first project, "Canyon Walk Apartments" on Tract A-9, 120 DP Road, building permit submittal is anticipated in June with construction start in August 2019. Canyon Walk will be for 70 units focused on workforce housing. For the second project, "The Bluffs" at Tract A-8-b 135 DP Road, in mid-June the State will announce whether the project received a tax credit financing award. The Bluffs' plan is for 64 units for age 55 and over. On DP Road, County departments

and other agencies will be overseeing several other construction projects. Community Development staff will be meeting with these entities regularly to ensure proper coordination and minimize disruption to local business owners and customers.

Housing Needs Study:

The County has opened a Request for Proposals (RFP) from April 29th to March 16th for consulting services to conduct a Housing Market Needs Analysis over the summer. The purpose of the study is to provide the County with current information about the housing market and housing needs in order to direct public resources for housing development and meet Council's Strategic Goals for Housing. The Study will identify housing demand and gaps, and housing preferences, types and number of units needed for the different demographic segments of the population.

Planning Division

The Planning and Zoning Commission met April 10th, 2019. The meeting was for a subdivision approval of one lot into three lots. Included in that day's meeting was Commissioner training provided by the County Attorney's office.

Planning staff received a site plan application for approval for a new Wendy's restaurant, anticipated to be built on the site of the former McDonald's at 1247 Trinity Drive.

Staff received an application from developers of "The Hill" - 150 \pm new market rate apartments to be built on the former LASO site, east of the Medical Center on Trinity. They expect to be ready for P&Z for their first meeting in June.



ED Marketing

Public Involvement Process for Economic Vitality Strategic Plan 2019:



The **Economic Vitality Strategic Plan 2019 (EVSP)** will be presented to Council for approval at the May 28 County Council meeting. This is an update of the original EVSP approved by Council in 2010. EVAT members conducted an extensive review of the 2010 plan goals and actions to determine what had been accomplished, what issues were still relevant, and what new issues, initiatives, County priorities, and projects should be added. Since 2010, Los Alamos County has accepted strategic plans for wayfinding, branding and tourism, as well as a Comprehensive Plan. These concurrent strategic plans that impact the progress and implementation of this EVSP19 have been noted to ensure their future coordination. In February and March, the draft EVSP19 was issued to the public for input via a survey on Open Forum and at a Public Open House. The EVSP19 update provides the basis for aligning actions, services and projects to further Council's strategic goals.







Tourism • On April 28 and 29, staff from CMO and EDD joined representatives from some of Los Alamos' key attractions at the **New Mexico Hospitality Association's 2019 Governor's Conference on Hospitality and Tourism** at the Santa Fe Community and Convention Center.

Informative sessions included a panel discussion regarding opportunities for defining and marketing outdoor adventure meccas. Panelists represented the state's new Office of Outdoor Recreation, Utah's Office of Outdoor Recreation, Routes Bicycle Tours, Farmington's Outdoor Recreation initiative and the Tourism Department's tourism development office. Other tourism development sessions focused on how to tap into the international travel market, how to estimate event attendance and inspiring rural travel

through arts and culture. Marketing sessions offered tips on how to sustain tourism activity through the low season, as well as how to conduct effective e-mail marketing campaigns, and produce great videos. Keynote speakers including media coach Katrina Cravey, executives from Zappos.com and the New Mexico United soccer team and the new Tourism Cabinet Secretary Jen Schroer, provided direction and inspiration to improve our tourism efforts. EDD's Community Intern Collaboration (CIC) intern, Rudy Trujillo attended one of the keynote presentations and a tourism development session. The event concluded with a banquet at which Joanie Griffin, CEO of the County's long-time tourism marketing services contractor Sunny505 (a.k.a., Griffin and Assoc.), was inducted into the New Mexico Tourism's Hall of Fame.

On May 1, the Economic Development Marketing Specialist, a long-serving member of the **New Mexico Tourism Department's North Central Region Tourism Marketing Board**, attended the quarterly meeting of the governor's Tourism Commission, an "All Regions" meeting and a working meeting of the North Central Board members is comprised of tourism managers from Los Alamos, Town of Taos, Taos Ski Valley, City of Santa Fe (TOURISM Santa Fe), the Santa Clara Pueblo and Angel Fire. Those in attendance decided to join forces to market the outdoor recreation offerings of the North Central Region, starting with cross promotion of assets and itineraries between Los Alamos, Taos and Santa Fe. The board is developing a stakeholder list to include all interested tourism and hospitality interests in the region. The board is also revisiting the brand for the North Central region (currently "Georgia O'Keeffe Country"), developing new collateral and collaborating on at least one "fam" tour (media familiarization tour) for the region. The New Mexico Tourism Department also announced that they will be offering a free Google Training session in each region focused on helping businesses increase their SEO (search engine optimization) ranking on the site.

Branding • The *Discoveries Action Team (DAT)* met April 18 at Council Chambers!



The Los Alamos High School JV boy's golf team took to the course with 8 other teams and came out victorious. Good Job Topper JV Golf!




Los Alamos Golf Association tournament season begins - April 12th, 24 participants

Unquarked Moves To Larger Downtown Space

Unquarked, the local bar and lounge in Central Park Square that encourages everyone to "Eat Local, Drink Global" is relocating to Mari Mac Village Shopping Center at 813 Central Ave.

Prashant Jain, owner of Unquarked's parent company, Sirphey, spoke about the reasons for the move and his plans for the new location during an interview Wednesday with the Los Alamos

Sirphey took over operations at Unquarked in October of 2017 with the goal of turning it into Los Alamos's premier event location, as well as a place where locals could unwind, he said. But with that change came growing pains.

"We quickly found that the space was a bit too tight for us. It's not rare for On Tap lectures, Trivia Tuesdays, and dance nights to fill every seat in the house and then some," Jain said. "And so began the plan for expansion. Several local possibilities were explored in the process of finding the perfect fit before the company ultimately settled on the former Blue Window Bistro space."

He that the space is perfect for his needs and he signed the lease April 22.

"It provides us and our customers with 50 percent more square footage, a full kitchen, multiple bathrooms, and plenty of parking just off the main street," Jain said.

With the new location will come a brand new, globally inspired menu and a full-service coffee operation through an exclusive partnership with Santa Fe's Iconik Coffee Roasters. They are a direct trade coffee roaster that goes to various countries to develop partnerships with the growers.

"They are an environmentally sustainable company, which resonates with Unquarked's philosophy," Jain said.

Unquarked also will be doubling its brews on tap to 16 and expanding its wine selections as well as 40 loose leaf teas by the pot and Boba Tea, a milk tea with tapioca pearls, which basically makes Unquarked a Tea House, he said.

Jain said fans of Sirphey need not fear – the restaurant's daily changing offerings may still be added to bar tabs for on-demand delivery.

"We really want Unquarked to be a place where all members of the community feel welcome to wander in, day or night, for a coffee, quick bite, place to work, place to unwind, or a night out with friends," Sirphey's Communication Director Cortni Nucklos said. "And we're taking a number of steps to make that possible."

Free Wi-Fi will be available to all, wireless charging stations will be on hand, and plans for a music stage are in the works.

"But mostly, we're excited for the opportunity to bring more special events to Los Alamos County," Nucklos said. "Tap takeovers from local breweries, special Pixar and Harry Potter trivia nights, the return of the Hot Texas Swing band, and more will be taking place at Unquarked, over the summer."

Jain explained that the Mari Mac Village Shopping Center has been an epicenter of vacant spaces in downtown Los Alamos, over the past few years, and Unquarked is excited by the prospect of creating some change in the downtown landscape.

And in that endeavor, he said they have been greatly assisted by commercial broker Jyl DeHaven, building manager Steve Waller and the County.

"The business development and building safety divisions have been incredibly helpful," he said. "Leasing a long-vacant space in a corporate dark site is a very tricky process, and the County was there to help – answering our most random of questions and providing insight at every step. They're a tremendous aid to small businesses in the community."

But the Unquarked team does find the move slightly bittersweet, Jain said.

"Our neighbors at Central Park Square are lovely. We'll miss seeing the ladies of Allure, Marguerite and MJ at Rose Chocolatier, everyone who works with projectY, and the parade of puppies from Cyndi's Downtown Dogs events. And we'll miss the friendly waves from Caesar, Martin, Leo, Bernadette, Phillip, and Terry as they work in and around CPS," he said.

Unquarked closed its operation at 145 Central Park Square Monday after Trivia Night.

The new location in Mari Mac Village will have a two-tiered opening: Tier one is projected to open within a month and includes food and dancing; and Tier two will happen once the liquor license is obtained.

"I am really excited about the location and the ability to welcome more people to the space and personally I am also excited about creating unique flavors in the commercial kitchen," Jain said.
