INCORPORATED COUNTY OF LOS ALAMOS ORDINANCE NO. 696

## AN ORDINANCE PROVIDING FOR THE TRANSFER OF APPROXIMATELY 87,976 SQUARE FEET, OR 2.02 ACRES $\pm$, OF LAND OWNED BY THE INCORPORATED COUNTY OF LOS ALAMOS TO THE BOARD OF EDUCATION OF THE LOS ALAMOS PUBLIC SCHOOLS

WHEREAS, the Incorporated County of Los Alamos ("County") has agreed to convey approximately 87,976 square feet of County land, the description of which is attached hereto as Exhibit "A", to the Board of Education of the Los Alamos Public Schools ("Schools"); and

WHEREAS, County and Schools mutually agree that the land transfer is in the best interest of both parties; and

WHEREAS, the transfer shall be subject to the execution and performance by the parties, or their designated and authorized representatives, of all documents, including quitclaim deeds, free and clear of any encumbrances, and the filing thereof with any and all proper authorities or entities.

## BE IT ORDAINED BY THE GOVERNING BODY OF THE INCORPORATED COUNTY OF LOS ALAMOS:

Section 1. Pursuant to Section 14-31 of the Code of Ordinances of the Incorporated County of Los Alamos, a total of approximately 87,976 square feet of County-owned land, the description of which is attached hereto as Exhibit " $A$ ", shall be conveyed by quitclaim deed to the Schools.

Section 2. County Staff is hereby directed to prepare all documents necessary to effect the conveyance, and the Council Chair is hereby authorized to execute all documents necessary to effect the conveyance on behalf of County.

Section 3. This Ordinance shall be effective thirty (30) days after publication of notice of its adoption. Publication shall be made by general summary.
