Regarding: Letter of Interest for Complete Count Committee

This letter is respectfully submitted to Los Alamos County to express interest in having a representative from the Los Alamos Community Foundation (LACF) serve on the Complete Count Committee for Los Alamos County. If it is permissible, LACF proposes that our "seat" on the committee would be shared by the foundation's executive director Rachel Kizielewicz and board member Jenny McCumber.

The Los Alamos Community Foundation is a member of New Mexico Counts 2020, which is an outreach campaign supported by a collaborative of funders across the state to help ensure that all New Mexicans are counted in the 2020 Census, especially in the most hard-to-count and reach communities. The committee is comprised of the New Mexico Census Funder Collaborative, The New Mexico Civic Engagement Table, and a Tribal Coalition.

New Mexico Counts 2020 has accomplished the following towards their objective of having a fair and accurate count of all New Mexicans in the upcoming census:

- In partnership with the UNM State Demographer, leveraged \$363,500 for the Local Update of Census Address (LUCA) that added over 100,000 addresses missing from the U.S. Census Bureau's files. This represents a 6666% return in federal assistance on the investment in the LUCA program.
- Raised over \$735,000 for NM Counts 2020 and now actively engaged in a public education campaign and in releasing thousands of dollars in grant support to nonprofit and Tribal partners.
- Signed a letter calling for the withdrawal of a citizenship question on the 2020 census form.
- Leveraging trusted voices who can motivate every New Mexican to respond to the census.

- Working with the New Mexico Civic Engagement Table to support a statewide Complete Count Committee Advocacy Coalition and promoting optimal federal and state census outreach funding.

A representative from the Los Alamos Community Foundation (Rachel Kizielewicz) participates in quarterly meetings of the New Mexico Counts 2020 group. It would be a natural role for LACF to serve as a liaison between the work of the statewide NM Counts 2020 group and the CCC of Los Alamos County.

LACF would be honored to have a seat on the Complete Count Committee of Los Alamos County.

I am submitting this letter of interest for membership on the Complete Count Committee for Los Alamos County. I am currently the Director of Student Affairs at The University of New Mexico - Los Alamos and have served in student success roles for over 19 years.


Serving on this committee is of special interest to me as I understand the complexities of enumerating college-aged students. College-aged students often have temporary living situations and multiple addresses. They may be homeless or have other attributes that can be classified as vulnerable which can result in them being undercounted. I would like to contribute to the conversation and provide education to students about how easy it is to be counted, about how responses on the census are confidential, and about the personal and community-based benefits of being counted.

I know that achieving an accurate count impacts the distribution of funding for healthcare, housing, highways, schools, libraries, and other services. Federal student financial aid allocations to each state are affected by census numbers and this directly impacts current and future students at UNM-Los Alamos. Additionally, fair political representation for the state is at stake. I was recently viewing data on the economic impact of a census undercount and it was estimated that just a 1% undercount could result in a ten-year revenue loss of over 600 million dollars to New Mexico. These are all issues that should be of interest to college-aged students as they are preparing to enter careers and engage on these matters.

I am participating with Complete Count Committee that has been created at UNM-Albuquerque and, even though their process has just started, it has been energizing to talk about the dynamic programming that the Committee has planned.
