Dear County Manager Burgess,

My name is Kristina Ortez, and I am seeking the appointment for State Senate District 6, held by Senator Carlos Cisneros. Senator Cisneros' legacy is long and significant; he did so much to improve the lives of northern New Mexicans through his deep knowledge of state financial issues, investments in acequias and our water future, and his commitment to helping families across the state.

I know that no one can replace the esteemed Senator Cisneros, but I would be honored to take up the mantle of leadership in northern New Mexico.

I moved to Taos nearly 10 years ago, drawn by the land, water and light that has sustained this community for millenia. I am raising my two children here in Taos, and send them to a local school. I am also a proud Lobo—I received my Masters in Public Administration at the University of New Mexico—and I have served as the Executive Director of the Taos Land Trust for five years. This community supports and sustains me and my family; I am rooted here, and I feel a deep passion to serve Northern New Mexico.

I am not a career politician, though I have always worked in service to my community. That is how I was raised, and I have gone on to have a career in leadership within the nonprofit sector, focusing primarily on resolving land and water issues in communities.

As an advocate, I have worked with elected leaders to draft legislation and have advocated for public lands and clean water at the state and national levels. As the Executive Director for the Taos Land Trust, I develop operational budgets for my organization and set our strategic direction based on significant community input, including participation in the Taos County Community Conservation Plan and the Enchanted Circle Trails Plan. I focus on developing and furthering partnerships, such as the Rio Fernando de Taos Revitalization Collaborative, to achieve positive change for our community. And, as a mother, I understand the importance of investing in our children's educational future, health and safety.

In recent weeks, after being asked if I would consider candidacy for this seat, I have talked with my daughters, family members, friends, and colleagues. My community has helped me understand that my kind of leadership, with a focus on deep collaboration, partnership, and community input, is uniquely suited for leadership within the State Legislature.

In the last six weeks I have met with several Los Alamos Councilors and concerned residents of the county to better understand the priorities and community needs. I have learned that Los Alamos works very hard to ensure that the county offers extraordinary educational and job opportunities for those in the county and in the region as a whole. I pledge to work with the county to ensure that Los Alamos continue to provide this, while we work together to improve equitable educational access, good jobs that pay a living wage, and improved and expanded housing opportunities in the entire region.

I am proud to be a Democrat. My priorities for the district include:

- **Education:** Fully funding high-quality early childhood education and increased equity in funding K-12, higher education, and adult education
- **Jobs**: Economic development rooted in northern New Mexico's strengths, including the restoration and recreation economies
- **Tribal Sovereignty**: Respect for tribal sovereignty that is put into action daily, particularly in funding decisions by the State
- **Women's Health**: Expansion of women's access to the full spectrum of reproductive healthcare
- **Environment**: Strong protections for our air, land, and water, investment in our acequias and food sovereignty, and a renewed focus on clean energy
- Common-sense Gun Safety measures: Measures that will save lives and build safer communities that are data driven and supported by an overwhelming majority of voters, including gun owners

I will work with each of the counties that make up Senate District 6 and promise to address the needs and concerns of the Los Alamos County Council and its constituents. I will work with the legislators from each of the counties in the district to ensure that our communities' voices are heard and represented. I am grateful for the service that you and the Los Alamos County Councilors provide to your community.
