2. APPROVAL OF AGENDA

Agenda was approved as presented.

3. PUBLIC COMMENT

Chair Wheeler opened the floor for public comment for items not included on the agenda. No public comment.

4. APPROVAL OF MINUTES

Neighborhood Traffic Management Discussion

Juan Rael, Traffic and Streets Manager, provided an update regarding neighborhood traffic management and the information that was included in the packet. Attachment B historical data collected in 2016 and 2017. Attachment C east bound new data collected in July and August of 2020 on Urban Street at North Park; 85th percentile speed shows 27 mph, down from 33 mph. Mr. Rael explained the traffic survey summaries for Ridgeway and Urban. Data that was collected on Ridgeway (Attachment A) indicates mean speed was found to be 19 mph and the 85th percentile was found to be 24 mph (speed limit is 25 mph). The data indicates that there was not a speed problem on Ridgeway.

*Chair Wheeler explained that Ridgeway is a very narrow street and parking on the street might factor in as traffic calming. There might be a perception problem from the person standing still that vehicles are traveling faster than they really are.

*Member North asked a question about excessive speeds on Attachment C. Do the detection devices capture motorcycle data the same as cars? Anne Laurent mentioned that there is a process to get the speed monitoring devices out to neighborhoods, and staff is happy to put them out as requested.

*Commander Morris indicated that since April 1st officers have conducted approximately 900 traffic stops; 15% were in neighborhoods. Over the past two weeks 40% of their traffic stops have been in neighborhoods; officers logged approximately 333 hours, 60 hours on the Trinity/Sandia Loop the past two weeks. LAPD has purchased two traffic shields that have a camera built in the device which will be deployed in different areas this month. LAPD will continue to respond to resident concerns in coordination with Traffic & Streets.

*Commander Morris mentioned that an alert will be sent from the device if they are tampered with.

Vice Chair Schiferl wanted to commend the police department on their great professionalism.

*Anne Laurent mentioned that there are three different types of technologies: traffic shields, speed trailers and the small data collection that are on a pole.

*Chair Wheeler asked what the plates are on the road? Juan clarified that the tubes are data counting collection devices for traffic counts.
