Tamara Baer, Los Alamos County Planning Manager, presented to the Commission the draft sign code. She said that the Supreme Court case Reed V. Gilbert deemed content on signs as freedom of speech and any content based regulation was unconstitutional. Ms. Baer highlighted the major changes made to the code.

Commissioner Mamula asked if regulations for Electronic Message Centers (EMC) were going to change mostly in the regulation of the night illumination of signs.

Ms. Baer said that no changes will be made to the dark sky aspect of signage meaning that no obvious glare can be present.

Commissioner Martin asked if signage for trails and open space will still be allowed as well as kiosks on County Property. Ms. Baer said they would be allowed under the exemptions section.
