Motion:

Board Member Aaron Walker moved to approve the minutes from the March 18, 2019 meeting. Board Member Derkacs seconded. The motion passed (5/0). Member Hollabaugh abstained.

D. Public Comment for Items Not on the Agenda

II. PRESENTATIONS AND DISCUSSION ITEMS (Action May be Taken on These Items)

A. Update on the Legal Landscape for Codes from Judge Allen

Chair Ozment introduced Judge Allen and invited her to the podium to give her presentation to the board. Judge Allen told the board some of her legal background in JJab and Teen Court. She stressed her judicial philosophy and the importance of remaining impartial when hearing a case. Judge Allen reviewed the court and police forms associated with criminal cases, citations, and summons. She also explained the sentencing options, disposition of 2018 code charges and cases, and common legal definitions related to cases. She reported that codes cases have never resulted in jail time and in only two cases was a fine levied. Mr. Andrus explained that in the future the charging document will pare down the number of offenses to focus on only the most egregious violations. The board asked questions and received responses from Judge Allen and Mr. Andrus.

B. Review Codes: 18-54 Structural members; 18-55 Foundation walls; 18-56 Exterior walls; 18-57 Roofs and drainage; 18-58 Decorative features; 18-59 Overhang extensions; 18-60 Stairways, decks, porches, and balconies; 18-61 Chimneys and towers; 18-62 Handrails and guards; 18-63 Window, skylight and door frames; 18-64 Doors; 18-65 Building security. 16-281 Inoperable Vehicles; 16-361 Off-Street Parking (parking on the front lawn); 38-367 Un-hitched trailers.

The board discussed the codes listed on the agenda. The sections of most concern to the board covered sections in Chapter 16, i.e. inoperable vehicles, off-street parking, and un-hitched trailers. The board discussed the nuances of "aesthetics" and "property values". Attachment A flipchart pages illustrate the main issues discussed.
