The ESB discussed the award categories, criteria, name and process at the April 2019 meeting. The following changes were made. The award name was changed from Recycler of the Year Award to Zero Waste Champion of the Year Award to be more inclusive of all the sustainability issues. The categories were also expanded from two categories - Educational Institute and Business/Non-Profit, to five categories - Schools, Business, Small Business, Restaurant and Non-Profit Organizations. The winners will be announced at the Chamber of Commerce Banquet on June 7th, and at Chamber Fest on June 8th.

#### REPORTS

#### A. Chair's Report - Lisa Bakosi

Chair Bakosi reported on the B&C luncheon which she attended on May 16th. This included Fuller Lodge receiving a nine-thousand dollar grant to use to create an interpretation of Fuller Lodge. The White Rock library has an art display called "Kites of Many Colors." The library will continue their summer reading program including adults in this program. The library also has two vacancies on their board. A big discussion on the summer concerts because of how large it may become. She was also asked about the Eco Warriors business that picks up glass at residents' curbs. Staff Liaison Angelica Gurule and Chair Bakosi also presented the ESB 2020 work plan to the County Coucil.

#### C. Liaison's Reports

#### 1). Board of Public Utilities - Sue Barns

Member Barns reported that they are doing interviews for the Utilities Manager position, Tim Glasco is retiring this year and they have received 10 applications, 5 in-house and 5 out-of-house. They are also in the process of appointing a new member to the board. The waste water treatment plant had a couple of violations that the EPA found, regarding chlorine and PH difficulties. They met this week with DOE and NNSA to discuss about the power pool agreement. The chair of the board asked if we received the report form Robert Gibson on Green House Gas Emissions from the county. They also talked about a possible joint meeting to be presented by Robert Gibson about GHG.

#### 2). Planning and Zoning Commission - Vacant

Chair Bakosi reported that they reiterated about the all the building that is happening in the county.

#### 3). Transportation Board - Heather Ward

Chair Bakosi reported that the Transportation Board are included in the construction on Diamond Dr. and have sent out RFP's to fix the disintegration that happened over the winter season. They are looking into completing streets to make them safer for the public and have access to use them. They have one position open on their board.

#### 4). Parks and Recreation Board - Heidi Rogers

Member Rogers reported that on Earth Day they had 55 people volunteer to plant 90 blue stem willows and 50 mountain mahogany tree in an area with high risks of mud slides around Ponderosa Estates. The board is going to present at the next meeting on the usage of Round Up.

#### 5). Community Development Advisory Board - Warren Mazanec

Member Mazanec reported that he will be presenting the Save As You Throw presentation to the board. He will also be asking the board that while they are reviewing the code to look into codes about composting in backyards. Aaron Walker, CDAB liaison to the ESB, commented that they were at the farmers market a few weeks ago and received a few comments on the use of Round Up.

#### 6). County Council Liaison - Antonio Maggiore

Councilor Maggiore reported that he liked Chair Bakosi's presentation. He also reported about the joint meeting with the schools and that Dr. Steinhaus was speaking in favor in the ESB efforts to make schools more environmentally friendly and to reduce waste going out of the schools. He also mentioned about a project he would like to do with the Eco Clubs at the Middle School and the High School. He has a plot of land that he has turned into a garden and was wondering if there was any interest in having those clubs come over and help

take care of the garden.

#### D. Subcommittee/Team Reports

#### 1). Save As You Throw - Sue Barns

Member Barns reported that they had a booth at the farmers market recently and that there was sparse attendance because of how early in the year it is. They collected more comments on Save As You Throw. Their current project is to reach out to other communities about how they have implemented a Save As You Throw program in their community.

#### 2). Los Alamos Public Schools Subcommittee - Lisa Bakosi

Chair Bakosi reported that she is excited that Kurt Steinhaus is interested in changes in the school and that he wants to continue with Operation Green Cafeteria. She sat with some teachers and talked about pulling together a Zero Waste Festival which would be a daylong event to third graders in town similar to PEEC's water festival. Susan Hettinga, Green Team Leader at Chamisa is doing a Summer Seminar to other teachers on how to make their schools more Eco Friendly.

#### 3). Zero Waste Los Alamos - Dorothy Brown

Member Brown reported that herself and Staff Liaison Angelica Gurule went and talked to Mr. Arellano about why we should encouraged the community to compost in their backyard and wanted to know what the rules were about backyard composting. He suggested that people attend a workshop on how to compost properly before starting their own backyard compost. He is also in support of backyard composting. Any nuisance issues would be reviewed on a case by case basis.
