4. CURRENT PROJECTS - UPDATES AND POSSIBLE ACTION

- A. [11913-19](#) Ed Grothus "Sunflower" donation

Joe Lindsay of Sculpture Smart inspected the sculpture and his proposal for repair and construction of a supporting frame will be considered at the June meeting.

- B. [11914-19](#) Richard Swenson "Lizard" donation

Donation paperwork has been completed. Katie Bruell from the Nature Center spoke in favor of accepting the donation. Next step will be creation of a staff report to Council completed by May 31 to be on the agenda for the June 11 Council meeting.

Vice Chair Ozment moved to recommend to Council the acceptance of two lizard sculptures from Richard Swenson to be installed at the Los Alamos County Nature Center. The total budget for the project is not to exceed \$3000.00 including installation, plaque, dedication and contingency. Board Member Carson seconded. All voted in favor. (3/0)

More public opinion on the relocation of "Apache Harvest" will be gathered at the Friday night concerts.

The contract will be sent out to the artist on May 24. The artist is starting to design the piece.

Alternate locations inside Fuller Lodge could be considered.
