8.c. Emergency Preparedness Brochure

Utilities Manager's Report September 17, 2025

- 1. For the replacement transformer at the White Rock sub-station, DPU in coordination with the design engineer T&D have made a selection, and we are in the process of completing the purchasing documents to replace the failed 5 MVA transformer. The transformer selected is \$380,000 with a three-year warranty and will be rebuilt upon order and delivered between 10 to 12 weeks. This 12 MVA transformer can be expanded to 22.4 MVA by adding cooling fans. This will allow for our future needs as identified in the Distribution System and Electrification Study. Staff is still coordinating with LANL on the temporary tie design. The pole staking by LANL is scheduled for this Friday and then DPU can stake the LAC side of the road for the tie line and then work to set poles. The voltage regulators have been delivered. Finally, DPU has found the right person at PNM, the vice president of engineering, in obtaining a mutual aid type agreement with PNM to use their mobile transformer if necessary.
- 2. For Elk Ridge, about half of the new gas line has been installed. Cartwright Plumbing is inspecting homes for the gas service cut-over to see if there are any code upgrades required by the homeowner that is required before cutting over to the new gas system.
- 3. The Deputy Utility Manager for Electric Distribution has been re-advertised since no qualified applicants were received. Dennis Astley, Engineering Manager, has been appointed acting Deputy Utility Manager for Electric Distribution. Next week, staff will interview the Business Operations Manager and are currently in the process of making an offer for the Billing and Service Specialist. Other recruitments that are ongoing are for the Engineering Project Manager for Electric Distribution and Engineering Aid for utility locates.
- 4. NNSA Albuquerque procurement office has presented a draft ECA to staff and we held a meeting to provide some clarifications and answer some questions in development of this agreement. They still have a lot of work to do on this agreement before we can present it to BPU and Council. At last night's Council meeting, Mr. Ted Wyka, NNSA Los Alamos Field Office Manager, offered that finalizing this agreement is a priority for NNSA.
- 5. Foxtail Flats is in the process of ordering the equipment and plans to mobilize to the site on 11-15-2025. The first phase is due to go on-line on 10-30-2026 and the second phase will be online on 3-15-2027.
- 6. The proposed award for the Jemez Fire Protection Project has cleared the headquarters review and DPU is still awaiting Secretary Noem's approval.
- 7. UAMPS held a short session this month and only covered the CFPP at this month's meeting. The closeout of the DOE award is on track; however, the exchange of funds will run into October, and the letter of credit held by CFPP LLC was extended by a month. Next month, I will attend the board retreat in Sacramento, CA where CAISO is located.

- 8. The Pathway to Zero Natural Gas project survey has closed and received 905 total responses and just under 600 completed surveys.
- 9. Met with senate staff for Energy and Natural Resources Committee and explained our pending issues with the ECA delays, hexavalent chromium plume remediation, FEMA grant delay and Forest Service lag in project reviews. Also on September 4, 2025, I attended a tour with our state and federal representatives and explained some of the same issues with them. Also, I explained the benefit of the EA-4 power line replacement and how it supports vital infrastructure. EA-4 line replacement is in the top five of the County's ICIP list of projects.
- 10. In celebration of National Preparedness Month, Los Alamos County Emergency Management invites the community to a special event focused on emergency preparedness. The event will take place on Sept. 18 from 6 to 9 p.m. at the SALA Event Center and DPU will have a table and a handout for this event.

Who is DPU?

The Department of Public Utilities is **county-owned**. Established under Article 5 of the 1968 Charter for the Incorporated County of Los Alamos, the DPU falls under the jurisdiction of the Board of Public Utilities. Community members apply, interview and then are appointed by Council to 5-year terms.

Restoring Power

1. Assessment

Crews immediately begin restoration work while assessing the full extent of damage, which may take hours for largescale events. During this phase:

- Accurate restoration times for specific areas are often not available.
- Except for very small outages, updates are provided via DPU's social media channels and local media.
- In the unlikely event of widespread outages that pose health or safety threats, the Code Red emergency alert system may be used.

2. Substations, Main Lines, Critical Facilities

LAC has two substation power sources:

- Townsite Switch Station (LAC-owned but supplied by a Los Alamos National Laboratory (LANL) substation)
 - White Rock area substation (LAC-owned)

Priority is given to:

- Repairing outages at LANL substation (by LANL crews).
- Restoring main lines serving large numbers of
- Powering critical infrastructure such as hospitals, wastewater treatment plants, communication systems, water pumps & wells, and schools.

3. Taps and Service Lines

After main line restoration:

- Repair damage to tap lines branching off main lines (serving neighborhoods or areas like the ski area).
- Fix individual service lines to homes. During this stage, estimated restoration times are provided through social media and local media.

Transformer Boxes



- Keep your distance. Electric transformer boxes house transformers fed by 13,600 volts of electricity.
- Don't plant trees and shrubs too close to it. Roots can grow around underground power lines presenting a potential hazard for anyone that tries to remove that plant.
- To work on the transformers safely, electric linemen need at least 8 feet of clearance in front and 3 feet on the other three sides.
- Do not try to remove trees and shrubs near boxes on your own! DPU's linemen will remove them.
- Even when situated on private property, all transformer boxes are on county electric easements.
- When planting vegetation, call for locates by dialing 811 first even if a transformer is not in the area. Contact NM811 at least 2 days before digging. You can also submit a locate request online at www.NM811.org. Click on "I'm About to Dig."

Public Safety Power Shutoffs

Special notifications (texts, phone calls, emails) are sent in the event of utility emergencies and planned electrical outages impacting those that voluntarily register for the Life-Sustaining Medical Equipment Alert (ladpu.com/medequip).

You might receive a call from the **Customer Care Center** (505.662.8333) if your account is past-due, an excessive water leak is discovered on your account, if a normal payment method bounces back, or for some other account anomaly.

Staying Cool

If you have power:

- Close windows and window treatments during sunny hours.
- Install cellular shades, window films, or blackout curtains for added thermal insulation.
- Use fans strategically to move air from cooler areas to warmer areas. Put a fan in an open window to blow in cooler night air.
 - Set ceiling fans to rotate counterclockwise in the summer.
- If you use room fans with air conditioning, you can set AC 4 degrees warmer without impacting comfort.
 - Run your dryer at night or hang your clothes outside.
 - Take cool showers and baths.
- Visit a Cooling Station! These are air conditioned places where you can cool off and drink water to get relief from the heat without pressure to



buy. In Los Alamos County: County-owned public buildings, White Rock Visitor Center, Nature Center, Senior Centers, Los Alamos Co-op Market, Smiths, Natural Grocers, American Legion Post 90 and Bathtub Row Brewing Co-op.

If you don't have power:

- Seek out family, friends, neighbors or public places that do have power and AC.
- Wear loose, lightweight, light-colored clothing.
- Close and cover windows to keep out heat and sunlight.
- Drink lots of water.
- DO NOT open fridges and freezers for the cool air.
 - Use hand fans and spray bottles.

Keeping Warm

If you don't have power:

- Close off unneeded parts of your home and concentrate people, plants, and pets into one smaller room.
- DO NOT use outdoor cooking grills or your gas oven to heat spaces.
 - Take care if utilizing indoor wood fireplaces.
- Wear layers.
- Cover windows with heavy window treatments.
- For prolonged heat outages, open cabinet doors that house plumbing. Set faucets to a very slow stream to prevent freezing.
- Seek out family, friends, neighbors or public places that do have power and heat
- Stay hydrated.

If you do have power:

- Set fans to rotate clockwise in the winter.
- Move furniture away from radiators and heating vents. Clean or replace filters.
- Close window coverings at night.
- Draft-proof your home.

Medical Equipment Alerts

The DPU maintains a **voluntary medical equipment alert program** for customers who use life-sustaining, electrically powered, medical equipment for the preservation of health or life. This list helps us to identify individuals with special notification requirements of planned utility outages and assists us in prioritizing repairs for unplanned outages.

Weattempt to provide special notification above normal notification procedures to registered community members when a planned power interruption is scheduled.

Although we work hard to maintain and improve the reliability of the electric system, we cannot guarantee that a power outage will never occur. It is the responsibility of the individual to have a backup system and/or a plan of action in the event of a power outage.

We ask that those who are registered re-enroll once a year so that we can keep the list current. After a year, customers who do not re-enroll are removed from the list.


WildFire Evacuations

Los Alamos County follows the Ready, Set, Go guidance for wildfire preparations.

Sign up for Code Red for instant evacuation notices at <u>lacnm.com/codered</u>.

Utilities-related preparations might include:

- Eliminating outdoor water use to ensure sufficient water pressure to fill tanker trucks and other fire fighting efforts.
- Powering off devices and appliances before you evacuate to reduce unnecessary draw in the event of a power outage while you are gone.
- **DO NOT turn off utilities to your home.** DPU will handle turnoffs on a neighborhood scale, if it becomes necessary
