

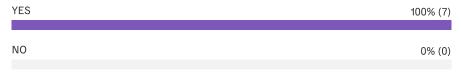


2023 BOARD OF PUBLIC UTILITIES SELF-EVALUATION

Is there a board policy manual addressing meeting procedures, committee roles and structure, election and term of officers, new member orientation, and related matters?



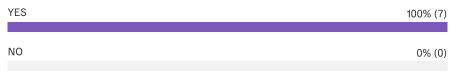

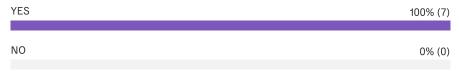

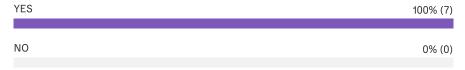
