Once a resident fills out and submits this application, an interview is scheduled with the B&C's County Council liaison, the relevant staff liaison, and the B&C Chair. After the interviews, the applicants' names are presented to the full Council during a regularly scheduled Council meeting, where a vote is taken regarding the appointment of each applicant. Each applicant will be notified if they are appointed or not.

Only on-line applications will be considered.

1	<p>Please tell us a little about yourself and then describe your experience, education, and training that qualify you for this Board or Commission.</p> <p>Ocean engineering, Naval Architecture for 9 years. Stay at home mama, Volunteers with Girl Scouts. Most of her work experience is in small Engineering firms. Map making is her passion. She has attended in the board meetings.</p>
2	<p>What do you believe are the greatest issues facing the County? What do you believe are the greatest issues facing the Board/commission you applied for? Girl Scouts just did a project planting trees. Fires are our biggest concern. In addition, small businesses, supporting them and adding more. For this board: bidding process is important. Getting community feedback. Wants to work on current and future projects. Identifying new projects and locations. Can we partner art with supporting local businesses.</p>
3	<p>How do you perceive the role of County Boards and Commissions in local government?</p> <p>Difficult question. She has seen Boards do studies on composting and trash mgt. Way for the public to pursue ideas/projects. Support interaction between the residents into the county council.</p>
4	<p>What specific skills do you feel are important for effective Board or Commission members? Which ones do you possess?</p> <p>Be willing to talk to the public and take negative feedback. Do not get emotionally engaged, take the feedback and dialogue and help build a case</p>
5	<p>What could you do, specifically, to foster a collaborative relationship between staff and the Board or Commission on which you would like to serve?</p> <p>Engineering staff, she has the background in engineering, so she has that common background, so it is beneficial. We are missing that expertise with Pete Carson terming out.</p>

What do you think was your greatest contribution during your tenure?</p> <p>She has not officially served on a Board, but she has managed and led the cookie sales for Girl Scouts. Very engineering mentality. She is good at scheduling, logistics and working through projects. Ran it very much like an engineering project. Previously it was very chaotic around cookie pick up, so she made changes and it runs more smoothly. She started that 2017. She developed a cookie committee because previously it fell on one person.</p>

Is a stay @ home mom. Moved to Los Alamos in 2014. Volunteer with Girl Scouts. Worked for a small consultant firm, where there were responsible for their own proposals. Therefore has experience with public presentations. Did make a submission to MapMaker. She is not experienced with APP, but has some familiarity.</p>
