

**INCORPORATED COUNTY OF LOS ALAMOS RESOLUTION NO. 23-25**

**A RESOLUTION OF THE INCORPORATED COUNTY OF LOS ALAMOS COUNCIL AUTHORIZING THE FILING OF AN APPLICATION AND OTHER DOCUMENTS FOR FEDERAL TRANSIT ADMINISTRATION SECTION 5310 FUNDING, COMMITTING THE NECESSARY LOCAL MATCH AND STATING THE ASSURANCE OF THE COUNTY TO COMPLETE THE PROGRAM UPON RECEIPT OF THE FEDERAL TRANSIT ADMINISTRATION FFY25 SECTION 5310 ENHANCED MOBILITY FUNDING**

**WHEREAS**, The U.S. Department of Transportation is authorized to fund and disburse grants to states through the Federal Transit Administration (FTA) Section 5310 program (49 USCS § 5310, Formula grants for the enhanced mobility of seniors and individuals with disabilities); and

**WHEREAS**, eligible project sponsors wishing to receive FTA Section 5310 grants for a program in New Mexico, shall submit an application first with the New Mexico Department of Transportation, Transit and Rail Division (NMDOT) and second through the Northern Pueblos Regional Planning Organization (NPRPO), for review and inclusion in the State's Section 5310 Program; and

**WHEREAS**, the NMDOT is the planning organization for the Los Alamos County region; and

**WHEREAS**, the NMDOT has programmed FTA Section 5310 funds toward the capital assistance for the Incorporated County of Los Alamos ("County"); and

**WHEREAS**, County is an eligible project sponsor for the FTA Section 5310 funds and is authorized to submit an application to receive the FTA Section 5310 program funding; and

**WHEREAS**, County wishes to submit a grant application to the NMDOT for funds from the FTA Section 5310 program.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE INCORPORATED COUNTY OF LOS ALAMOS**, that the County Council, by adopting this Resolution, does hereby authorize County's Transit Division to submit an FTA Section 5310 grant application on behalf of County.

**BE IT FURTHER RESOLVED** that the County Manager is authorized to execute any necessary documents with NMDOT or FTA, or related agency, for receipt of such funding and is authorized to commit to the required local match of Forty-Four Thousand Six Hundred Ninety-Four Dollars (\$44,694.00) for the 2025 Federal Fiscal Year.
