Deputy Utility Manager - Engineering was serving as the Acting Utilities Manager and provided the board with details regarding a recent leak survey of the natural gas system in the Elk Ridge neighborhood at 2025 East Jemez Road. The inspection, which took place from July 15-17, did not identify any immediate gas leaks in the areas that crews were able to inspect. DPU is now continuing inspections for the areas that they were not able to fully access. The department began contacting Elk Ridge residents the afternoon of August 7th and will continue to update the BPU and Council on the status of this event. Ms. Anne Laurent, County Manager also commented that her communications with the NNSA and Triad regarding the situation were positive and appreciated.

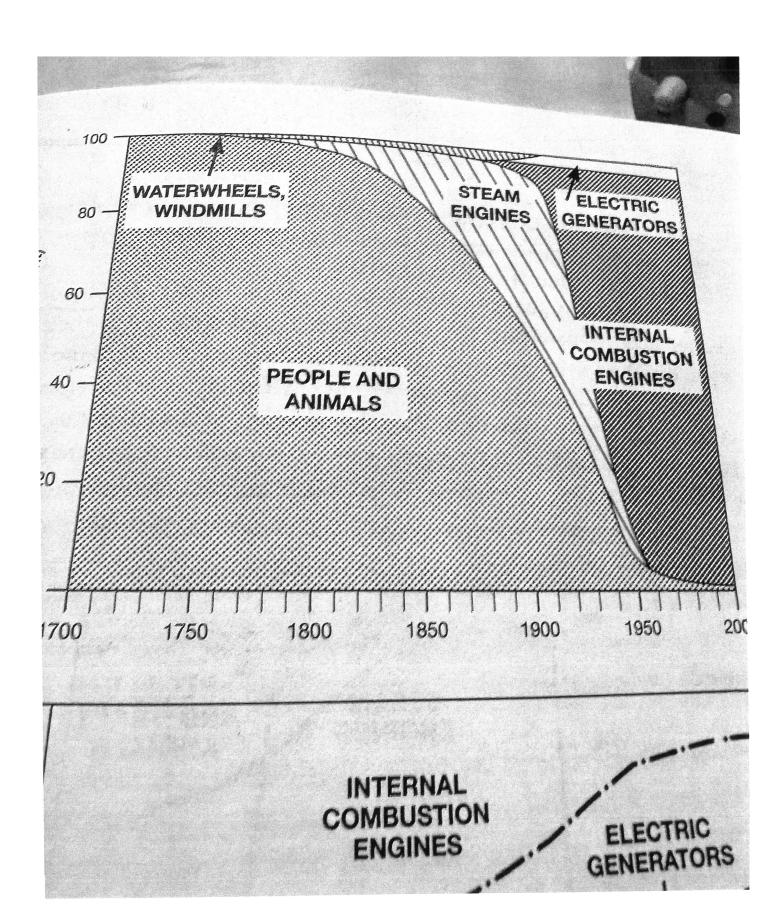
