17758-23 Approval of Minutes from the Los Alamos County Health Council Meeting on

17868-23 Updated process for Los Alamos County Health Council topics- Presented by Lori Padilla

Lori Padilla presented on an updated process for Health Council members, and members of the general public, to suggest issues for the Health Council to look into in more depth. Lori showed examples of how previously discussed topics would flow through in this new process, and Health Council members had a robust discussion to brainstorm several additional topics to consider.

Unfortunately, due to technical difficulties with zoom, the conversation and meeting were cut short, and the Council did not get to the Subcommittee and Staff updates.

- 17759-23 LACHC Comprehensive Health Plan/Equity Subcommittee Update- Cameron Counters & Emily Piltch
 - 1. The subcommittee meeting in Sept. was cancelled.
 - Because there are no pending issues that need to be decided, and it is a county observed holiday, the October 9, 2023, CHP subcommittee meeting is also cancelled.
 - 3. Status of scoping interviews data collection and analysis: Currently in the analysis phase of the information we learned from interviews and focus groups with community members. A reminder that we're summarizing input based on the 5 social determinants of health. While we've wrapped up interviews and focus groups, we're certainly open to doing additional ones if there's compelling reason.
 - 4. On sept. 19, following the LACHC presentation to the County Council by Lori Padilla and Jessica Strong, Emily presented a synopsis of the process being used to develop the Comprehensive Health Plan and the status of the project.  - There will be 3 community forums -all structured similarly- to share with the public an overview of what we've learned so far, AND it will provide opportunity for additional input to be shared.

- A brief questionnaire is live on the CHP website- it's another opportunity for community member input.

- 6. Community survey: We are exploring requirements of the County procurement process so that we will be able contract with a community survey provider to provide questionnaire design and survey administration services. We have also had exploratory conversations with a survey provider currently under contract with the County. We have developed a working draft version of a set of questions to include in the community questionnaire. The draft questions are derived from the topics and issues raised through the scoping interviews of health and wellbeing service providers. We will follow the same process to draft questions based on the community scoping interviews after the interviews have been analyzed.
- Project timeline: The next major milestone is administration of the community survey which is targeted for late winter/early spring of 2024.
 Completion of the CHP is anticipated for late summer 2024.
- 8. Status of collection of CHP's from peer locales- We have some that we've collected over time https://drive.google.com/drive/u/3/folders/1 -mC7a5oVgFEm7Dlj-0yh6AGvd 2SdtCd> Have glimpsed at some of the counties IDed as similar by University of Wisconsin Population Health Institute Health Rankings-Counties similar to Los Alamos, NM based on key demographic, social, and economic indicator. However, given Los Alamos's unique combination of community characteristics (e.g., education level x community size x rural location) we may need to do a search of communities that may be dissimilar to Los Alamos but share one or more unique characteristic with Los Alamos.

Health Equity Council Update:

- 1. At September meeting, Jeramay presented on the Comprehensive Addiction and Recovery Act (CARA), we'll hopefully hear more from her within this CHC setting in the next couple of months.
- 2. The focus of discussion at the Health Equity meetings has been gathering topics that are of most importance to group members. At the October HEC meeting (the 18th) we'll be discussing and identifying synergies among topics that have been discussed. There are a lot of important topics that come up and we'll be adding those to the CHC decision model that Lori spoke about, and we'll also be looking for other strategies to work towards these priorities- including through next steps with the CHP.
