The ESB received a presentation from Ron Wilks, Vice President of SCS Engineers, on the Los Alamos Closed Landfill Gas Extraction system. The Landfill was closed in 2009, methane gas was detected migrating away from the landfill so a temporary gas extraction system was installed in 2014. Design and installation of a permanent system took place in 2018 and 2019. Once the permanent system was brought online methane outside the landfill was once again at safe levels. Mr. Wilks stated that in five to ten years the current system may need to be replaced with a smaller one. There may be an option to sell the current one to cover the cost of the smaller system.

Some questions asked included how much of an impact would not spraying cause in terms of labor and will there be a need for more employees? Would the

County and residents be ok with more dandelions and weeds?
