Councilor Rachel Mohr-Richards told the council that JJAB held a Youth Mental First Aid Training for staff members at LAPS Transportations. Kristine Coblenz trained about 30 of the staff. They are looking at having another training for the general public on October 4th. There is also a Community Conversations being held on September 28th to help with strategies on dealing with political stress. They contracted with a psychologist in Washington D.C. who's clinical expertise and dissertation was on this topic. Everyone is welcome to join.

Councilor Sylvia Diehl told the council that they are getting ready for the start of the school year. They now have a Sources of Strength Room (SOS) room to have it open as much as possible. They will be using sources of strength at the High School this year. They have Rita at the Middle School doing the Grow Your Mind Program. They are also focusing at expanding the SCL program. They would like to find a way to reach out to parents and potentially collaborate with other organizations.

Staff Liaison Sara Martinez told the council that the DWI booth has been at the concerts and doing well with adults and kids. A fan favorite is the question wheel. The questions are true or false questions and it helps get adults and older youth thinking about drinking and driving as well as consequences. For the younger youth it starts the conversation about drugs and how they can be dangerous.

Councilor Jemuel Montoya told the council that Los Alamos Police Department (LAPD) has had a few cases the past two month.
