Councilor Kristine Coblentz updated the council about the Alcohol Awareness Classes that was done for LAHS Drivers Ed. There was a total of 63 students. The Elementary School event Drugs, Sec, and Phones: What Families Need to Know About Phones was well attended and there was great engagement with parents who attended. They are planning on events with more depth of information for the future. She completed the QPR Training and Suicide Prevention. She will be holding the first training in January.

Councilor Rachel Mohr-Richards told the council that JJAB has gotten their first Seven Challenges group up and running with 5 students. They are already seeing the students thinking critically about drug use and life choices. The Youth Peer Support Specialist is almost finished with certification with New Mexico Center of innovation. She is accepting new clients. She explains the peer support specialists job and who would be a great fit for her. Herself and Kristine will be hosting a community wide Youth Mental Health First Aid Training, Saturday, January 11th. It'll be 8:30 am to 5:30 pm at Fuller Lodge. It is free and lunch will be provided. This is open to those who wants to learn to support youth.

Councilor Jaime Gonzales gave an update since July.  
July 31st at 1:30 am, 47 year old female, DUI crash by the new round about.

August 19, 2:00 pm, 36 year old male, called in an assault, found him on NM4, found he was impaired  
September 1, 11:40 pm, 43 year old male, officers heard an individual honking their horn, traffic stop and arrested one individual who blew a 0.15.  
September 16, 8:30 pm, 63 year old male, police officer watched erratic driving and pulled over, arrested for open container and blowing a 0.13.

Los Alamos Police Department conducted a Road Block in October. They tested 4 individuals. No arrest. There is plan for more road blocks in the future. They are looking to get supervisors certified as DRE. Next year, they plan to conduct three DRE schools.
