## COUNTY MANAGER'S MONTHLY REPORT



## INTRODUCTION

The County Manager's Monthly Report provides updates on key programs and projects, County financials and metrics that help track how we are serving our community.

## NOTE FROM THE COUNTY MANAGER

March started with a trip to Washington DC by Council's Federal Working group (Chair Cull, Vice-Chair Havemann and Councilor Ryti) along with Intergovernmental Affairs Manager Danielle Duran and I to talk to our federal delegation and committee staff about the Council's priorities. Although uncertainty was a predominant theme, the meetings were positive about our focus on housing, jobs, infrastructure and safety. March 12<sup>th</sup> was Los Alamos Day at the New Mexico Legislature. Chair Cull, Vice-Chair Havemann, Councilors Herrmann and Reagor and leadership staff were sponsored by Senator Leo Jaramillo and recognized on the Senate Floor.

Additionally in March, staff stayed focused on completing the proposed Fiscal Year (FY) 2026 budget document that was published on March 31<sup>st</sup>. Capital Improvement Program (CIP) open houses were held on March 10<sup>th</sup> and 17<sup>th</sup> for our project managers to engage with members of the public about the many active projects the County is either planning, designing or constructing. Feedback about the open houses were positive and staff plans to have open houses on a routine bases - once or twice a year in the Spring or Fall.

- New appointments were made to the Planning and Zoning Commission, Transportation and Lodgers' Tax Advisory boards
- Eli Isaacson was appointed as Community Development Director with a start date of May 12<sup>th</sup>
- National Nuclear Security Administration (NNSA) Los Alamos Field Office Manager Ted Wyka gave a biannual update
- Library Board annual update
- Presentation and discussion on the proposed Wildland Urban Interface (WUI) code ordinance

- Introduction of traffic safety ordinances related to distracted driving and speed cameras ticketing
- Presentation on the County Fleet conversion plan and community-wide electric vehicle (EV) charging plan
- Citizen Petition request to purchase “The Boys of the Pajarito Plateau” oil painting by Jeff Segler was sent to Art in Public Places Board for a recommendation
- Amendment to Sky Elements agreement for a second 4<sup>th</sup> of July drone set and adding additional drones in future years (note in 2025 the 4<sup>th</sup> of July celebration will be at Ashley Pond due to rehabilitation of the fields at Overlook Park)
- 9<sup>th</sup> Street Apartment affordable housing deed restriction development agreement was discussed and approved
- Metropolitan Redevelopment Area (MRA) Downtown East plan was discussed for priority guidance

## **Public Meetings**

The CMO staff has been preparing the Fiscal Year 2026 budget for the upcoming April hearings. This includes hosting two open houses on March 10 and 17 to share information on completed, ongoing, and future County CIP projects with the interested public.

Kinnikinnik Trail ADA Trail Project was completed. A ribbon cutting ceremony was held on March 25<sup>th</sup>, 2025, at 1:00 PM. This trail was renovated in conjunction with a grant from the NM Economic Department's Outdoor Recreation Division's Trail Plus program

The Los Alamos County Pedestrian Master Plan returned to the Transportation Board on March 6 to summarize comments received and provide a tentative schedule for completion. Staff will address feedback received and will provide an update to the County Council on April 8, and a tentative final presentation to the Transportation Board in June, with a request for adoption at County Council in late June or early July.

The Pedestrian Master Plan update will be presented to County Council on April 8. A public meeting will be conducted at the Transportation Board meeting on April 3 for the Denver Steels Phase II Improvements project.

CSD hosted two public engagement listening sessions for the North Mesa Recreation Plan: one on March 12 at Cottonwood on the Greens, and the second virtually on March 26, providing an opportunity for community discussion and input.

## **INTERGOVERNMENTAL, TRIBAL, AND REGIONAL RELATIONS**

### **State**

The 2025 State Legislative Session ended March 22. Los Alamos County projects were included in legislation, including Capital Outlay for the Emergency Operations Center and for housing infrastructure – this bill has not yet been signed. The Intergovernmental Affairs Manager (IAM) presented to the Senior Management Team on March 16 about the legislative session

### **Federal**

Councilors Ryti and Reagor along with the IAM, attended the NACo Legislative Conference, which highlighted the rapid and high-level of change taking place within the federal administration. Subsequently, the Council Federal Working Group along with IAM met with the New Mexico congressional delegation, congressional committees and federal agencies to ensure those issues important to the County are visible to those

making decisions

### Tribal and Regional

IAM is currently working on finalizing a joint meeting with the Pueblo of San Ildefonso and Los Alamos County Council that is scheduled for May 9<sup>th</sup> at the County Municipal Building.

## FISCAL STEWARDSHIP

### Financial Overview

March was a busy month for the Budget office. The Proposed Fiscal Year (FY) 2026 Budget Book was published on March 31<sup>st</sup> on the County Website in anticipation of the upcoming Budget Hearings Scheduled for April 21<sup>st</sup> and will be continued to April 22<sup>nd</sup>, 23<sup>rd</sup>, 28<sup>th</sup>, and 29<sup>th</sup> as needed. Los Alamos County proposed budget for FY 2026 is \$364.9 Million in expenditure. A big thank you for all the hard work each department for putting together their budgets and cooperatively working with the budget office and County Manager's office.





### CLERK

#### State Legislature Activity

In the final days of the Legislature, several bills related to the Clerk's Office moved swiftly toward final passage. The most notable bills—SB 16, SB 290, and HB 101—have all passed and are now on their way to the Governor for signature. These bills reflect important changes that will affect voting rights, county funding, and election security.

- **SB 16** expands voting rights for non-major party voters, allowing Independents and third-party voters to participate in primary elections. Currently, only voters registered with the major political parties—Democratic and Republican—are eligible to vote in primaries. This bill aims to give non-major party voters a voice in candidate selection.
- **SB 290** increases the marriage license fee to \$55, with \$20 directed to the county clerk's recording and filing fund, \$20 going to the children's trust fund, and \$15 to the general fund. If signed, the fee change will be effective June 20, 2025.
- **HB 101** amends the election code to allow for an additional exception to the prohibition of firearms at polling places: commissioned law enforcement officers with arrest powers, both in the performance of official duties and in accordance with their agency's policies.

#### Los Alamos Day at the Legislature in Santa Fe, NM

Los Alamos County Day at the Legislature was an outstanding success. The County Clerk's Office played an active role in this important event, setting up a booth to represent our office and engage with the community. Our team had the opportunity to meet and connect with a wide range of individuals, from state legislators to representatives from various departments and local agencies.

Throughout the day, staff distributed promotional materials, shared information about the services we offer, and networked with other county agencies and partners. This event not only allowed us to showcase the work of the Clerk's Office but also strengthened our relationships with key stakeholders, further fostering collaboration within Los Alamos and beyond. Staff look forward to continuing these meaningful connections and building on the success of this event.

## **HUMAN RESOURCES**

Collective Bargaining with the International Association of Fire Fighters (IAFF) is ongoing. The current CBA expires June 30, 2025; if no agreement is reached by then, operations will continue under the existing agreement.

The Compensation Team continues to assist departments in updating employee and supervisor data in Munis for the 2024-2025 Performance Evaluation (PPA) period.

A new policy is being developed to comply with the Pregnant Workers Fairness Act.

Class 14 of the LAC Leadership Academy is on hold; re-evaluation of the program is underway with a potential Fall 2025 start.

Risk management staff will begin facility and site inspections to ensure OSHA compliance. These inspections aim to:

- Identify and correct unsafe work conditions.
- Ensure PPE usage, fire safety, machine safeguards, and policy adherence.
- Support a culture of safety and reduce liability.

The goal is to mitigate risks before they result in accidents or injuries, while also ensuring the organization remains in compliance with federal safety requirements. These inspections mark an essential step in fostering a culture of safety, reducing liability, and maintaining a secure environment for employees.

### Updates

In 2023, Los Alamos County replaced its Development Code with an updated version to streamline zoning regulations, development standards, and procedures while aligning with the county's evolving needs. The staff is currently working with the County Attorney's Office on a "Clean-Up" process to clarify language, fix inconsistencies, and refine standards, continuing into 2025 alongside a Comprehensive Plan update. This effort supports the County Council's Strategic Leadership Goals for Operational Excellence. Upcoming activities include:

- Proposal to County Council for Adoptions of Development Application Fees
- Chapter 16, Text Amendment application(s) to amend Article III, Use Regulations, and Article VI, Definitions

**New Initiative:** The Planning Division is creating an interactive development map—your go-to tool for tracking projects from application to completion! This addition will allow the public to stay informed with updates and key details on developments across Los Alamos County.

## INFRASTRUCTURE ASSET MANAGEMENT

### INFORMATION MANAGEMENT

#### Updates

Assisted with the launch of the library subsite on the County's public website, hosted by Granicus OpenCities. The subsite, [losalamoslibrary.org](https://losalamoslibrary.org), was developed collaboratively by the Library team, the vendor and Information Management.

Assisted the Fire department with configuring a Kiosk in Fire Administration to allow LAC residents to schedule fire inspection for their residence and properties. LAFD also plans to use the Kiosk at Ashley Pond Park during the 2025 Wildfire Day event in April.

Completion of the dHCI project – Replace/Refresh LAC Virtual Server Infrastructure (VMs) and move end of life/end of support infrastructure into a single HCI platform/infrastructure.

## **AIRPORT**

March take-offs and landing – 236. There was a 2% decrease over January due to unfavorable weather and wind. Classic Air (92 operations) and commercial operations continued like the previous month.

With the successful commissioning of the new fuel farm, the original fueling system—operational since 1962—has officially been retired. The legacy fuel tank was removed from the airfield, tested, and certified by the New Mexico Petroleum Tank Bureau. Following its removal, the site was leveled and restored, making way for a new generation of New Mexico weeds for the manager to mow.

This marks a significant milestone in modernizing airport infrastructure, and the County extends its appreciation to the Avgas Cooperative for nearly six decades of dedicated fuel service to the Los Alamos aviation community.

As part of ongoing efforts to enhance community engagement and regional partnerships, the Airport Manager attended the FAA-sponsored Southwest Airports Partnership Conference in Dallas at the end of February. The event provided an opportunity to connect with airport managers from across the region and participate in workshops focused on lease agreements, grant assurances, and airport master planning.

In addition, the Airport Manager participated in Aviation Day at the State Capitol, where he engaged with FAA representatives and networked with airport professionals from across New Mexico. As a long-time member of the New Mexico Pilots Association (NMPA), he has recently joined the organization's tourism committee. This involvement aligns with current terminal improvement efforts and supports the broader goal of positioning Los Alamos as a gateway for general aviation tourism in Northern New Mexico.

Locally, the Los Alamos Chamber of Commerce hosted a well-attended coffee and tea networking event at the terminal.

Fleet is working on needed updates to fuel tanks after State Inspection.



**Loc: FLEET - FLEET**


**Actual Number of Work Orders Finished**

Replaced lights and Fixtures – 10

Traffic electricians removed and replaced light fixtures at various locations in Los Alamos and White Rock and installed an in-line fuse holder and fuse on a light fixture along South San Ildefonso Rd. Electricians installed a shield on a streetlight along NM-502 and responded to a hanging light fixture due to high winds on Canyon Rd. at 39<sup>th</sup> St. and replaced an arm bracket, conductors, light fixture and installed in-line fuses.

The Signs and Markings crew have been working on sign reinstallations due to wind damage, and temporary installations for construction and wind damage.

Crews removed graffiti on signs located at the new Urban Trail. Additionally, crews fabricated new *Road Work Ahead* signs for our division to use and loan to other divisions in the county, fixed and fabricated 30 signs, and are gearing up for the upcoming striping season and getting the striping equipment ready, ordering and receiving paint materials.

Transportation Safety Specialist Benjamin Gonzales along with members of Risk, hosted a new Quarterly Safety Meeting on February 28<sup>th</sup> at the PCS Training Room for Traffic and Streets staff. The training consisted of round table discussions about any safety concerns crews may have experienced or witnessed, a talk from Mr. Gonzales about Occupational Safety and Hazard Administration (OSHA) hazards and fire watch readiness.

Mr. Gonzales also attended the Jemez Mountain Fire Prevention Phase 1 meeting to discuss traffic control for this project. He set up traffic control for the blood drive hosted by Social Services at the Municipal Building parking lot, and assisted Utilities Water Production with traffic control on Central Ave.

In response to the internet outages caused by the NM4 waterline replacement construction, crews dispersed message boards to designated locations informing the public of the Luman Network Outage for both events.

## EMPLOYEE RECRUITMENT AND RETENTION

### March Highlights

Recruitment staff have remained active at various regional job fairs and is helping departments fill vacancies, including management positions.

Police Department recruitment is ongoing, with a sign-on bonus being offered. Recent updates:

- PD testing was conducted on February 20th.
- Two candidates are in the background check process.
- One candidate has accepted an offer and will start with LAPD on May 12th

Community Development Director was approved by Council and will start May 12<sup>th</sup>, and the Deputy Public Works Director interviews were held on March 21st. Keith Wilson (internal candidate) was selected and began his new role on March 30th.

Recruitment is also working on staffing the 2025 Summer Student Intern Program, which will run for eight weeks, from June 9 through August 1. The job posting will be live from April 1 through April 30.

## HOUSING

WASHINGTON, DC – March 28, 2025: Mark Palim, Fannie Mae Senior Vice President and Chief Economist: “We expect the recent pullback in mortgage rates will provide a small boost to home sales this year. While our latest forecast calls for a period of modestly slower economic growth, historically, interest rates have been the most important driver of home sales. We think mortgage rates will move even lower within the next quarter and ultimately close the year at approximately 6.3 percent, which could be low enough to generate some extra sales from any would-be buyers still waiting on the sidelines.”— Fannie Mae – Economic & Strategic Research Group.

## Partnership Project Updates

**20th Street Development Solicitation:** County staff and RBMM development are finalizing the SPDA and related cost estimates for on-site and off-site improvements. The RBMM engineering team are completing initial design and cost estimates including a 'not to exceed' amount for intersection improvements. *[Goals: Downtown Revitalization, Local Business, Housing.]*

**Affordable Housing Service Provider RFP:** The Housing Trust staff are reviewing applications for both the Home Rehabilitation and Home Buyer Loans. The County and Housing Trust hope to issue affordable housing loans under the partnership in the coming weeks.

**North Mesa Update:** Wilson and Company largely completed the collection of field data for water and sewer modeling. The data will determine the necessary system upgrades necessary required to serve the site with utilities and how to mitigate impacts on the transportation system. In addition, the data will provide preliminary cost estimates for the work. *[Goals: Housing, Intergovernmental Relations.]*

## **Update**

The Library continues to meet the County's quality of life goal by providing diverse programming, materials, and services for all ages.

The Los Alamos Community Seed Library celebrated the start of the third season with two programs. The first program was hosted at MPL on Saturday, March 1. Garden experts and seed volunteers assisted patrons with selecting seeds for the upcoming growing season. The second celebration took place at the White Rock branch the following Wednesday with seed-themed Music and Movement and Storytime for the youngest library patrons and their families. Staff and seed volunteers also led seed crafts and activities, and cupcakes were enjoyed by all!

On March 6, the library hosted National Book Award finalist Deborah Jackson Taffa. In a well-attended author talk, she carried the audience through the arc of her life as an indigenous woman whose identity intersects many pueblos and tribes. She shared details of how she came to write her award-winning memoir and was available for an author signing after the event.

On March 28, the library hosted an after-hours special event with Los Alamos County Courts and Social Services and JJAB. The event explored different personal stories of grief. The program was offered as a part of an ongoing series of community "Deep Dives", a series intended to build community through storytelling and shared lived experiences. 50 community members attended.

In March, the Step-Up gallery hosted the 29th Annual Los Alamos Photographers' Show. The show opened on March 22. There were 70 visitors at the reception. The replacement of the siding at Mesa Public Library is finishing soon. The contractors, as soon as weather conditions permit, will move on to filling the surface cracks in the veneer of the building.

The public poll on the outdoor classroom closed on March 2<sup>nd</sup> with 230 responses received. Based on survey responses, Library staff will send feedback to the architect to modify the design.

The Broadband Manager continued to meet weekly with the Bonfire team to implement the Community Broadband Network (CBN). The project is currently in the engineering and design phase, having reached a milestone for completing the first half of this phase,

working towards delivering the preliminary or "High Level Design". The project team is working with staff from Public Works and Utilities to discuss the details of using existing county-owned conduit and aerial electric poles. Bonfire's subcontractor will have completed field proofing "burn area" conduit to determine viability for CBN use. Collaboration efforts continue with the Pueblo of San Ildefonso and their middle mile fiber project, including progress on finalizing a series of agreements related to grant match funding, construction and operation of the Pueblo's new 11-mile middle mile fiber line.







Atomic City Transit continues progressions for charging stations with ChargePoint and DPU for the Battery Electric Buses (BEB's).

Atomic City Transit has been under negotiation with the Department of Interior to continue the Los Alamos County Cooperative Agreement with Bandelier National Park Service for the 2025 shuttle service contract. This agreement would provide seasonal shuttle service from the Frey Trail to Bandelier Visitor Center during the busiest visitor season, mid-May through mid-October, seven days a week.





#### Updates

#### International Accreditation

Los Alamos is one of only five fire departments worldwide to achieve International Accredited status five times. Staff are preparing for a sixth appearance before the Commission on Fire Accreditation International (CFAI).

First, thanks to the division chiefs, program leaders, and teams for the phenomenal job of preparing the recent Annual Program Appraisals (APAs). There are many great things happening and some opportunities for enhancing the programs. The thoroughness of the APAs made it easy to produce the required Annual Compliance Report (ACR), which is a reporting requirement of the Center for Public Safety Excellence as well as the County's Cooperative Agreement with the Department of Energy (DOE).

In the last week of February, Chief Hughes, Chief Servey, Accreditation Manager Xavier Anderson, and Security and Administrative Services Manager Norma Valdez met with Retired Fire Chief Jerry Nullner, a Technical Reviewer from the CPSE, to go over details of the ACR. Chief Nullner quickly advised the department that he submitted his report to the Commission, recommending that LAFD remain accredited. He also suggested that the Los Alamos ACR *"be a best practice for others to follow."* It's excellent recognition for all of us!

In the coming weeks and months, an in-depth self-assessment and study of all that the Fire Department does will be conducted. Three critical documents will be created: 1) Community Driven Strategic Plan; 2) Community Risk Assessment-Standard of Cover; 3) Self-Assessment Manual. The accreditation process showcases the high-caliber membership of the Los Alamos Fire Department (LAFD) and verifies and validates that the focus of LAFD is exceptional service delivery

### **EMS Division**

LAFD's EMS Division conducted drills among all shifts with the lifeguards from Los Alamos Aquatic Center and Los Alamos County Dispatch Center to simulate a drowning patient at the pool. The lifeguards would rescue the person from the pool and render first aid while the dispatch personnel would notify LAFD personnel to respond and render further care to the patient. The drill simulated medical care until the patient arrives at Los Alamos Medical Center. The drills were graded and observed by LAFD training personnel, EMS Captain K. Kamplain, EMS Chief M. Pacheco, as well as our Medical Director Dr. Christopher Hammond.

### **Wildland Division**

Monday, March 17th, 2025, Los Alamos Fire Department (LAFD) in collaboration with Los Alamos County Parks and Open Space Department began work on an important wildfire fuels reduction project that will provide much-needed mitigation in several areas of Los Alamos. The primary focus points of this project will include ladder fuels reduction, increasing tree canopy spacing and fuel break construction.

LAFD crews along with Los Alamos County Parks and Open Space are doing mitigation work in the North Road area, which includes marking trees to be thinned, chainsaw work and the use of woodchippers. The mitigation work will continue through the summer with the goal of completing these designated areas in Los Alamos and White Rock in 2025.

### **Technical Rescue Team (TRT) Training**

The Los Alamos County Fire Department Technical Rescue Team (LAFD TRT) recently completed its first-quarter training for 2025, focusing on Confined Space Rescue. This training is designed to ensure team members can safely and effectively perform rescues in confined spaces, such as tanks, tunnels, silos, vaults, and other restricted environments found throughout Los Alamos County and the Los Alamos National Laboratory (LANL). These spaces present significant hazards, including limited oxygen, toxic gases, and exposure to biological, chemical, and other hazardous materials. During the training, the LAFD TRT conducted an equipment refresher and familiarization session, which included:

- **SCOTT Supplied Air Cart** – Ensuring rescuers receive breathable compressed air from external supply stations outside the IDLH (Immediately Dangerous to Life and Health) environment.
- **Communications System** – Reviewing protocols to maintain critical communication between rescue teams inside the confined space and incident commanders outside the hot zone.
- **Confined Space Blower Fan** – Using ventilation to introduce fresh air into potentially hazardous spaces.

Following the equipment review, the team conducted a scenario-based rescue at Fire Station #2's confined space prop. The scenario simulated a worker who became unresponsive after performing routine work in a confined space. The team executed a 20-foot vertical entry using a tripod and a rope rescue mechanical advantage system.

The Incident Action Plan (IAP) included deploying two rescuers on supplied air to enter the space and make contact with the victim. Safely packaging and extracting the simulated patient.

The rescue was successfully completed within the industry standard of under one hour, and all equipment was returned to service. The LAFD concluded the 1<sup>st</sup> Quarter of training and will conduct the team's second quarter this May, which will cover High Angle Rope Rescue. The team plans on traveling to Bandelier National Park to train on rescue techniques that we could face at their site.

## ENVIRONMENTAL STEWARDSHIP

In March, the Environmental Sustainability Board (ESB) heard an update on the Water and Energy Conservation Plan from Abbey Hayward. The ESB working group held their first meeting to begin researching the plastic bag fee as requested by the County Council. The ESB members working on this research are Shannon Blair, Hermann Geppert, and Rebecca Paley-Williams. Several climate action initiatives are funded and are in progress, such as gathering data for the Electric Vehicle (EV) Fleet Conversion Study and Community-Wide EV Charging plan and efforts to advertise a Request for Proposals (RFP) for Climate Action Marketing and Engagement Services in April 2025, as well as exploring how to design and effectively implement energy audit services for residential households. Staff, ESB, and Los Alamos Sustainability Alliance (LASA) are also preparing for the upcoming Earth Day celebrations.

### **Update**

Environmental Services has a monthly Household Hazardous Waste (HHW) drop-off opportunity. During the March 2025 event, Los Alamos County's contractor, ACT Enviro, provided trained personnel to properly categorize and sort materials from 60 residents, ensuring safe transport to appropriate disposal facilities. The next HHW collection event is scheduled for Friday, April 4, 2025, from 9:00 a.m. to 1:00 p.m.

Yard trimming collection for the 2025 calendar year began on March 24, and will conclude on December 5. During this period, Environmental Services collect yard waste on a bi-weekly basis from residential customers. The material is repurposed in various ways, including mulching for biosolid composting in wastewater management, erosion control at the Caja Del Rio Landfill, and landscaping by residents. Each household is eligible for one yard trimming cart. To register for a cart, visit

In response to the drier-than-average winter and increased fire danger, Environmental Services is offering additional services to help residents reduce fire risk. These services include the collection of large brush piles, bagged yard debris, and extra yard trimming cart pickups. The expanded services will be available through May 9, 2025. 



## ROADS

The Trinity Drive ADA project design is nearing completion with a 90% Design Review taking place on March 27. This project will be advertised for construction in Summer 2025 with construction being completed in 2026.

Active construction projects such as Bathtub Row and DP Road require consistent outreach to the public including affected residents, businesses, Los Alamos Public Schools, and LANL/DOE. This coordination is critical to successful project execution while minimizing negative impacts.
