20262-25 **Update on Los Alamos Airport (KLAM)**

Presenter: Gary Goddard, Airport Manager

Mr. Goddard's presentation outlined a plan to enhance access, improve utilization, and strengthen civic engagement at the airport. He shared his personal background and experience as a pilot, provided an overview of the airport's history, discussed the challenges facing aviation in Los Alamos, and highlighted the airport's role in supporting the local community.

20263-25 **Discussion of Canyon Rim Trail Feasibility to LAMC/Omega Bridge**

Presenter: Eric Ulibarri, County Engineer

Mr. Ulibarri recently delivered an engaging presentation on the Canyon Rim Trail, providing a historical overview of the project. The current trail spans approximately three miles and features a paved multiuse path that runs from Camino Entrada to Knecht Street. During his talk, he also addressed several important factors, including the constraints of the project, necessary construction work, land ownership issues, and the areas of interest for LANL and the DOE. He concluded with a discussion of the next steps for moving forward.

Following the presentation Chair Hampton made a motion following motion seconded by Member Altherr recommending that staff bring a proposal to Council to engage in a feasibility study for an extension of the Canyon Rim Trail beyond 20th Street; to include cost, right of way, possible physical, cultural and biological impediments to extending it. Also including early discussions with the lab.
