Board members shared their opinions. Member Grissom asked a question about the recycle fiber art.

A motion was made by Member Grissom, seconded by Member Haaser, that the APP Board make a recommendation to the Los Alamos County Council to place "Moonrise Shiprock" with a narrow black canvas, wooden stretcher bars, and a maple frame, by Patricia Gould and commission a custom piece of recycles fiber art by Lindsay Brenner, for art in the Los Alamos County Airport.

Member Haaser made a motion, Member Grissom seconded, that the APP Board agree to amend the current agreement in place with Mr. Davis to allow for an additional \$2,000, in order to complete the repairs necessary for the industrial machine.
