All meetings of a quorum of members of any board, commission, administrative

adjudicatory body or other policymaking body of any state agency or any agency or

authority of any county, municipality, district or political subdivision, held for the

purpose of formulating public policy, including the development of personnel policy, rules,

regulations or ordinances, discussing public business or taking any action within the authority of or the delegated authority of any board, commission or other policymaking body are declared to be public meetings always open to the public, except as otherwise provided in the constitution of New Mexico or the Open Meetings Act [Chapter 10,

Article 15 NMSA

1978]...."

Mr. Wyman offered valuable insights on several key aspects of public meetings, including the definition of an open meeting, the nature of public business, and what constitutes a quorum. He also covered the powers and duties of the Transportation Board, clarified that rolling or walking quorums are prohibited, and discussed the notice requirements for open meetings. The Snow & Ice Control Plan is a comprehensive strategy and approach to the snow and ice control operations of Los Alamos County to provide

Storm Response Goal - "The goal includes safe completion of an initial storm response within 24 hours of the end of a typical snow event; defined as snowfall of 6 inches or less.

Mr. Blea discussed the support provided by 10 departments and divisions for snow and ice control operations, as well as the necessary equipment. He shared insights on priority areas and safe routes to schools. Additionally, he provided details on the types of materials used for snow removal, recent changes to the plan, employee training, and the new equipment acquired for snow removal efforts.

Members of the public and members of the board discussed snow removal efforts at the stables and the need for additional snow removal efforts.

Chair Hampton moved to approve the FY25 Snow & Ice Control Plan, recommending that the North Mesa Stables be moved to Priority 2 along with County Facility B. Member Muck seconded the motion, which passed unanimously.
