## **Review Process**

Board and Commission (B&C) Work Plan Review Committee members Reagor and Havemann plus staff members Matteson, Pacheco and Lovato met on May 15, 2023 to review and discuss the work plans. Minor changes were recommended to some work plans. The requested corrections have been made and incorporated to the work plans.

The committee members reviewed the draft work plans using the following questions:

- 1. What is the area of responsibility for each B&C?
- 2. What is each B&C doing in its area of responsibility?
- 3. How is each B&C involving the public?
- 4. Is each B&C working collaboratively, when appropriate, with one or more other B&Cs?
- 5. Does the work plan reflect previous Council discussions on relevant topics?

## **General Recommendations/Comments on FY24 Work Plans**

- 1. The Work Plan Review Committee continues to encourage all the B&Cs to actively solicit public input and to look for ways to gauge public sentiment on items within the B&C's area of responsibility, with the help of the Public Information Officer as needed.
- 2. The Committee stresses the importance of the B&Cs collaborating on projects, when appropriate, and continuing to designate inter-board liaison assignments, as appropriate, to increase communication and coordination among all the B&Cs.
- 3. The Committee compiled information provided in the B&C work plans regarding how their work/projects relate to Council strategic goals. This information is provided in Attachment A of this report.
- 4. Overall, the Committee feels that the FY24 Work Plans were well prepared and addressed stated Council priorities. Committee members express their gratitude for the time and effort spent by the B&Cs on the work plans.
- 5. The Committee made suggestions and requested staff to create a new template to use beginning with FY25. The template will be brought to Council for approval.
- 6. Lastly, the Committee recommends that a staff committee (made up of staff liaisons to the B & C) review the template for B&C work plans revise/update, as appropriate, for review by the CRC before the next planning cycle.
