ARTIST STATEMENT

Hey there, I'm Peter Hazel. I'm the guy that can create something beautiful, safe, and lasting. I can turn virtually any design into a structure made of steel, concrete, ceramic tile, glass, LED lighting, or any combination of those ingredients. I'm passionate about creating art that invites the public to experience a sense of wonder and a sense of community. My art has been called joyful, inclusive, playful, and can be easily appreciated by every individual. I am inspired by nature, and I celebrate the natural world with larger-than-life sculptures of flora and fauna, without detracting from the beauty of the environment.

I'm excited to submit my interest in participating in the request for proposals for Lion Sculpture to Accompany Police Memorial Wall. My artistic practice explores art created to be appreciated by the entire community, appropriate for all ages, and I believe my work aligns perfectly with the focus on this project.

I've got plenty of practice shipping my work all over the country. My portfolio includes works that have been installed in a range of climates, to name a few of my diverse installation sites—the "Dancing Monarchs" series sold to four different buyers (one of which Jimmy Carter), withstanding climates from the mountains of California to the plains of Georgia; "Wanna Play?", a 14' tall horse and 4' tall dog tolerating the Vegas heat; "Octavius", a 25' wide climbable octopus permanently displayed in the mountains of Park City, Utah; and a 4' long "Dragonfly" mounted over the water in Virginia Lake in Reno, NV. My most recent installations, "Desert Tortoise", size 5ft tall, 10ft wide, 20ft long, commissioned by City of Indio, and "Resting Moose", size: 6' high, 4' width, 15' depth, commissioned by City of Laramie Wyoming.

I'm confident that I have the work ethic and time management skills necessary to fulfill the role for this job. I look forward to learning more about the opportunity and to discussing details with you and your team.

I believe that my artwork will enhance the chosen space, because my art always catches people's attention, always makes an impact and never goes unnoticed, it is inclusive and appropriate for all edges.



NOTE: For the numbered art #2, 4, 5, 6, 7, 10, 12, 13 and 15, it should be noted that these are made on a base made entirely of concrete and steel, and their coverage is made with handmade and painted mosaics, no cuts, the edges all high fire made the clay vitrify. High resistance to weather, water cannot penetrate these ceramics at all. Manufactured by this same art company.
