**20010-25 Denver Steels Phase II Road Improvement Project**

Presenter: Jeremy Lujan, Engineering Associate

The project aims to support the Council's strategic goals of Quality Governance, Operational Excellence, and Quality of Life.

Funding for projects has been outlined within the Roadway Budget and Utility Budget, including grant applications for the New Mexico Transportation Project Fund (TPF), which is administered by the New Mexico Department of Transportation (NMDOT) for local roadway projects. The County plans to submit its application by the end of May 2025 through the Northern Pueblo Rural Transportation Planning Organization (NPRTPO).

The roadway project involves the removal and replacement of the asphalt surface, with a focus on exploring recycling options for the existing roadway. This project will also include the installation of four inches of new asphalt pavement, the replacement of curbs, gutters, sidewalks, and drive pads, as well as improvements to ensure ADA compliance.

On the utility side, the project encompasses the replacement of the water distribution line, water services, and new water meter cans, with construction expected to commence in late Spring and anticipated completion by Spring/Summer 2026.

**20011-25 Los Alamos County Design & Construction Standards**

Update to the Public Works Design and Construction Standards. The Standards were re-organized and are now current with industry standards. The Design and Construction Standards will be utilized for all future improvements.
