19240-24 DWI Prevention Efforts- Kristine Coblenz, Rachel Mohr-Richards, & Sara Martinez

Councilor Kristine Coblenz told the council that the event Drugs, Sex, and Phones: What Families Need to Know About Phones was well attended and thanked everyone who promoted it. The event was planned for that evening for Elementary Families. She told the council that her and a few others participated in the Seven Challenges Training hosted by JJAB. She explained what the program focuses on and what messages it gives to those who participated. She co hosted, with Rachel, a Youth Mental Health First Aid at the United First Methodist Church. Kristine said she will be completing the QPR (Question, Persuade, Refer) program to become a trainer. She will also be in the Los Alamos High School Drivers Eds classes the coming weeks to talk about the dangers of Driving While Intoxicated.


Councilor Kristine Coblenz mentioned that community conversations at SALA was coming up the next week. She invited all to attend.
