1/16/2025

# Background

## 2015 to Present

## 2015

- Citizens Petition to ban single-use plastic bags and impose a \$0.10 fee on paper bags
- Surveys 80% opposed a ban and 72% opposed reducing distribution
- ESB recommended education over regulation

## 2019-2021

- Another petition to ban plastic bags, straws, and Styrofoam
- Council forms subcommittee
- FY21 Council actions focused on education campaigns, funding washable utensils for schools, and a feasibility study on food composting, but no plastic bag ban was implemented

## **Present**

 Council directs ESB to evaluate the aspects of a ban/fee



## **Fast Facts**

### What type of plastic?

 Most grocery bags are high density polyethylene or HDPE

### Lasting Impact

It takes 1,000 years for a plastic bag to degrade in the landfill. Rather than breaking down, they photo-degrade, becoming microplastics that absorb toxins and continue to pollute the environment

#### In New Mexico

- New Mexicans use at least 330 million single-use plastic bags a year
- 7 municipalities have bans/fees

### Recyclable?

- Yes, but not in curbside recycling
- About 80%-87% of bags produced are not recycled
- Used for an average of 14 minutes

### Plastic Bag Policies

- O 19 states ban single use plastics
- A study looking at US jurisdictions found that bans can lead to a 25% to 47% decrease in plastic bags as a share of tidal items collected by litter cleanups relative to areas without policies
- BUT can have unintended consequences - increase in trash bag purchased

## **Environmental Impacts of Plastic Bags**

#### **Greenhouse Gas Emissions**

- Organization for Economic Cooperation and Development
  - Plastics = 3.4% of global GHG emissions
  - Of the 3.4% of GHG emissions
    - 90% of the total emission from plastics are from novel plastics
- HDPE Plastic Bag
  - o 2.6 kgCO2e /kg Plastic
  - Number varies depending on the source
    - 1.5 to 6 kg of CO2e
- ~90% of the emissions come from the production stage
  - Reduce and reuse!

#### Decomposition

- Plastic Bags ~1,000 years
- Paper Bags months
- Organic Cotton several months

#### **Pollution**


- Most common item of waste found in rivers and oceans
- Can breakdown into microplastics
- Impact on animals birds and deer
  - Eat plastic
  - Can cause intestinal damage, sickness, death
- British Deer Society notes that plastic bags are a large problem with deer in the UK (and across the world!)



## Environmental impacts of different types of grocery bags



Number of times a given grocery bag type would have to be reused to have an environmental impact as low as a standard single-use plastic bag.


Note: Average across all indicators includes other metrics not shown here, including marine eutrophication, particulate matter, toxicity and others.



# **New Mexico**

## NM Single-Use Plastic Bag Ordinances

- Santa Fe County pop. 157,765
- Santa Fe City pop. 90,551
- City of Las Cruces pop. 116,998
- Bernalillo County pop. 671,747
- City of Carlsbad pop. 113,575
- Silver City pop. 9,399
- Town of Taos pop. 6,453



## New Mexico Plastic Bag Bags/Fees

- Santa Fe County pop. 157,765 (estimated estimated 24 million single-use plastic bags/ year)
  - Sept 2024: bans single use plastics, styrofoam, straws at all businesses and restaurants (no fee for paper bags)
  - Penalties from \$50 to \$300
- Santa Fe City pop. 90,551
  - April 2015: Ordinance bans single use plastic bags and includes a fee for paper bags
    - Exemptions: restaurants tourism concerns (mostly targets grocery stores)
    - Ordinance cites plastic bags as concerns for tourism, wildlife and aesthetics
  - o 10 cent fee for paper bags, 9 cents goes to the City and 1 cent is kept by the retailer
    - Fee goes to making the residential calendars for waste services
  - Average \$~250,000K
- City of Las Cruces pop. 116,998
  - Jan 2022: Ordinance bans single use plastic bags and includes a fee for paper bags (40% post consumer recycled)
    - Exemptions: restaurants and (internally) exempted mom and pop stores, SNAP/EBT, non-profits
  - 10 cent fee for paper bags, 5 cents goes to City (collected on a quarterly basis) and other 5 cents goes to corporation, ideally used for replacement of paper bags)
    - Fee goes to sustainability education and reusable bag purchases
  - Average ~\$190k yearly in revenue for the City

## New Mexico Proposed Statewide Ban - 2025

- While a statewide ban on plastic bags has not yet been enacted in NM, efforts have been made to pass legislation.
- 2025 House Bill 392, the Single-Use Plastic Bag Act, proposed a statewide ban on plastic bags and a \$0.10 fee per paper bag, with \$0.03 going to the store and the remainder going to the municipality or county for litter reduction and outreach.
- The fiscal impact report estimated a statewide plastic bag ban could save \$3.8 million per year for recycling processors due to the damage that plastic bags have on recycling materials recovery facilities.
- Suggested to us that if more counties adopt their own bans, a statewide ban will be more likely MENT C

# Los Alamos

# Los Alamos & White Rock Smith's Locations - at least 3.25 million bags used per year

## Los Alamos

#### 3.12 million bags/year

Weekly: 24 boxes X 2,500 bags = 60,000 bags/ week

#### **Bag Collection**

- Sent to a warehouse either in Phoenix, Las Vegas or Seattle
- Then recycled (?)

## White Rock

130,000 bags / year

#### **Previous Plastic Bag Fee Attempt**

- 10 cent fee for "non-single use" plastic bags - all going to Smiths
- Customers complaints that the WR had fee and LA did not
- The bag fee was dropped without any follow on

#### **Bag Collection**

- Sent to a warehouse either in Phoenix, Las Vegas or Seattle
- Then recycled (?)

- 2018 Kroger pledged to eliminate single use plastic bags in stores by 2025
  - No longer pursuing this

#### **Education Opportunities**

- Clean reusable bags
- No trash in the recycle drop offs
- Encourage reusing bags

#### 50/50 Preferences

 About ½ of customers use reusable bags and ½ use plastic bags

## **Recycling Contamination - Cost to County**

<sup>\*\*</sup>Contamination is general waste in recycling. It is not just plastic bags. Nationally, plastic bags are the largest source of contamination.



# What would a bag fee/ban look like in Los Alamos?

- Ban: Eliminate single use plastic bags in county
  - Possible exemptions
    - Medical use (dentist, etc.)
- Fee: Consumer would pay for a paper bag at the store
  - \$0.10 fee with \$0.01 going to business & \$0.09 going to County = estimated \$325,000 total, \$292,500 for LAC to use for sustainability and waste reduction efforts (possibly pay for contamination charges)
    - Other uses: bag reuse program, R&D, etc.
  - Possible exemptions
    - Medical use, SNAP & EBT, etc.
    - Small businesses (restaurants, thrift shops) & focus on large grocery stores and gas stations
- Administrative costs for both alternatives
  - THACHMEBusinesses are required to self report annually

# Lessons Learned from Santa Fe & Las Cruces

- Ensure fee/ordinance is legally enforceable
  - Recommend considering enforceable fine for businesses
- Ensure revenue from the fee can be used effectively
  - Recommend having a clear but broadly defined use for the revenue
- Initial start-up of collection has the potential to be a lot of work
  - Difficult to contact managers of businesses (particularly big box stores)

Ensure continued education of ordinance for residents

## **Engagement with community**

- Due to the history regarding the lack of community support and sensitive nature of this topic the ESB is seeking Council guidance before pursuing further engagement with businesses and community
- ESB requests guidance if council wants to keep pursuing bag ban and/or fee
  - Our How to engage?

## **Common Questions & Answers**

Q Are plastic bags recyclable?

Yes, BUT not in curbside recycling. Locally, both Smith locations collect them.



### **Common Questions & Answers**

Q Do plastic bag bans work?

Yes, they have shown a reduction in plastic waste. However, other studies show an increase in plastic garbage bag purchases.



### **Common Questions & Answers**

Q Are paper bags or canvas bags better for the environment?

Depends, BUT either way, bags need to be reused multiple times to offset the environmental impacts.
