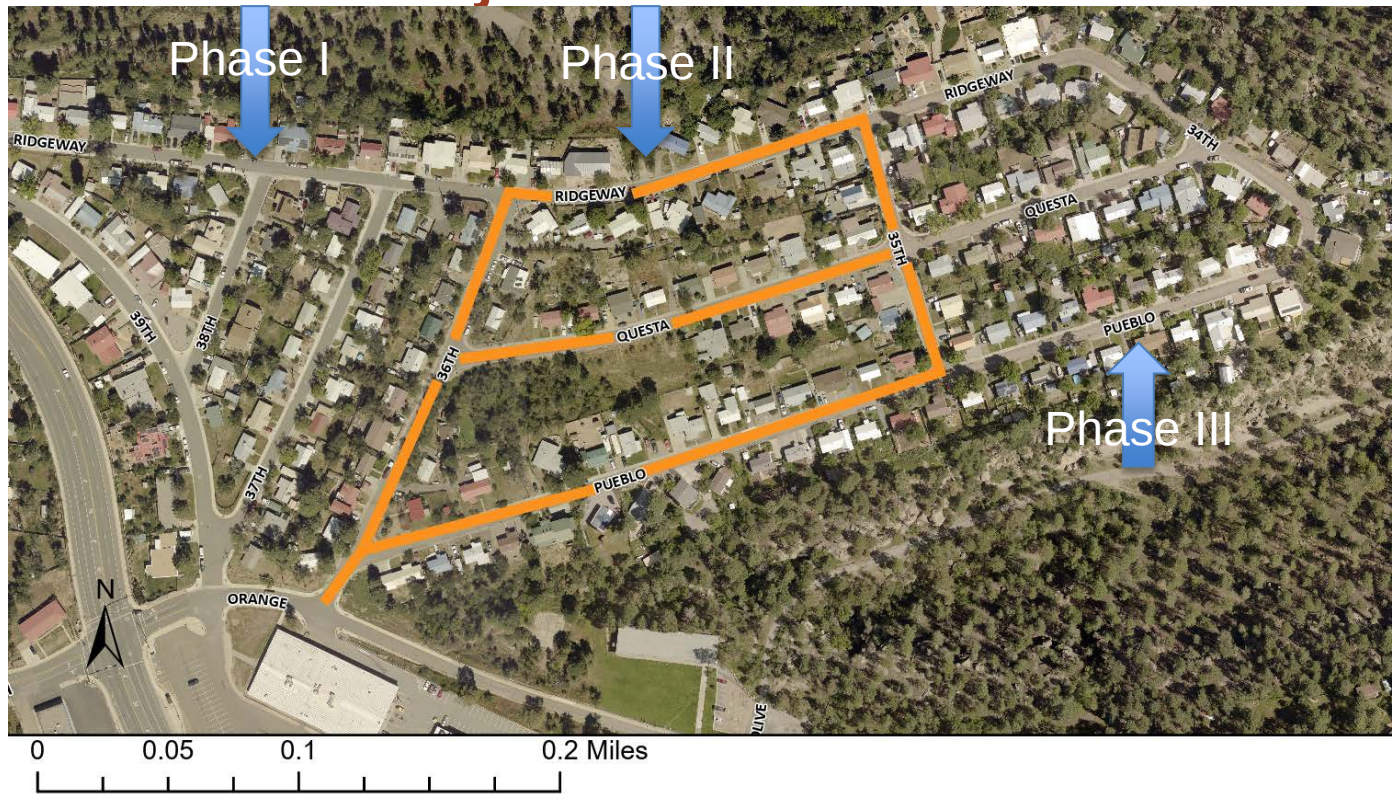

Project Location



Project Background

- County Identified Priority Project
 - Capital Improvement Program (CIP)
 - Fiscal Year (FY) 2025
 - Joint project Public Works and Department of Public Utilities
- Project Scope
 - Roadway Improvements
 - Project Selection Based on Pavement Condition Indices (PCI)
 - Scale from 1 (worst) to 100 (best) Project Area average PCI of 47
 - Utility Improvements
 - Joint Utility Project programmed in DPU 10-Year Plan

Project Funding

- Budget
 - Roadway Budget \$2,900,000 (CIP)
 - Utility Budget \$1,400,000
- Grant Applications (Roadway Only)
 - New Mexico Transportation Project Fund (TPF)
 - Administered by NMDOT for local entity roadway projects
 - County submittal by end of May 2024 through Northern Pueblo Rural Transportation Planning Organization (NPRTPO)

Project Summary : Roadway

Denver Steels Phase 2 Project Area includes:

36th Street – Pueblo Drive– Questa Drive– Ridgeway Drive – 35th Street

- Remove and replace the asphalt surface
 - Full Reconstruction
 - Install 4 inches of new asphalt pavement
- Targeted replacement of curb and gutter, valley gutters, sidewalk, drive pads, and ADA improvements.
- Design will be completed by Los Alamos County Staff
- Construction
 - Anticipated Bid Spring 2025
 - Completion Fall 2025



Project Summary : Utility

Denver Steels Phase 2 Project Area Utility Improvements

- Work will include replacement of water distribution line, water services and new water meter cans.
- Cost Estimate - \$1,400,000 (Utility)
- Design will be completed by Los Alamos County Staff
- Construction
 - Anticipated Bid Spring 2025
 - Completion Fall 2025



Public Services/Access Identified

- Los Alamos County Environmental Services – Trash Pickup
- Los Alamos Public Schools – Transportation School Bus Routes
- USPS/UPS/FedEx – Mail Delivery
- Access by Residents Denver Steels Neighborhood

Project Coordination

- Traffic Management
 - Vehicular, bicycle & pedestrian access dependent on sequence and phasing of construction
 - Evaluating temporary one-way scenarios or full closures of roadway sections for safety and expedited construction
 - Traffic control signs & devices to be utilized for traffic routing, detours, egress/ingress
- Work Hours: To be determined, typically 7:00 AM- 5:00 PM
 - County Noise Permit required for any work proposed from 9:00PM to 7:00AM
- Dust Control: Maintained daily with water truck

Public Information & Involvement

- T-Board & Public Meeting – May 2, 2024
 - Public Comment requested by May 9, 2024
- Before Start of Construction
 - Notices will be sent to the local media and Cone Zone
 - Flyers will be distributed residents within the project area informing of the start of construction and the initial traffic management plan
- Ongoing Notifications During Construction
 - Traffic conditions and changes will be distributed through a Traffic Conditions email distribution list and to the media through the Cone Zone
 - Residents directly impacted by temporary construction disruptions or changes will receive door hangers 48 hours in advance
