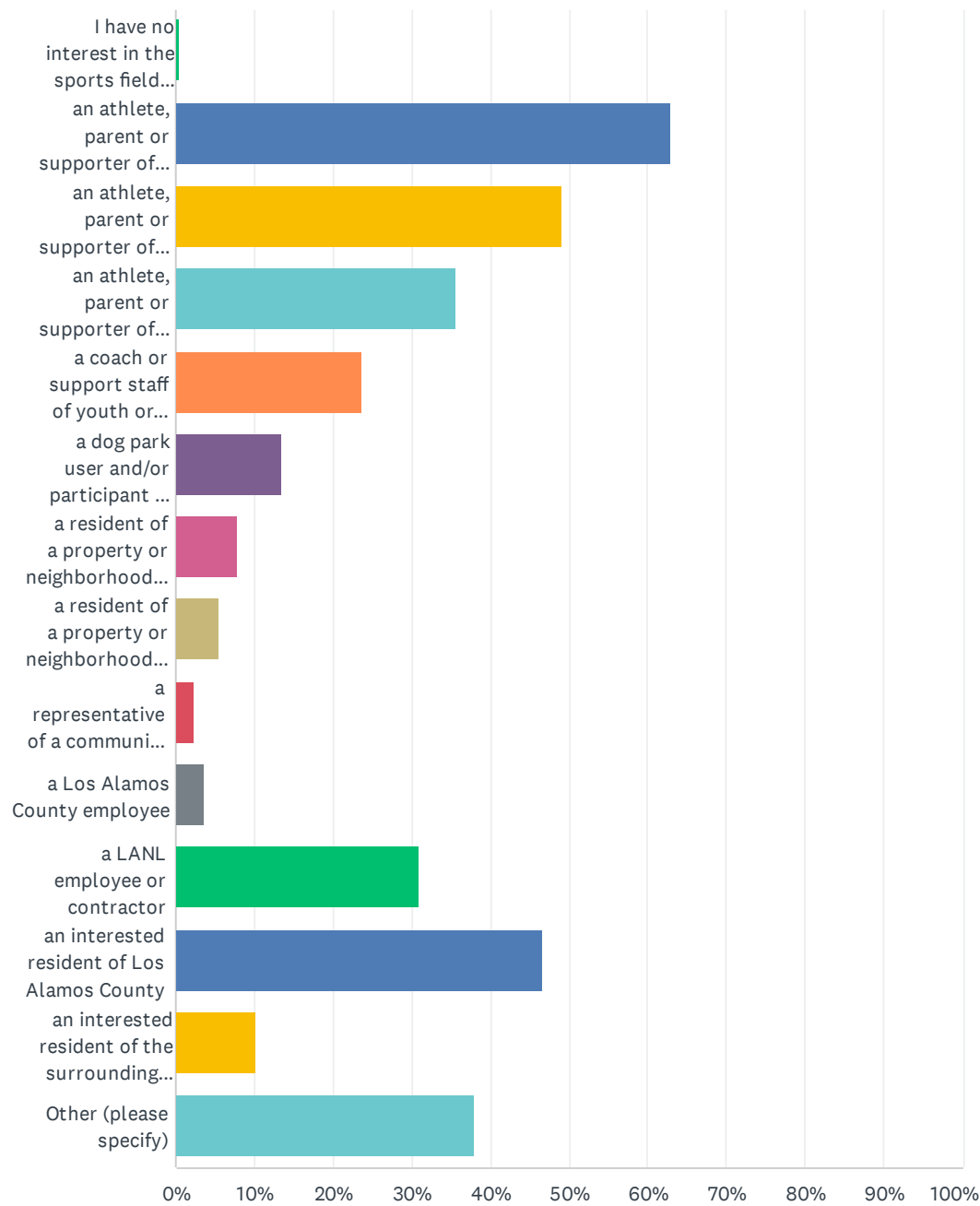

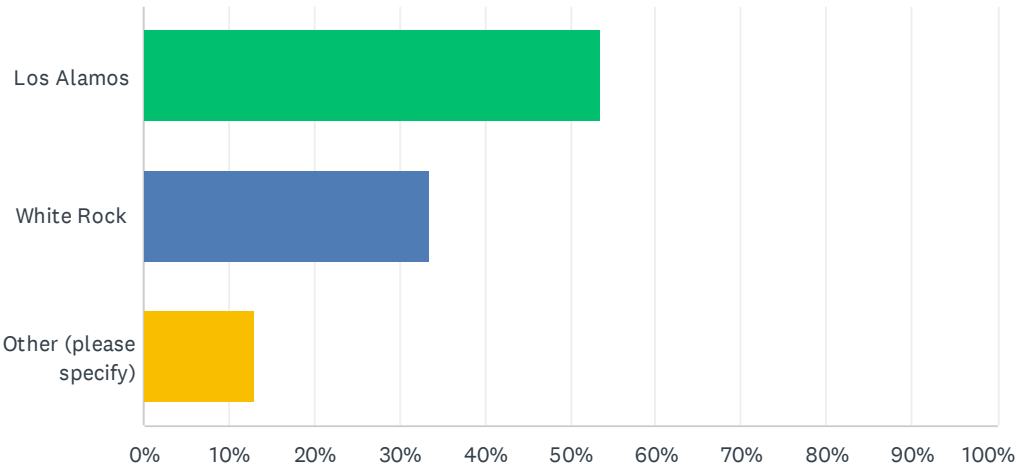

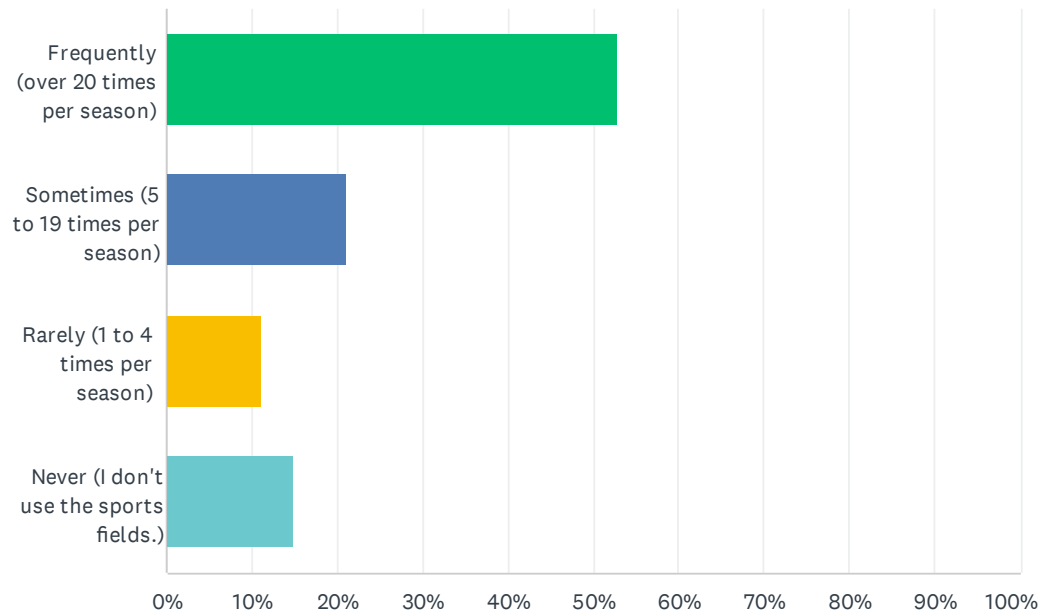

Q3 How often do you use the sports fields at North Mesa Recreation Area?

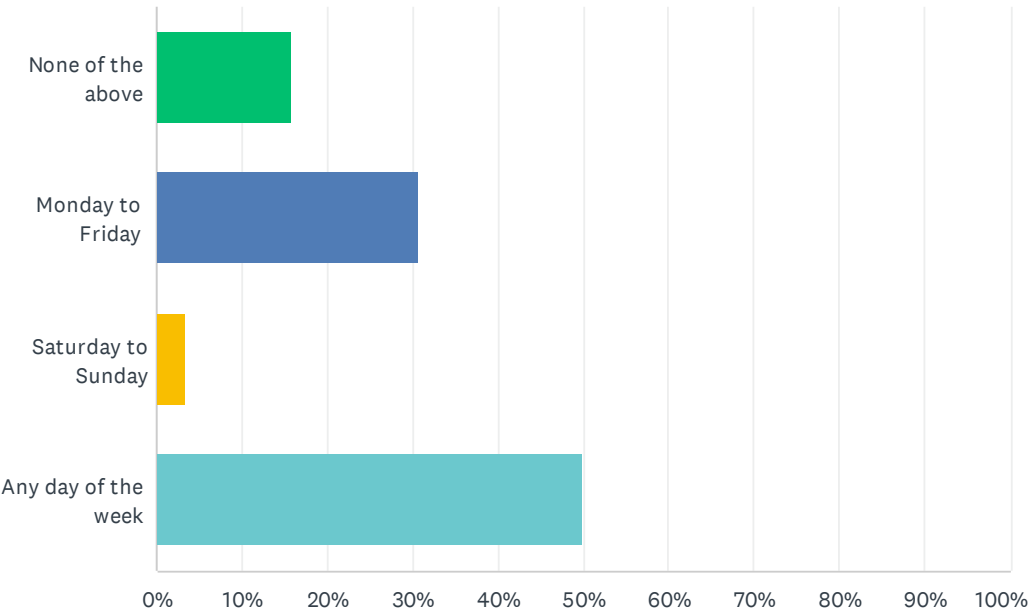

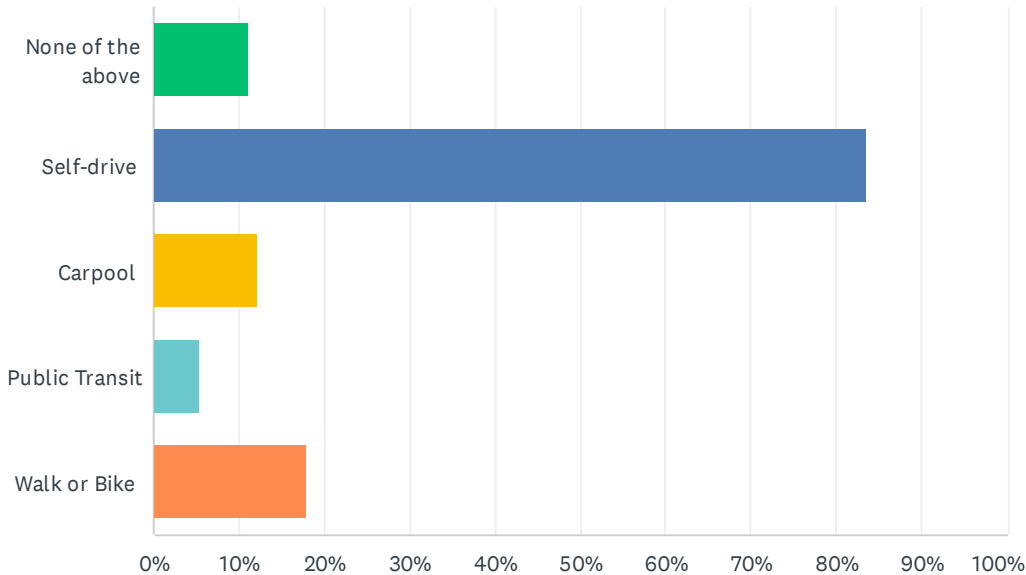

Q5 Which of the following best describes how you travel to the sports fields at North Mesa Recreation Area?

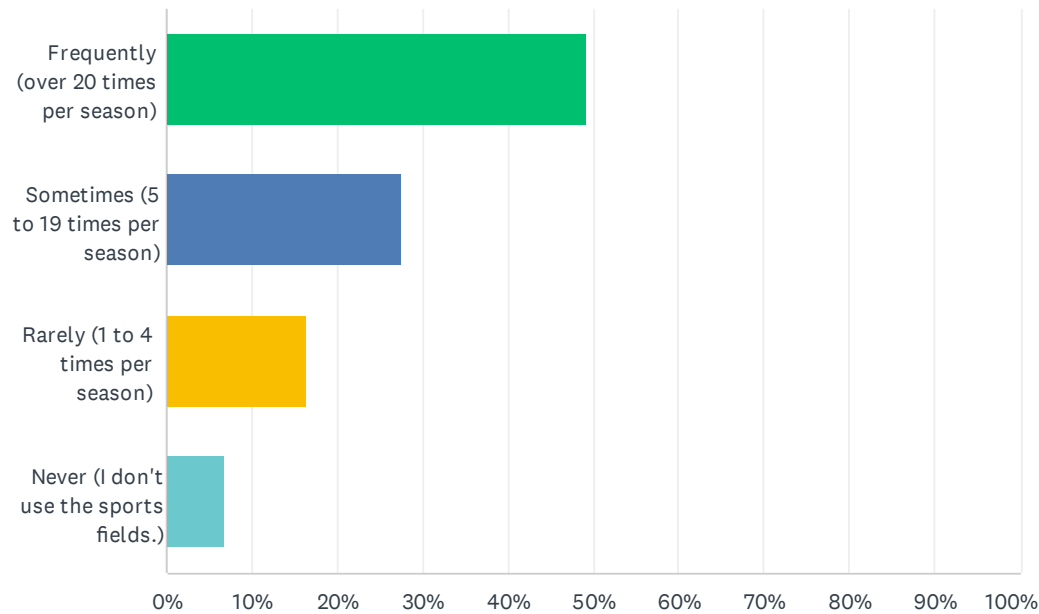

Q6 How often do you use the sports fields at Overlook Park?

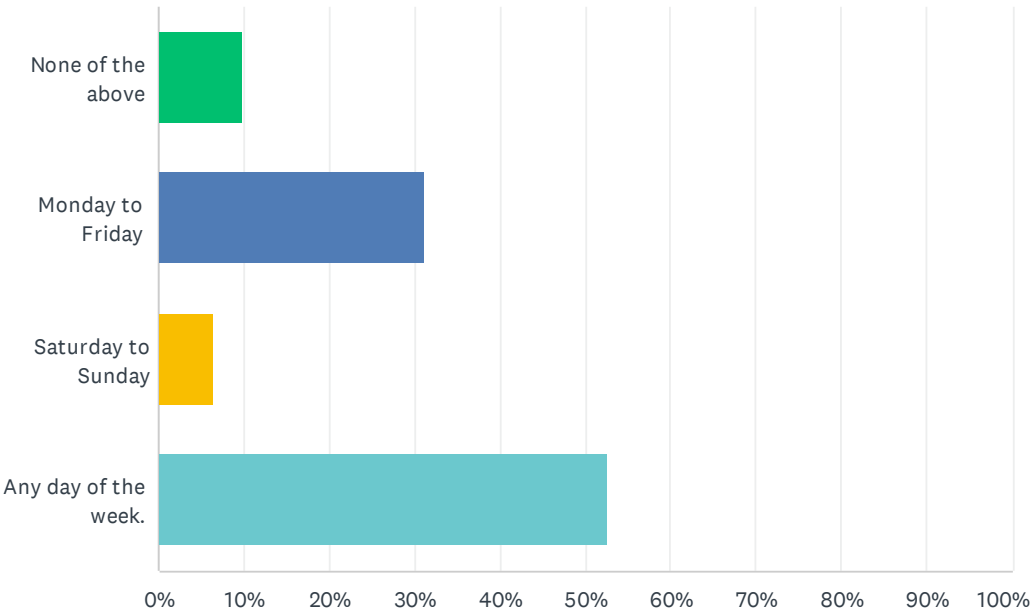

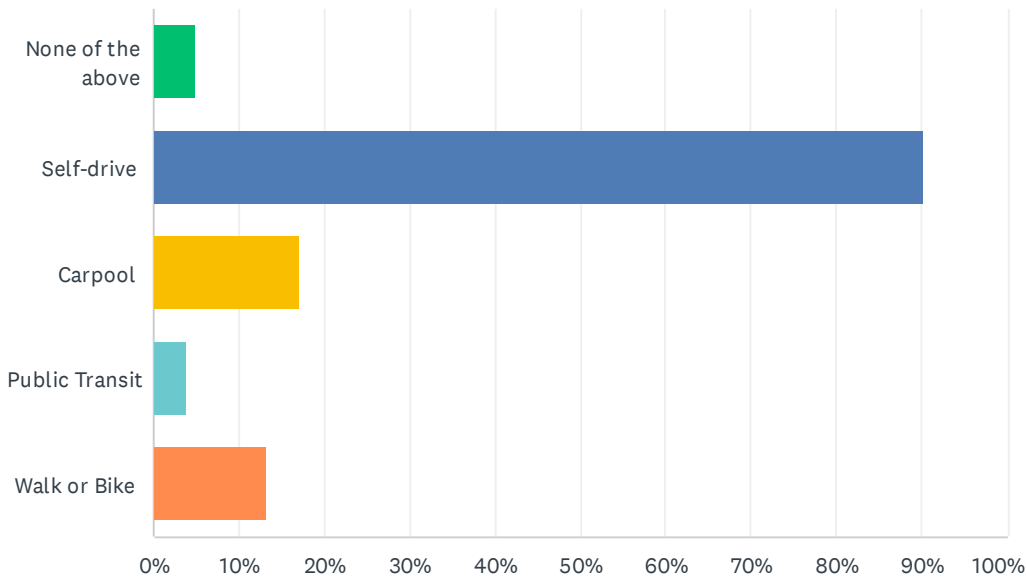

Q8 Which of the following best describes how you travel to Overlook Park?

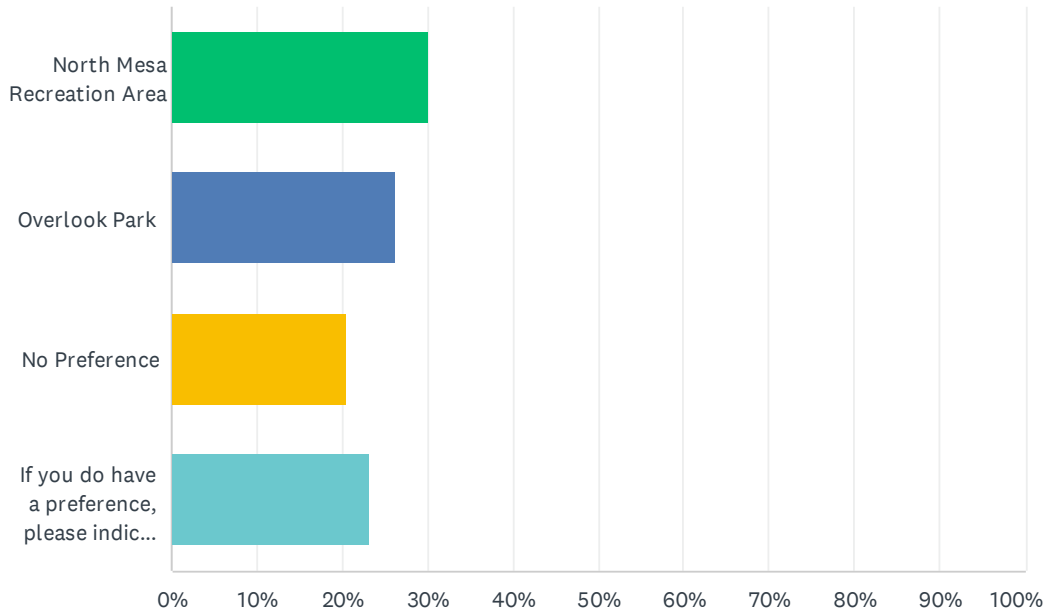

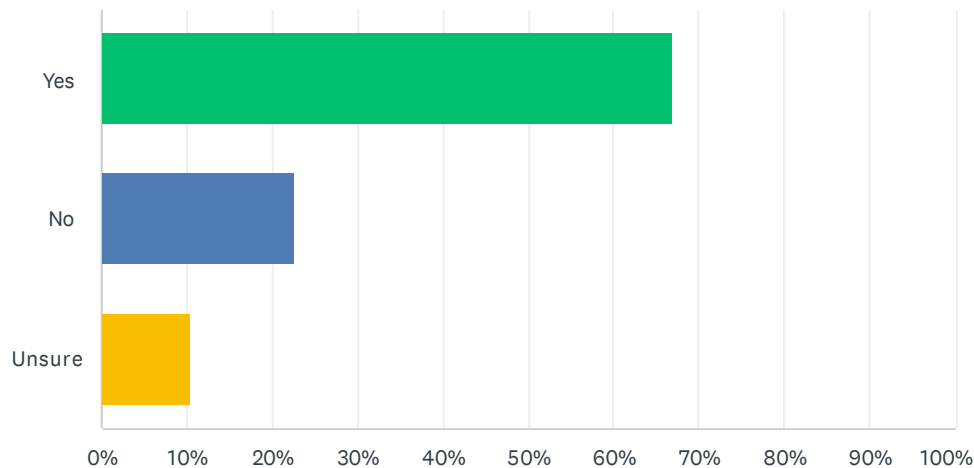

Athletes may inhale these particles, which could pose respiratory issues over time, especially if the particles contain toxic components. 6. Skin Abrasions and Infections: Sliding or falling on artificial turf often results in more severe abrasions compared to grass. These "turf burns" can create open wounds, making athletes more susceptible to infections if the fields are contaminated or not properly sanitized. A study by the Connecticut Department of Environmental Protection observed high zinc concentrations in artificial turf stormwater runoff as a particular concern for aquatic organisms. Zinc compounds are toxic and are known to kill fish by destroying gill tissues. Zinc also affects fish reproduction. The zinc levels are so high that they are negatively affecting the environment. Zinc is not the only negative byproduct of artificial turf fields. Advertisement Article continues below this ad Artificial turf has been found to contain as many as 16 per-and polyfluoroalkyl substances (PFAS) compounds. Exposure to PFAS is harmful to humans because it can cause changes in hormones, cholesterol, and liver enzyme levels. Numerous studies by the National Institutes of Health (NIH) have proven that these chemicals have been linked to various chronic diseases, including cancers and diabetes. According to the Journal of Exposure Science & Epidemiology, "Exposure to synthetic turf can negatively affect the immune system, responses to certain vaccines and cause neurological impairments." Because of this, when an athlete has a fall on synthetic turf, they are given specific instructions on how to clean out their wounds. There is concern about microplastics entering the human body through open cuts, and the Connecticut State Department of Public Health has dedicated a website to reducing PFAS exposure and impacts on the environment. PFAS doesn't just affect the water table, it also affects the entire environment. Artificial turf is not a living landscape and is not water-free. Natural grasses provide a habitat for local fauna. Synthetic turfs remove insect populations that animal life relies on in the food chain. It is much better to have a natural environment that can support healthy microbes, produce oxygen, and remove carbon. Stanford University water conservationists have raised the concern that water is needed to periodically clean the turf for sanitation purposes. This leads to multiple negative effects on the ecosystem. Because artificial turf can get extremely hot in direct sunlight, water is often used to cool the turf before it can be used comfortably. Some people think that by incorporating recycled plastic, a turf field can be more environmentally friendly. In fact, there was a movement led by the Environmental Protection Agency (EPA) to recycle scrap tires into synthetic turf. However, research conducted by the nonprofit Public Employees for Environmental Responsibility has found that forever chemicals and heavy metals can still be found in recycled synthetic blades and the cushion below. According to SportsField Management Online, a used and worn-out synthetic field cannot be sent to a recycling plant and turned into a new field. Only a small portion can be repurposed. In most cases, these toxic materials will end up in a landfill. Many politicians think synthetic turf is popular with the members in their community. This is not true because Connecticut, like other states, is proposing laws to protect our communities from these toxins. In a Jan. 25 news release, Connecticut Attorney General William Tong announced that his office is suing chemical manufacturers for contaminating our waters and natural resources with toxic forever chemicals. In the last legislative session, state legislators introduced CT SB00292 to get millions of dollars to keep PFAS out of our drinking water, and Gov. Ned Lamont signed the Senate bill to ban the use of forever chemicals. However, the new law lacks a waiver process for products and the legislature may come back next session to consider exemptions. Bacterial Growth: Unlike natural grass, artificial turf does not have natural antimicrobial properties. This means that harmful bacteria, such as *Staphylococcus aureus* (which can cause staph infections), may persist longer on artificial surfaces, especially when the field is not adequately maintained. 5. Respiratory Concerns: The breakdown of artificial turf fibers and infill can lead to small particles being released into the air. Athletes may inhale these particles, which could pose respiratory issues over time, especially if the particles contain toxic components. 6. Skin Abrasions and Infections: Sliding or falling on artificial turf often results in more severe abrasions compared to grass. These “turf burns” can create open wounds, making athletes more susceptible to infections if the fields are contaminated or not properly sanitized. While artificial turf provides benefits like year-round usability and lower water usage, these potential negative health impacts have prompted discussions around safer alternatives, better maintenance practices, and improvements in the materials used for artificial surfaces.
