Meeting Our Goals

Public safety under "Quality of Life" was front and center during June. Our Wildland Division Fire Chief Kelly Sterna issued important messages to the community on the significance of the "Ready, Set, Go!" program. These efforts were aimed at ensuring our residents were well-informed and ready to act in the event of wildfires. Staff also continues to work on the public-facing dashboards to present the status of our management action plans to realize the Council's strategic goals and priorities. The team plans to launch these soon.

News & Updates

Intergovernmental Affairs: Finalized planning for ScienceFest panels with DOE and others as well as a visit from EM-1, continued meetings with neighboring local government leaders, met with Governor Moquino from San Ildefonso to continue discussions on broadband and other issues, attended the NM Counties Annual Conference.

Sustainability: To take advantage of federal funding such as the Inflation Reduction Act, the County Sustainability Manager worked to secure five vendors to provide on-call Grant Writing Services. These services are available for all County staff to use. Staff also participated in a community workshop to provide feedback on the New Mexico Climate Adaptation and Resilience Plan. County Council allocated \$550k during the FY25 budget process for Initial EV Implementation. Coordination efforts for this project have begun, including identifying strategic locations, assessing infrastructure needs, and researching charging equipment. Staff also participated in the Los Alamos National Laboratory Climate Security Council – Harnessing Transformational Technologies Symposia Series and NM Recycle Coalition Annual Conference.

Broadband: Staff continue negotiations with a vendor to finalize a contract to bring to the Council for award consideration for construction and operation of the Community Broadband Network. Meetings between the County and San Ildefonso Pueblo staff are continuing, progressing towards a finalized agreement to construct the new 11-mile fiber line from White Rock to Pojoaque. The project total is \$6M, with the County contributing \$2M as a grant match. The Pueblo is awaiting news on possible award for this project for their application to the Connect New Mexico Fund grant from the state's broadband office. A parallel effort involves collaboration with the DPU's NM4 water transmission line replacement project. An executed construction agreement is anticipated soon between the County and the Pueblo, where the Pueblo will install conduit for the fiber optic line in the DPU's open trench while replacing the waterline. County staff is anticipating a long-term agreement with the Pueblo for use of a portion of the resulting new fiber line, to support the Community Broadband Network and other county needs.

Connecting with the Public

The council booth at the Farmers Market is open for business. Councilors and guests will be at the Farmers Market on the fourth Thursday of each month from May to October, except the month of August.

Wildlife Education Plan (mid-year update)

The Wildlife Education Plan launched on January 1, 2024, jointly with the New Mexico Department of Game & Fish, Pajarito Environmental & Education Center, and Los Alamos County's Communication & Public Relations Division. The Plan includes monthly interagency meetings to discuss issues, coordinate programming, and talk about educational messaging. Meetings have grown to include Bandelier National Monument, the Valles Caldera National Preserve, LANL Environmental staff, and LAPD Animal Control. Educational messaging is shared weekly via social media posts, articles in the County Line and traditional news media sources, displayed on the county website and the televisions in the Municipal Building. Ads are also included in the monthly utility bill inserts and seasonal activity guides.

After six months from the Plan kick-off, organizations have confirmed it has resulted in positive outcomes. NMDFG reports a significant increase in communications from citizens in the community responding positively to the educational information provided and asking questions. The increase in communication with the public has helped NMDGF identify wildlife issues, determine problem areas in the community, and log incidents. NMDFG maintains that active feeding is the largest problem in Los Alamos County currently and leads to traffic accidents, predator encounters, diseased deer, and injured animals in the vicinity of the feeding locations.

Due to the steps taken at the beginning of 2024 to proactively address wildlife issues in Los Alamos County, the data from 2023 cannot be directly compared to the data for 2024. Three main actions are impacting the numbers for 2024: 1) The data for 2024 is not a full year and we are still collecting data. Further, how incidents are logged has also changed, providing a clearer view of wildlife impacts within the community; 2) NMDGF officer was designated to Los Alamos County at the beginning of the year, providing the ability to respond to and investigate issues in a timely manner; 3) Educational messaging is providing increased awareness and attention by the public to wildlife issues.

The chart below shows reported numbers for 2023 and the first six months of 2024.



Munis

In June, we prepared Munis for an upgrade to version 2024.1 in mid to late September, coordinating with the IM Applications team. In July, IM will prepare the TRAIN environment for testing. We've also worked with Tyler on the Transparency portal for a July public release, ensuring it's user-friendly and minimizes data misinterpretation. Additionally, we're evaluating secure, user-friendly payment options for citizens and contractors, simplifying county requirements. Lastly, we've resolved an issue with some employees not receiving Pay Advices via email. While few were affected, the resolution is promising and will be monitored in upcoming pay periods.

Information Management Applications

Mail Server Migration: Successfully updated critical functioning business applications to use the new mail server.

Security Upgrades:

- **Payroll and Clerks:** Discussed adding multi-factor authentication for the Tyler Time & Attendance system. Testing in a non-production environment before seeking approval.
- **Public Safety:** Evaluated multi-factor authentication for mobile devices with Absolute Secure Access VPN software. Seeking approval after review.


Procurement Operations

Looking Ahead

20th Street Development Solicitation: County staff and RBMM development are working to finalize the negotiations related to the Sale, Purchase, and Development Agreement (SPDA). County staff will provide an update to the Council at an upcoming closed session in July for discussion. [Goals: Downtown Revitalization, Local Business, Housing.]

Affordable Housing Plan Update: County staff and the consultant, Sites-SW, presented the final draft of the Plan to Council on June 25, 2024. Based on feedback, staff and the consultant are preparing the final document for adoption at the July 30, 2024, regular session. At this same meeting the associated ordinance will be introduced on first reading. [Goals: Housing.]

North Mesa Update: Wilson and Company have been selected to conduct a baseline analysis for new residential development on North Mesa. The analysis of traffic and utilities impacts will determine the level of necessary infrastructure improvements to support development and provide a preliminary cost estimate for needed work. In addition, a boundary survey with title research and a Phase I Environmental Site Assessment will be conducted. Staff will present an update to the Los Alamos Public Schools Board in August 2024. [Goals: Housing, Intergovernmental Relations.]

A-8-A "South Mesa": Staff have completed the draft solicitation for the lease or sale of the County owned 21.7-acre parcel. The land is currently zoned mixed-use (MU) which allows a variety of residential unit types at moderate densities. Staff seeks a development partner who can deliver a project with moderate residential densities comprised of apartments or condominiums in addition to low maintenance moderate-density rowhomes, patio-style, or similar smaller lot residential units. Units are encouraged to be a mix of rental and for-sale units. Special consideration will be given to proposals that include mixed residential densities with a managed affordable housing component targeted to households between 60% and 120% Area Median Income.

Facebook: In addition to regular printed media advertisements, EDD is utilizing the Community Development Department's Facebook page to promote local business, chamber, and economic development activities. As of June 30,2024, we have 741 followers, reached 4,626 people this month, and had 319 post engagements this month. *[Goals: Communications and Engagement]*

The Bottom Line: CDD-EDD published its June e-newsletter specifically serving the local business community. The June edition of The Bottom Line included information about the Economic Development Program Manager Janice Krish. It is in our EDD goals to use the newsletter to share resources and opportunities with the local business community. Planning staff reviewed and acted on 39 Building permits, 7 subsequent Planning inspections, and 10 Business License applications.

Meeting Our Goals

The Community Development Planning Division has been focused on the Chapter 16 cleanup & updates and Short-Term Rental Program. Division Staff continue to maintain a high level of customer service with ongoing current planning cases.

News & Updates

Planning Division staff are keeping a close watch on some case law regarding Short Term Rentals that is developing in our neighboring Santa Fe County. Staff will review the progress and outcome and use this as a learning experience moving forward with finalizing an STR Ordinance at the end of 2024.

Planning Division staff began work on various Code Clean-up items; the first draft of proposed edits was reviewed for input from P&Z Commission on January 10th, 2024, and an Update to the Council was presented on 19th. Staff are currently working on a final draft text amendment and planning on scheduling a review by Planning & Zoning Commission for Recommendations to Council in late August early September.

Planning Division staff was given direction by County Council to evaluate possibly revising the boundaries of Downtown Los Alamos Master Plan and propose a subsequent Zone Map change. Staff are currently working scheduling a town hall and neighborhood notification meeting in August prior to scheduling a review by Planning & Zoning Commission for Recommendations to Council in September.

Planning Division staff is working on Downtown Los Alamos (DT-LA) East Metropolitan Redevelopment Area Plan with MainStreet Program. County Council, by resolution, approved designation of the boundaries of the MRA Plan on May 7th, 2024, and hosted a Town Hall on June 27th at Fuller Lodge. The final MRA Plan is scheduled to be presented to Council in late summer.

The Planning & Zoning Commission, during their regular meeting in June, acted on a Zone Map Amendment application. Planning Staff conducted five pre-application meetings in June.

The Historic Preservation Advisory Board had their monthly meeting on June 5th and welcomed new board members and elected board chair and vice chair. The HPAB chair gave an update to Council in June.

Operational Excellence

June kicked off with an active final day of Early Voting at both our Municipal Building and White Rock Town Hall sites. The evening's close-out is more complicated for these dates as the presiding judges create final vote reports for each tabulator and secure them for transport back to our warehouse.

Election Day is long for everyone involved, starting at 6:00 a.m. and continuing late into the night until the final unofficial results are published. Even with few contested races, our process remains the same: We carefully pull data from each tabulator and combine it into results reports. Congratulations to all candidates who advance to the 2024 General Election!

While Election Day is busy, the day following is physically demanding. Clerk's office staff met our software vendors and moving company at each site to ensure machines were carefully transported and materials were returned to our warehouse and storage facility.

The Board of Registration convened on June 12 to complete a canvass of the County's election results. As is typical for our well-oiled machine's operations, the Board certified the 2024 Primary results quickly and cleanly.

Intergovernmental Relations



Election month does not mean that other operations cease; Clerk Naomi Maestas, attended the NMC Board of Directors meeting, which included the election of an incoming Vice-President of the Board. She, Chief Deputy Clerk Tessa Jo Mascareñas, and Senior Deputy Clerk Danielle Miera attended the New Mexico

Counties' (NMC) annual conference, followed by the New Mexico Clerk Affiliate meeting. Clerk Maestas represented the County in a strong fashion by presenting to the Affiliate about the success of our 2024 Primary Election operations and proposed legislation that may affect Clerks' Offices.

Education

With new legislation come new training opportunities. Before Election Day, our dedicated Presiding Judges met to discuss new procedures and ensure they were prepared to run each of our five Voting Sites and the Absentee Board.

During June, our Staff became the trainers, with three new Student Clerks joining our team. Jasmine Maez is a participant in the Summer Intern program and focused on learning basic office procedures while she gains an overview of the operations of a County Clerk's office. Both Trinity Lucero and Andrea Alarid are permanent student employees, and we have already discovered that they are rapid learners. What will they do? Everything except for the work that requires an Oath of Office.

Project Updates

One more step left to go: the Clerk's Office microfiche documents are all in digital format and uploaded to a County drive, ready to be imported into Tyler Recorder. Once these are updated, records will be accessible by book, page, and document number.

Meeting Our Goals

The library continues to meet the County's quality of life goal by providing programming and services for all ages.

Golf Course Improvement Project

The golf course renovation project continues to see solid progress through June. A few days of progress were lost due to rain, and subsequent course drainage, but Mid-America worked through the last two weekends in June to regain their schedule. There are still a few holes where the tee box complexes need completed, as well as some sand bunkers. Except for a few small sections on the front 9, the concrete golf cart paths are complete. Multiple tee box complexes have been seeded, and hydro-mulched, and grass is growing in these areas. The two new green surrounds have been sodded in, and the greens are now ready for seeding and the grow-in period. Some work has been done on the back 9 on holes 16, 17, and 18. Full transition to the back 9 will begin in the first or second week in July. Mid-America will focus on holes 16 through 18, reaching full completion on these holes, before moving to the north of Diamond Drive to work on holes 10 through 15.

The Public Works Administration is responsible for providing coordination to all divisions of the Department through leadership and support to ensure that all duties and functions are carried out effectively and efficiently.

Connecting with the Public

Transportation Board held a meeting on May 2, 2024. A presentation was provided on the Denver Steels Phase II Improvements Project and a presentation was provided on the Initial Evaluation of Potential Transit Center Sites in Downtown Los Alamos and White Rock. The public was invited to provide comments on this project.

PW: Airport

Meeting Our Goals

The Airport Division continues to be successful with meeting Council's strategic goals in the areas of Fiscal Stewardship, Effective, Efficient, and Reliable Services, and Infrastructure Asset Management through the administration of grant and county funds for airport operations and capital improvements. The county continues to seek funding opportunities through partnership and collaboration with the Federal Aviation Administration and New Mexico Department of Transportation Aviation Division to implement improvements in accordance with the Airport Master Plan.

News & Updates

Recent rains have brought on a lot of weed growth around the airfield but crews with the Traffic & Streets Division have performed an amazing job with mowing operations. Additional groundskeeping around the airport terminal building and parking lot is scheduled to begin the second week of July.

Construction of the Airport Fuel Farm continues. With the relocation of utilities and the installation of storm drains, secondary containment system and fuel system foundation, and site work is nearly complete. Fuel tank delivery and installation is scheduled for August barring any manufacturing or shipping delays. The project is currently scheduled for final completion in late October. The project is funded through a New Mexico Department of Transportation (NMDOT) aviation grant.

The 90% design drawings for constructing of a 8-unit t-hangar were submitted to the County by the design team in June. Final comments are being addressed by the design team to finalize plans for bidding. This project is anticipated to go out to bid late summer or early fall and is also funded through a NMDOT Aviation grant.

Recruitment of a new Airport Manager position is ongoing and in process.

The airport continues to welcome visitors this summer from various parts of the country visiting Los Alamos via the airport.

Meeting Our Goals

The Capital Projects and Facilities Division (CPF) oversees project planning, design, and construction in support of the County's Capital Improvement Projects for all divisions in the County along with renovation, renewal, and maintenance of 47 County buildings and facilities.

The Division supports operations County-wide and involves coordination and collaboration with various departments, contractors, vendors, and stakeholders to ensure projects and maintenance activities are completed efficiently and within budget to meet the strategic goals of Operational Excellence and Improvement of Quality of Life for County residents and visitors.

The Division provides updates and information about ongoing projects, budgets, timelines, and potential disruptions to the public. Currently, the Division is actively working on 82 projects and assignments including preparation for projects programmed in Fiscal Year 2025.

News & Updates

CPF project managers are working on 22 active projects. The activities in these projects span from planning, procurement, and design to construction. The Mesa Public Library water heater project was completed in June, two others are nearing completion or in the closeout phase, four are currently under construction, two more are about to kick-off construction. The rest are in the planning, procurement or design stages. Construction continues for the Golf Course Improvements, the High Netting Project, the Airport Fuel Farm Project, and the White Rock Visitor Center.

The Facilities crews continue maintenance and repair work county-wide. Most of this work supports the essential services of county buildings and goes on behind walls on spaces such as mechanical and electrical rooms, roofs, and attics. Other work improves the functionality and safety of the spaces that are accessible and serve the public in a more direct manner. Highlights of this work include cleaning up a broken mirror and installing hardware to secure mirrors to the walls at the Betty Ehart Senior Center, completion of the repairs to the north mesa bus stop that serves the middle school. The Facilities crews also performed work at the Cottonwood On The Greens kitchen to replace a leaking commercial gas flex. Facilities also restored normal operations to most of the county HVAC systems after a power fluctuation brought them offline.

During the month of June 2024, Facilities crews completed 133 work orders out of 140 active work orders. The table below lists these work orders by category and numbers completed.

Meeting Our Goals

Consistent with the Council strategic priority to invest in infrastructure, improve mobility, and support economic vitality, the Engineering Division continues to actively manage multiple design and construction projects, providing county-wide support for existing infrastructure, and providing engineering reviews and inspections of new developments.

News & Updates

Bids were received for the Bathtub Row project. Recommendation for award is anticipated in July pending successful evaluation of bids. Once awarded, this project will begin in 2024 and is anticipated for completion in Summer 2025.

TLC Plumbing and Utility began construction of the DP Road Phase II project installing new utility infrastructure.

The Rose Street project began paving operations in June. The final paving surface will be complete in early July.

The Urban Trail project is progressing with work being performed along Canyon Road for new retaining walls. Installation of the Permatrak boardwalk is underway.

Staff has completed a Mid-Block Crossing Policy which was presented to the Transportation Board in June. This policy is based off of nationwide standards, studies, and similar policies and will assist the County in reviewing requests for pedestrian crossings at mid-block locations. The Public Works Department currently receives approximately 5 to 10 requests for new crossings per year.

Connecting with the Public

A public meeting was held in June for the Trinity Drive Safety project presenting alternatives from Oppenheimer Drive to Knecht Street. Following evaluation of public comments additional presentations to the Transportation Board and/or County Council are anticipated.

Other projects such as Bathtub Row, Urban Trail, Rose Street, Loma Linda, DP Road, and the Transit Study have required outreach to the public, residents, businesses, Los Alamos Public Schools, and LANL/DOE. This coordination is critical to successful project execution while minimizing negative impacts.

County staff have been involved with coordination of development construction activities across the County to ensure that contractors are providing adequate access and advanced notifications for activities that affect the community

Looking Ahead

Engineering staff is currently managing multiple active construction projects. New projects are pending successful bidding and award. Additional projects are in study and/or design development in support of pavement rehabilitation, maintenance, and safety improvements.

Staff continue to be involved with multiple development inspections, permit reviews, and design reviews. Some recent project reviews include the Women's Dormitory Building, Buena Caza (Mirador Mix-Use development) in White Rock, Arbolada Subdivision on North Mesa, Arkansas Townhomes, Hills Apartments/35th Street Realignment project, Cañada Bonita, Century Bank, Sherwood Rounds off Longview Drive, and the development at Meri Mac.

The scope of work includes construction of a 10-ft wide concrete multi-use trail from Trinity Drive northwards to Canyon Road and ending near the Aquatic Center. Construction will be completed in late 2024.
DP Road Phase II	PW	The project was awarded to TLC Plumbing and Utility on March 26. The current project scope includes new sewer and gas lines, electric conduit, storm drain, concrete replacement, and full reconstruction of roadway. Installation of new utilities began in June with construction to be complete in late 2024.
Loma Linda Road Improvements	PW	Construction began in August 2023 with paving complete in April 2024. Construction was fully completed in June 2024.
Rose Street	PW	The project was awarded to TLC Plumbing and Utility in November 2023. Construction began the first week of March 2024. The scope of work for this project involves full reconstruction of Rose Street from Central to Peach. This is a joint project with the Department of Public Utilities and includes full road reconstruction along with utility upgrades. Construction will be completed in late 2024.

Following public feedback, additional presentations to the Transportation Board and Council are anticipated. This project is the result of a 2016 road safety audit and has been awarded grant funding from the Federal Highway Safety Improvement Program (HSIP) by NMDOT. Construction is anticipated in 2025.
Finch Street	PW	This project design was completed by an engineering on-call. The project is anticipated to be advertised for bids later in the year with construction starting in 2025. Approval to enter into an agreement with the Los Alamos Medical Center for the transfer of land for the construction of the Finch Street project was approved by Council in August 2023.

Canyon Rim Trail Phase III	PW	This final project design and ROW acquisitions are underway. Design is being completed by an engineering on-call. The project is anticipated to be advertised for bids in early 2025.
County-Wide Crack Seal Project	PW	The County was awarded Local Government Road Funds for crack seal pavement maintenance projects in the Western Area. The County is anticipating the use of a Statewide Price Agreement to perform this work.
Bathtub Row-Peach Nectar	PW	Staff completed the design of the project which was advertised in May with bids received in June. Evaluation of bids is underway. This is a joint project with the Department of Public Utilities and includes full road reconstruction along with utility upgrades. Meeting Our Goals

Environmental Services continues to look at other locations and technologies for composting systems. SCS Engineers provided initial site plans for an Aerated Static Pile System and an In-Vessel System to be operated at the Eco Station. The program is estimated to divert 4,500 tons of food and yard trimming materials from the landfill and transform it into valuable compost material. At the February 6, 2024, meeting the County Council approved the staff recommendation to implement food waste composting at the Eco Station using Aerated Static Piles. The next step is to work with DOE to amend the lease for the Eco Station so that the facility can be operated on the property.

Operation Save the Bears - 260 dumpsters have been delivered to the business community and 1,000 roll carts have been delivered to residential customers. On December 12, 2023, Deputy Public Works Director Eric Martinez and Environmental Services Manager Armando Gabaldon gave a presentation to Council on the program. The Council directed that the program be rolled out on a request only basis and that Environmental Services will return with an update within the next 12 months. Environmental Services has received proposals from various vendors regarding bear resistant roll carts and has purchased a small number of carts to test in the field and testing is now underway.

News & Updates

On February 3, 2023, Environmental Services transitioned from a weekly Household Hazardous Waste (HHW) drop off schedule to a monthly schedule. Los Alamos County's contractor ACT Enviro had trained personnel on site to characterize and properly sort the material from 116 residents that was then transported to the proper disposal facilities. The next event will be held on Friday, July 12, 2024.

Yard trimming collection for calendar 2024 started on Monday, March 25, and to ~372 tons of yard waste have been collected. The material collected will be mulched and utilized in the bio solid composting for wastewater, sent to the Caja Del Rio Landfill for erosion control, or used by residents for landscaping. Residents are allowed one cart per household. Register for a Yard Trimming Cart online at www.losalamosnm.us/gogreen.

Connecting with the Public

Recycle Coach app is a great asset for residents to check collection schedules and use the 'What Goes Where' search tool for recycling questions. The main customer interactions are collection day reminders and real time notifications.

Looking Ahead

Environmental Services Staff will be at the Farmers Market on July 11th with the Sustainability Manager and County Councilors to talk to the public about sustainability and recycling in Los Alamos County.

The Eco Station will be closed on Wednesday, July 17, 2024 for a staff professional development day. All Wednesday routes will be collected on Tuesday, July 16th.

Service Period: June 2024




June Diversion Rate: 30%

The diversion rate is the percent of recyclable and compostable material diverted from the landfill.









Meeting Our Goals

Traffic and Streets Division met County goals by contracting with Dismuke Construction to crack seal the North Community, Quemazon Subdivision, and Diamond Drive. This project will continue through July.

News & Updates

Traffic Electricians:

- Removed and replaced light fixtures at various locations in the Los Alamos area.
- Repaired and replaced damaged streetlight feeds and conduit on Sage Loop and Ridgeway.
- Reinstalled one Ballard Light knockdown on North Mesa trail.
- Performed yearly school flasher maintenance for Chamisa Elementary and Pinon Elementary Schools.
- Removed and installed a new base for a damaged windsock pole, made repairs to the damaged windsock and reinstalled it on the new base at the airport.
- Assisted the County Arborist at the golf course by trimming ten trees and removing branches.
- Removed old school flasher conductors and conduit on the corner of Barranca and Loma Del Escolar.

Signs and Markings Crew:

- Have been manufacturing signs and decals. These include bike lane signs, object markers for the ski hill, new route signs for Atomic City Transit and knock downs as well as some window decals for PCS Building 1 and stickers for the Eco Station trash trucks.
- Painted the island tips on S.R. 4, Diamond Dr, North Road, Quemazon, at Sycamore St. and on the new section of asphalt work at Central Ave. and Canyon Road.

Street Crews:

- Patched the intersection of Oppenheimer Drive and Trinity Drive and patched asphalt on Yucca Street, 48th and 46th Streets in preparation for the crack seal project.
- Repaired potholes countywide and performed vegetation control.
- Repaired the rear parking lot at the animal shelter with millings and relocated their shed.
- Replaced sidewalks and curbs on Manhattan Loop, Rim Road and Myrtle Street.
- Worked on clearing a drainage area off Sycamore Street. They removed the brush, excavated and made a trail, and cleaned the outlet allowing drainage to flow. They also extended the culvert 20 feet.
- Moved a large pile of dirt (300-400 yards) on DP road for a contractor working in the
- Poured 2 yards of concrete around valves in Quemazon.

Administrative Staff processed permits for events and projects including driveway apron installations. Twenty-three permits have been processed and four permits have been extended.



Looking Ahead

Traffic and Streets will be working to resolve pothole and asphalt repairs, concrete repairs, vegetation control, sign fabrication, traffic signal maintenance, street lighting replacement and repairs and maintenance at the Airport.

Administrative staff will continue to work with the public and contractors to process permits for special events and work to be performed within the County right of way.

Atomic City Transit is working on a Zero Emission Transition Plan. The Plan will identify any current and future resources needed for a successful implementation of incorporating battery electric or low emission vehicle technologies in Los Alamos. Also, an essential component of this plan is its compliance with the Federal Transit Administration's requirements for a Zero-Emission Fleet Transition Plan.

News & Updates

The Purchase of two electric buses and charging stations with a new vendor continue. As negotiations are completed and the order gets placed, we can expect the new buses in about 24 months from the date of order. With the increase interest of electric powered buses throughout the United States and limited manufactures, work production has been delayed.






