Each applicant will be notified if they are appointed or not.

Presented accomplishments to County Council during the annual update from the Health Council. Leading the Health Council in executing items on the Action Plan, including community outreach and education and suicide prevention initiatives. Publishing monthly health articles written by various Council Members. Working with Social Services liaison to elicit speakers and facilitate monthly Health Council meetings. Collaborate with local, regional, and state health organizations to further critical health care initiatives. Led a CHC Working Group and prepared the report to provide recommendations for a multi-faceted Community Health Action Center. This was an 8 month effort and was approved by the Health Council in a 9-0 vote at the September meeting. These recommendations have gone forward at the County government level.
