Hi Chelsea.

I reviewed the input from Earthday. I haven't gone into PEEC to see if there have been additional reposes on the sculptures.

On Earth day, we had 105 comment cards. Most indicated the name of the sculpture that they favored. Five cards indicated two sculpture choices and one card say we should get all three.

If you include all cards including those with 2 choices, we had 108 votes. The talley of these comments indicates:

Raven Dialog (Bear) - 57 votes. 52.8 % Songbird pillar - 30 votes. 27.8 % Migrating Butterflies - 21 votes. 19.4 %

Those selecting Songbirds did not distinguish between the smaller or large pillars.

The size of the sample of choices from the Earth day celebration is remarkably similar to the sample size from the first data you sent us. The sculpture choices are very similar as well, with the Bear consistently receiving more than 50%, with Songbirds (summing all songbird votes from your survey) as the next choice and migrating butterflies as the least frequently selected. I wondered if there would be a difference, as there were a lot of families with small children voting at the live event. The children seemed vocal in support of the "Bear", Raven Dialog.

I found the comments on your survey informatively as well. One comment mentioned a larger Raven Dialog. I did ask this question of the gallery who talked with Star York. A sculpture that was about twice d the size would be about \$20,000. A bit more, than twice the cost of the smaller because of the work to create a larger scale model.

I am curious if AIPP might consider purchasing both the Ravens Dialog Bear and the smaller songbird sculpture (specifically to honor the founders)? It would be less than the \$10,000 budget we targeted.

Overall, I think that we have received very positive feedback and I think this joint effort has been very successful!

I will see if there are more comments at PEEC and share that information as well.
